## 2. Evaluation of Waste Hauling Services

Recommendation as submitted by Supervisors Barger and Mitchell: Instruct the Director of Public Works to report back to the Board in writing in 30 days with a one-year review of the current waste hauling contract for the Altadena and Kinneloa Mesa Residential Franchise and the Westside Commercial Franchise serving Marina del Rey; host multiple in-person community engagement sessions to obtain feedback from community members and report back to the Board in writing in 60 days with a summary of feedback along with recommendations for service improvements; report back to the Board in writing in 90 days with an evaluation of the County's requirements in the solicitation process for both Residential and Commercial Franchises and Garbage Disposal Districts, including recommendations to improve service delivery, data transparency, and accountability; and report back to the Board in writing in 60 days with grant opportunities, funding streams and recommendations to assist with the implementation of organic waste collection services, including waste reduction strategies, additional community education, and bill assistance programs. ## 3. Supports for Youth with Complex Care Needs

Recommendation as submitted by Supervisors Barger and Hahn: Instruct County Counsel, and the Director of Children and Family Services, in collaboration with the Chief Executive Officer and the Executive Director of the Office of Child Protection, and in consultation with the Directors of Health Services, Public Health and Mental Health, and the Chief Probation Officer, to report back to the Board in writing in 60 days on the feasibility of conducting an expedited solicitation to increase the number of beds available on an emergency basis by contracting with a service provider(s) who has proven expertise working with system impacted individuals with complex health, behavioral health, and mental health needs, including considerations to explore requiring selected service provider(s) to implement a "no reject, no eject" policy, including incentives for implementing such a policy, seeking a provider(s) with the ability to provide medication assisted substance use treatment, or other novel substance use treatment modalities to youth, an update on the County's Children's Crisis Continuum Pilot and the necessity for a provider to provide crisis stabilization settings and services on a 24-hour basis, and options to delegate authority to the Director of Children and Family Services and the Chief Probation Officer, to execute, amend, increase or decrease the contract amounts by 10%, and terminate contracts with any selected vendor, as needed, for a term of up to three years, with two one-year

extension options; and take the following actions:

Instruct the Office of Child Protection System of Care (Directors of Health Services, Mental Health, Public Health, and Children and Family Services, and the Chief Probation Officer, etc.) in collaboration with the Chief Executive Officer, to report back to the Board in writing in 60 days with recommendations to identify any returned funds to the State, and establish a fund dedicated to continuum of services for complex care youth that is comprised of immediate crisis response such as a dedicated psychiatric mobile response team, earmarked beds for temporary hospitalization and subacute mental health beds, and external supports to existing congregate care providers that are designed to help preserve placements, particularly during times of crisis;

Direct the Chief Executive Officer, in partnership with the Directors of Children and Family Services and Mental Health, and in collaboration with all relevant County Department Heads including, but not limited to, the Chief Probation Officer, Directors of Youth Development, Public Health, and Health Services, to build upon the Department's of Children and Family Services (DCFS's) and Mental Health's "strike team" model to establish Countywide complex care teams comprised of designated staff from each Department to develop a written crisis protocol to ensure continuity of care and case management for each individual complex care youth;

Instruct the Director of Children and Family Services, in collaboration with the Chief Executive Officer, to report back to the Board in writing in 60 days with a plan and cost estimate to expand the DCFS Placement Stabilization Team; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Branch, to advocate in support of legislation and funding that would allow courts and the counties to utilize secure housing sites that provide psychological and psychiatric care to youth as a placement disposition without requiring a referral to the youth justice/criminal court, increase State payment rates for Short Term Residential Therapeutic Programs, and remove any barriers or restrictions that have arisen due to the Institution of Mental Disease bed restriction issue. **4. Roadway Safety Along San Francisquito Canyon Road**

Recommendation as submitted by Supervisor Barger: Instruct the Director of Public Works to conduct a comprehensive traffic study, in consultation with County Counsel, on San Francisquito Canyon Road, between Elizabeth Lake Road and the City of Santa Clarita boundary, and report back to the Board in writing in 60 days, outlining initial strategies to increase traffic safety along this stretch of roadway; collaborate with the California Highway Patrol, and community partners, such as the Automobile Club of Southern California, to formulate a robust Community Traffic Safety plan, including coordinating a series of Community Traffic Safety meetings, with the meetings aimed to disseminate information, educate the community, and solicit community input and shall be conducted, in person (with options for remote attendance), no later than 90 days after approval of this motion; and report back to the Board in writing within 60 days of the final Community Traffic Safety meeting with recommendations and actions to address and improve roadway safety along San Francisquito Canyon Road between Elizabeth Lake Road and the City of Santa Clarita boundary. **6. Los Angeles County Shelter Crisis Declaration**

Recommendation as submitted by Supervisor Solis: Find that pursuant to Government Code Section 8698 et seq., a significant number of persons within the County are without the ability to obtain shelter, which has resulted in a threat to those persons' health and safety; in accordance with Government Code Section 8698 et seq., adopt a resolution declaring that the shelter crisis previously declared to exist within the County remains in effect for an additional year, during the period from November 2, 2023 through November 1, 2024; find that as a result of the Board's shelter crisis declaration, pursuant to Government Code Section 8698.1, any State or local regulatory statute, regulation, or ordinance prescribing standards of housing, health, or safety, are hereby suspended for qualifying County public facilities serving as homeless shelters to the extent that strict compliance therewith would prevent, hinder or delay the County's efforts to mitigate the effects of the shelter crisis, and that the County has, in place of such standards, enacted alternative minimal health and safety standards pursuant to Government Code Section 8698.1(b) for qualifying facilities to be operative during the housing emergency; find that, pursuant to Government Code Section 8698.4, provisions of any housing, health, habitability, planning and zoning, or safety standards, procedures, or laws, are hereby suspended for County homeless shelters insofar as the County has adopted the emergency housing provisions in the Los Angeles County Building Code (LACBC), consistent with ensuring minimal public health and safety and the requirements of Government Code Section 8698.4; find that the proposed actions are either not a project, or are exempt from the California Environmental Quality Act; and direct the Chief Executive Officer to take the following actions:

Designate County public facilities for use as homeless shelters during the period of the declared shelter crisis;

Take all appropriate steps to ensure compliance with the provisions of Government Code Section 8698.4 including, but not limited to, ensuring compliance with minimal public health and safety standards, filing a copy of the County's emergency housing provisions of the LACBC with the Department of Housing and Community Development (HCD) upon adoption of an ordinance subject to Government Code Section 8698.4, and filing an annual report by January 1 of each year to the Senate Committee on Housing and the Assembly Committee on HCD; and

Take any other actions consistent with and/or necessary for the implementation of the shelter crisis declaration and foregoing actions. (23-3802)

## **7. Establishing an Anti-Skimming Unit**

Recommendation as submitted by Supervisor Solis: Instruct the Director of Public Social Services, in collaboration with the District Attorney, to identify funding in an amount not to exceed \$750,000 in Fiscal Year (FY) 2023-24 and \$1,092,632 in FY 2024-25, to fund and establish an Anti-Skimming Unit within the District Attorney's Office to investigate and prosecute those responsible for stealing public assistance benefits via skimming and other illegal methods of electronic theft. **8. Reimagining Los Angeles County's Approach to Human Trafficking**

Recommendation as submitted by Supervisor Solis: Instruct the Director of Consumer and Business Affairs, through the Office of Immigrant Affairs and the Office of Labor Equity, in close consultation and collaboration with the Los Angeles County Regional Human Trafficking Task Force, and the Director of Public Health, through the Office of Women's Health, to report back to the Board in writing in 90 days, regarding the following:

Past efforts in addressing human trafficking in the County;

The current state of affairs in the County as to abating and eliminating human trafficking and as to providing support to survivors, with specific attention to the issue of labor trafficking in impacted immigrant communities in the County, including the San Gabriel Valley and La Puente, and other areas such as Pomona;

An analysis of, and recommendations about adopting a Countywide public health approach to combatting human trafficking;

Recommendations for actions on establishing a pilot worker's resource center in Monterey Park, including feasibility, necessary resources, existing resources, potential community-based organization partners, and other potential locations for future centers; and

An analysis of, and recommendations regarding establishing a Countywide human trafficking coordinating unit to integrate and harmonize the work of all County agencies and community-based organizations, including the Thai Community Development Center, Saving Innocence, the Coalition Against Slavery and Trafficking, and other non-government stakeholders relevant to the long-term mission of reducing and eliminating human trafficking in the County. **9. Restricting the Leasing/Renting of Recreational Vehicles in Los Angeles County**

Recommendation as submitted by Supervisors Mitchell and Barger: Instruct the Executive Director of the Homeless Initiative, Chief Executive Office, in collaboration with the Directors of Consumer and Business Affairs, Public Works, Regional Planning and Public Health, and County Counsel, to report back to the Board in writing within 90 days with an analysis and recommendations for proposed County ordinances to curtail the selling, leasing, or renting of Recreational Vehicles (RV) and oversized vessels in the public right-of-way, including the following:

Any relevant County Codes prohibiting RVs and oversized vessels from being sold, leased, or rented in the public right-of-way and any recommendations for County Code amendments related thereto;

A proposed escalating fine structure for County Code violations regarding the aforementioned and how fines can be invested and integrated into the County's Homelessness Initiative for the Pathway Home RV program's rehousing strategy;

Requirements for the lessor of an RV or an oversized vessel, such as a boat, to comply with relevant State and Federal laws as it relates to the sale and lease of RVs or vessels;

The feasibility of adopting ordinances that place restrictions on the sale or auctioning of personal RVs and oversized vessels in the public right-of-way;

Any relevant State laws which can be used for local accountability of landlords for habitability, health and wellness issues, or illegal activity liability; and

An analysis of, and recommendations to, the County's rent stabilization ordinance and mobile home rent stabilization to protect people experiencing homelessness who rent RVs or oversized vehicles, including the feasibility of requiring relocation expenses for any individuals dwelling within an RV or an oversized vessel, including repayment of any illegally collected rental arrears for the duration of their stay. **10. Moving Parking Enforcement Services from the Sheriff's Department to the Department of Public Works**

Recommendation as submitted by Supervisor Mitchell: Direct the Chief Executive Officer, in collaboration with the Director of Public Works, the Sheriff, and in consultation with County Counsel, to prepare a full business analysis, including organizational structure with appropriate levels of management and staffing, budget and funding analysis, and proceed with the steps required to transfer all parking enforcement services and authority from the Sheriff's Department Court Services Division, Civil Management Bureau, Parking Enforcement Detail to the Department of Public Works' (DPW) Transportation Services Division, or a separate division under the Director of Public Works' purview, and report back to the Board in writing in 120 days with an implementation plan, which should include, but is not limited to:

Specific steps required for DPW to fully execute parking enforcement services no later than July 1, 2024;

Programmatic, contracting, and logistical needs;

Staffing, any necessary movement of existing staff, and changes to current organization structures needed to maintain current levels of service and expanded service hours that are comparable to similar jurisdictions;

Necessary amendments or additions to County ordinances to transition parking enforcement authority from the Sheriff's Department to DPW;

Short- and long-term goals and performance metrics;

A process to transfer capital assets and parking citation processing tools for executing parking enforcement services to DPW;

A funding plan, including gaps, opportunities, and steps needed to transfer parking enforcement revenues from the Sheriff's Department to DPW;

A communication plan for unincorporated area residents to be informed of the transition before and after it occurs;

Comparison to parking enforcement services provided by neighboring jurisdictions; and

A timeline for implementation and any additional steps and tools to ensure a swift transition of service;

Direct the Chief Executive Officer, through its Employee Relations, to consult, where appropriate, with Labor on the impact of the transition; and

Request the Sheriff to promptly make available or provide access to all information including, but not limited to data, reports, employee information, strategic documents, budget reports, and correspondence, requested by the Director of Public Works to effectuate the directives of this motion. **11. Day Use Permit and Gratis Issuance of a License Agreement for Farmers Market at the Martin Luther King, Jr. Medical Campus Outpatient Center Fee Waiver**

Recommendation as submitted by Supervisor Mitchell: Find pursuant to Government Code Section 26227, that the portion of the County's Martin Luther King, Jr. Medical Campus Outpatient Center (MLK OPC) proposed for the farmers market is not currently needed for exclusive County purposes during those certain Wednesdays and the hours of operation of the farmers market, which will be defined in the license agreement; find that the services to be provided by Sustainable Economic Enterprises of Los Angeles (SEE-LA) are necessary to meet the social needs of the County and serve public purposes that benefit the County; find that the proposed issuing of day use permits and the granting of a non-exclusive, gratis license agreement to SEE-LA for a farmers market on County-owned property is exempt from the California Environmental Quality Act; and authorize the Chief Executive Officer to take the following actions:

Provide monthly non-exclusive, gratis day use permits to SEE-LA, provided that SEE-LA is cooperating and furnishing the information the County needs to issue a license agreement, SEE-LA is not negatively impacting the County and public use of the MLK OPC, and such day permits do not extend past January 31, 2024;

In consultation with the Director of Health Services, waive the \$200 per day event fee and the \$250 cleaning deposit fee, excluding the cost of security and liability insurance, for the day permits issued pursuant to the above directive;

Execute and issue a gratis license agreement to SEE-LA for a two-year term, for the operation of a farmers market at the County-owned MLK OPC, upon review of the operations of the farmers market on County property during the permit period; and

Execute other ancillary documentation necessary to effectuate the day use permits, and take any other actions necessary and appropriate to implement and effectuate the day use permits. (23-3798)

**15. Better Reaching the 95%**

Recommendation as submitted by Supervisor Horvath: Instruct the Chief Executive Officer, in collaboration with the Directors of Public Health, Mental Health, Health Services, Public Social Services, Children and Family Services, Justice, Care and Opportunities and Youth Development, the Executive Director of the Office of Child Protection, the Chief Probation Officer, the Executive Director of the Homeless Initiative, Chief Executive Office, and other County Departments Heads focused on health, social determinants of health, and public safety to develop plans, in consultation with relevant community stakeholders, on how those Departments can implement strategies to better engage individuals, including young people, impacted by substance use and ensure familiarity with accessing needed Substance Use Disorders (SUD) resources; provide education to County staff and pertinent contracted providers including, but not limited to, homeless outreach providers and case managers, on how to access beds in real-time using Department of Public Health (DPH) developed tools/resources, such as the Service and Bed Availability Tool, the mobile-friendly [www.RecoverLA.org](http://www.RecoverLA.org) platform, and the Substance Abuse Service Helpline; and instruct the Director of Public Health to take the following actions:

Partner with the Directors of Health Services and Mental Health, the Executive Director of the Los Angeles Homeless Services Authority, and other outreach providers, to ensure the existing network of outreach teams and interim and permanent housing providers are directly connected to all available specialty SUD resources, and Substance Abuse Prevention and Control (SAPC) should continue to enhance capacity to provide immediate bed access for people with SUD who express openness to treatment;

Enter into new agreements and work orders, and amend or extend existing agreements/work orders for professional and other services via expedited contracting processes, including sole sources and change notices, that support the mission and aims of SAPC's Reaching the 95% Initiative; and

Provide a verbal report back to the Board in February 2024, and in writing in 120 days and biannually thereafter, with a plan to engage individuals with substance use disorders who are not currently accessing needed services and needed resources to accomplish this aim, considerations in this plan should include, but are not limited to the following:

Description of existing SUD services and R95 Initiative services offered by DPH, and the delivery of an outreach and education campaign to ensure the public is aware of available SUD services and how they can be accessed, in culturally and linguistically appropriate ways;

Working with the Chief Executive Officer and others necessary to support SAPC's R95 Initiative including, but not limited to, the expansion of services provided outside of traditional settings inclusive of field-based services, outreach and engagement, ensuring sufficient resources to continue to expand on harm reduction services that target the 95% referenced above, all with the broader aim of elevating the visibility of and access to SUD services;

Engaging local Managed Care Plans (MCP) around the expansion of Screening, Brief Intervention, and Referral to Treatment, to include screening for all drugs as opposed to primarily being focused on alcohol, as well as other strategies the MCPs can be implementing to better reach people who need SUD services, but aren't accessing them; and

Engaging the Los Angeles County Office of Education, secondary school systems and local colleges and universities, on their strategies to prioritize positive youth development programs that increase access to substance use education, early intervention, naloxone, and other substance use and overdose prevention resources, all with the broader aim of ensuring that these preventative strategies minimize the adverse consequences of addiction for youth and young adults. The majority of the Board's Tuesday agenda is a consent calendar. All matters included on the consent calendar (including Board of Supervisors items and Administrative Matters) may be approved by one motion unless held by a Board Member for discussion. During the reading of the Agenda, the Executive Officer will indicate which items have been requested to be held for discussion or continued to a future meeting, and the remaining items will be approved. Items which are set for a certain time may or may not be called up at exactly the time indicated, depending on the business of the Board. The items that are held for discussion may be taken up at any time, depending on the business of the Board. Each item includes a brief summary of the Board member's motion or department's recommended action, and in some instances, a corresponding recommendation from the Chief Executive Officer, indicated in capital letters.

Included at the end of each agenda are items which have been continued from previous meetings for further discussion and action by the Board. This portion of the agenda is commonly referred to as the "A-item Agenda." At the request of a Supervisor, the A-items may be called up for consideration at any time.
