- i. Develop a plan and recommendations for short-term, medium-term, and long-term economic recovery in Los Angeles County, including industry partnerships and policy considerations to spur economic growth at the local, state, and federal levels.
- ii. Identify financial incentives, if any, the County can provide to existing or new businesses to spur economic recovery as the Safer at Home Order is relaxed.
- iii. Develop a systematic plan for the most COVID-19 impacted industries, and in consultation with labor, provide a systematic plan for rapid reemployment.
