THE 2018 REPORT ON THE STATUS OF WOMEN IN LOS ANGELES COUNTY was commissioned by the Los Angeles County Commission for Women (LACCW) and prepared by the Center for the Advancement of Women at Mount Saint Mary's University. The data included in this update provides a portrait of the wellbeing and status of women and girls in L.A. County on a variety of economic and social indicators.

The previous report in this series, the 2017 Report on the Status of Women in Los Angeles County, identified a number of positive trends as well as persistent challenges facing women and girls here.

Several trends evident last year have continued in a positive direction:

- Ninety-two percent of women and girls have health insurance, an increase of 2 percentage points in the last year.
- The poverty rate for L.A. County women fell nearly 2 percentage points between 2015 and 2017.
- Young women today are staying in school longer, graduating high school and going to college and beyond at significantly higher rates than women of previous generations.

Nevertheless, women and girls in L.A. County continue to experience significant hardships and gender disparities persist:

- Although the poverty rate declined for every demographic group of women in L.A. County, roughly 20% of Latinas and African-American women live below the federal poverty line.
- Women made up 31% of the homeless population in L.A. County in 2018.
- More than 42,000 domestic-violence related calls for assistance were made.

In this document, you will find highlights from the 2018 update (also available as a downloadable PDF), followed by data and tables on the condition and status of women and girls in L.A. County.

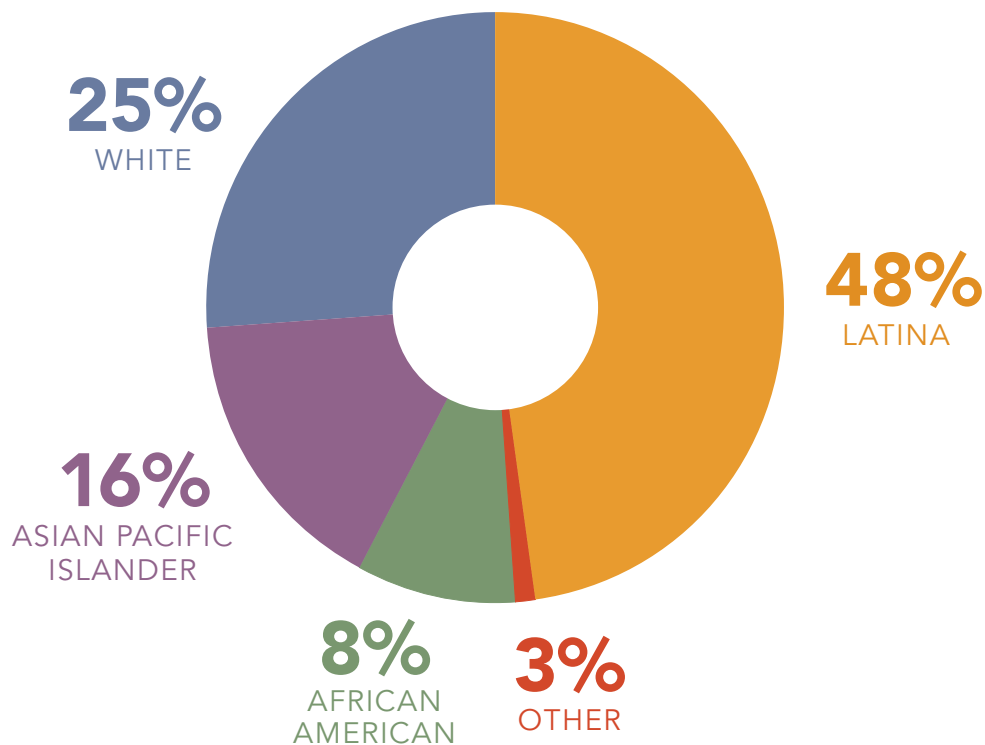

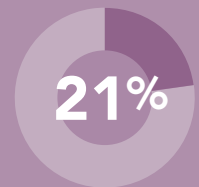

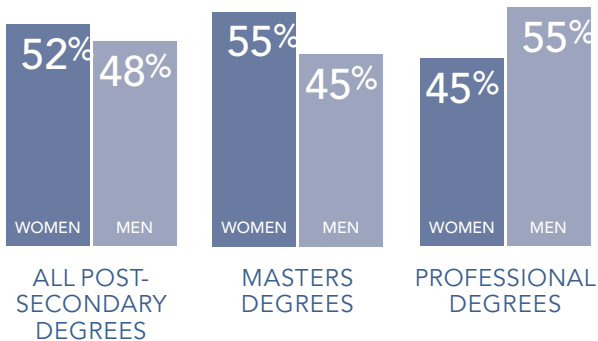

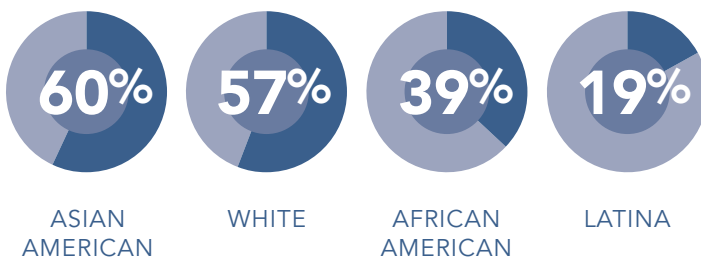

Women 25 years and older with a postsecondary degree by ethnicity



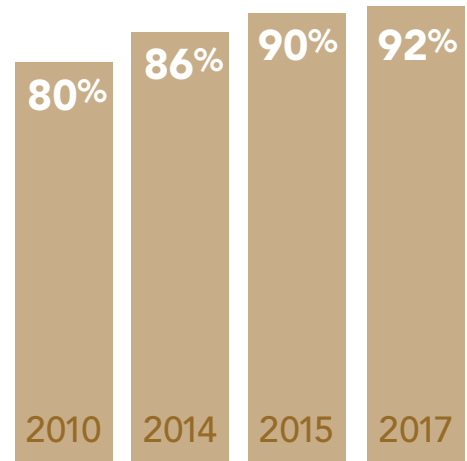

L.A. County women are younger, on average, than their counterparts in California and the nation as a whole. Latinas are the youngest of the county's major racial/ethnic groups, with a median age of 31.9 years, compared with 40.7 for African-American women, 44.0 for Asian-American women, and 46.5 for white women.⁵

3. Economic Wellbeing

Women-Owned Businesses

The metropolitan Los Angeles area (which includes Los Angeles, Long Beach and Santa Ana) has an estimated 736,000 women-owned businesses, second only to the New York, NY/NJ metropolitan area.⁹ As of 2018, California is home to nearly 1.6 million women-owned businesses, more than any other state in the nation.

Women-owned businesses in the Los Angeles area employ 457,000 people and have an annual sales revenue estimated at \$105.7 billion. Since 2007, the number of women-owned businesses in the Los Angeles metropolitan area has increased by 80%, employment by 18% and sales revenue by 32%.¹⁰

Unemployment

The unemployment rate for women in 2017 was 5.9%, its lowest in 10 years.

The poverty rate for L.A. County women fell nearly 2 percentage points between 2015 and 2017. Yet the poverty rates for both women and men in L.A. County remains higher than the state or national poverty rates.¹⁶

Poverty rates in L.A. County decreased from 2015 to 2017 in all populations. The percentage of Latinas and African-American women living in poverty decreased by 3 to 4 percentage points, but one in five continue to live in poverty.

Twenty-seven percent of women 16 years and over who lived in poverty in the past year were employed. Another 7% were looking for work but unemployed.¹⁸

4. Home and Family

More than 1 million Los Angeles County households are headed by women. Women head 22% of family households and 52% of non-family households. Over 860,000 women and men in L.A. County live alone. Twenty-three percent of those living alone are women over age 65.

Women make up 31% of the homeless population in L.A. County in 2018, just slightly less than in 2016. Although the numbers of homeless persons continue to rise, there has been considerable success in reducing the number of homeless veterans. In L.A. County, the number of homeless veterans fell 19% in 2018, relative to 2017. In 2018, only 28% of veterans were sheltered, compared to nearly half (47%) in 2016.²⁶

The health insurance rate of women and men in L.A. County rose from 89% in 2015 to 91% in 2017; 92% of women and girls are insured. Nevertheless, 900,000 County residents lack insurance. Men aged 25-34 have the lowest rate of insurance overall, but the proportion of this population that is insured has risen 5 percentage points from 77% in 2015 to 82% in 2017.

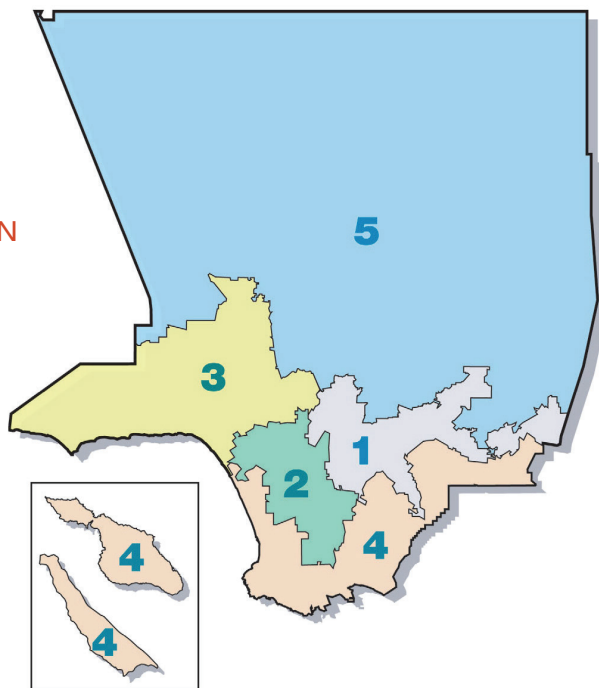
