

## CDCR Projections vs. Actual Intake


October 2011 through August 31, 2013






## PRCS Actuals/Projections-Active Cases\*

#### Defendants Sentenced Pursuant to Penal Code 1170(h) October 2011 through August 31, 2013




#### **Active Total Warrants**



## **Enhanced Hiring Standards**

In September 2012, the Department implemented more stringent hiring guidelines for sworn positions in the following areas:

Marijuana Use	No Convictions/Admissions in past three (3) years	No Convictions/Admissions in past two (2) years
Acts of Violence	No Convictions	Seven (7) years
Crimes against Property	No Convictions	Five (5) years
Driving Under the Influence	No Convictions within Seven (7) years	Two (2) years
Reckless Driving Offenses	No Convictions within Seven (7) years	Three (3) years
Vehicle Code Violations	No more than four (4) violations in ten (10) year period	No more than four (4) violations in five (5) year period



## **Enhanced Hiring Standards**

In March 2013, the Department implemented additional background screening tools:

- Polygraph Examinations
- Neighborhood Canvassing
- Credit Report Checks

- Live Scan
- Review Criminal and Substance Abuse History
- Review DMV Driving Record
- Verification of Current and Prior Employment History
- Confirm Education Requirements
- Review Social Media Websites
- Review Tattoos and Gang Associations
- Medical Examination
- Oral and Written Psychological Examinations

In addition, the Department is currently reviewing the entire hiring process including recruitment and the exam process to ensure we hire the most qualified staff.



### Strategies and Recommendations

- 1. Expansion of AB 109-funded DMH staffing to perform functions currently being provided by non-AB 109 staff.
- 2. Expand residential and outpatient programs for individuals with mental health and co-occurring disorders.
- 3. Develop a training curriculum for DMH contracted providers and directly operated DMH staff to enhance knowledge and practices related to engagement and treatment of persons with mental health and co-occurring disorders who have criminal justice histories.
- 4. Increase jail-in reach efforts by DMH outpatient programs.
- 5. Explore Senate Bill 82 funding to provide additional community-based crisis intervention/stabilization programs and mobile response teams that could serve the AB 109 population.


