Direct the Chief Sustainability Officer, in coordination with the Acting County Counsel, and the Directors of Public Works and Regional Planning, to report back to the Board in writing within 120 days with recommendations for updating the County's 2014 water conservation ordinance with permanent water conservation measures for outdoor water use in unincorporated areas of the County, such as requiring water efficient irrigation systems, multi-benefit landscape design, limits on washing of sidewalks and cars, banning non-functional turf, and other recommendations from the Chief Executive Officer's November 24, 2021 report entitled, "Report Back on Supporting Urban Water Conservation in Los Angeles County;" Instruct the Director of Public Works to publish within 90 days a resource list of available turf rebate programs through local water agencies to support turf removal and replacement and other water efficiency upgrades and notify relevant County Departments of the information available online at https://waterforla.com, as well as to make the information available at public-facing County facilities, such as libraries and community centers; and

Direct the Chief Sustainability Officer, in coordination with the Chief Executive Officer, to report back to the Board in writing in 120 days on the feasibility of creating programs to support equitable access to Federal, State and local resources to build climate resilience in communities, including providing low to moderate income residents with financial assistance as they remove their existing turf and replace it with native and drought tolerant landscaping that meet the requirements of the ordinance, with the report to include the Chief Executive Officer's fiscal analysis on possible funding streams for this program, once the Chief Sustainability Office has developed program options for consideration. ### 23. County Response to Windsor Hills Fatalities and Fast-Tracking Solutions to Increased Traffic Fatalities Countywide

Recommendation by Supervisor Mitchell: Instruct the Director of Public Works to contract with a third-party to conduct an after-action review into the response of the incident on La Brea Avenue and Slauson Avenue on August 4, 2022, under the oversight of and to be reviewed by the Acting County Counsel and report back to the Board in writing in 60 days on protocols to improve incident response, to explore and take appropriate actions to slow down excessive speeds on La Brea Avenue and Slauson Avenue and surrounding areas including, but not limited to, consideration of off-the-shelf and/or quick-build safety improvements, based on a traffic engineering evaluation within 30 days; and take the following actions:

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to explore what State and/or local statutory changes may be needed to allow the County to regulate excessive speed including, but not limited to, deploying automated speed enforcement and red-light cameras at key intersections on unincorporated streets, and if State statutory changes are needed, and sponsor or support State legislation, as appropriate;

Instruct the Director of Public Works to evaluate and develop a draft program design with extensive data collection that would identify high priority intersections and a program framework that prioritizes speed reduction, equity and justice; vet the program design through the Chief Executive Officer's Anti-Racism, Diversity and Inclusion Initiative, along with community-based organizations and report back to the Board in writing within 90 days;

Instruct the Director of Public Works to develop a Community Traffic Safety Plan in the Windsor Hills/Ladera Heights neighborhood, with traffic engineering reviews that include, but are not limited to, the feasibility of designs for road diets to curb excessive speeding, signal modifications and residential speed mitigation throughout the community; as part of the Community Traffic Safety Plan, the Director of Public Works must partner with community-based organizations on engagement for proposed design changes; and report back to the board in writing within 60 days on an implementation strategy and within six months on a final Community Traffic Safety Plan; Instruct the Director of Public Works, in collaboration with the Chief Executive Officer and the Director of Public Health, to identify funding sources and resources for the above work, along with a cost estimate that includes full-time positions to accelerate the delivery of Vision Zero Action Plan in the County; and instruct the Director of Public Works to report back to the Board in writing in 90 days on the potential funding sources, necessary staffing and estimated costs; the Director of Public Works should also include this in the Department Budget request for Fiscal Year 2023-24, with the report back to include comparison to funding in jurisdictions across the nation with adopted Vision Zero Action Plans, with populations of one million or more; and

Direct the Chief Executive Officer to explore centralizing all transportation related functions in the County, including traffic control, traffic investigations, mobility design, signal operations, planning, data analysis, parking enforcement, etc., with an effort to increase transparency and accountability directly to the Board and to unincorporated communities, and report back to the Board in writing in 120 days on recommendations. #### 24. Enhanced County Employee Election Worker Program

Recommendation as submitted by Supervisor Mitchell: Adopt the enhanced County Employee Election Worker Program (CEEWP) for use starting with the November 8, 2022 Statewide General Election, which aligns with the framework in the tentatively approved labor agreements; and take the following actions:

Instruct the Registrar-Recorder/County Clerk to utilize the CEEWP for the November 8, 2022 election;

Authorize the Director of Personnel, in conjunction with the Registrar-Recorder/County Clerk and the Chief Executive Officer, to set employee election worker targets for each Department;

Encourage all County employees to volunteer to serve as election workers;

Instruct Department Heads to make every effort to approve the volunteer requests of their employees in a timely manner; meet established Departmental thresholds for every election utilizing the CEEWP, including providing a certified referral list by the requested date and ensuring selected staff on the list are able to perform the assignment prior to submission, and if necessary, require members of select labor unions to serve as an election worker; and allow County employees to attend election worker training and serve as election workers during regular work hours;
