**5. Equitable Access to Healthcare for Contracted Employees**

Recommendation as submitted by Supervisors Hahn and Solis: Direct the Chief Executive Officer, along with the Directors of Health Services and Internal Services, and County Counsel, to take the following actions:

Develop and implement a policy to require all new Proposition A contracts for security, janitorial, environmental and food services at County Hospitals managed by the Department of Health Services in Fiscal Year 2023-24, to require 100% employer-paid healthcare benefits for employees who work 30 hours or more per week at the minimum level of the Affordable Care Act Gold Level, with this requirement to be implemented as soon as practical, but no later than December 31, 2023, and should not result in a reduction in wages or other benefits;

Require a Labor Peace Agreement for all new Proposition A contracts for security, janitorial, environmental and food services at County Hospitals managed by the Department of Health Services; and

Report back to the Board quarterly in writing on the status of implementation on this policy, which should include benefits/impact to service delivery, and challenges with recommendations associated with implementation and maintenance of this policy; and

Direct the Chief Executive Officer to explore options for implementation of a policy to require all new, renewed or extended Los Angeles County Proposition A contracts outside of the Department of Health Services with similar service industries to require Labor Peace Agreements and 100% employer-paid healthcare benefits for employees who work 30 hours or more per week at the minimum level of the Affordable Care Act Gold Level, with a written report back to the Board in 180 days, or sooner, on the aforementioned options. **7. Incentivizing Hiring for Los Angeles County's Alternative Crisis Response**

Recommendation as submitted by Supervisors Hahn and Barger: Instruct the Director of Mental Health, the Chief Executive Officer, and the Director of Personnel, to establish a plan for a pilot program to incentivize the hiring and retention of field-based positions that are part of the Department of Mental Health's various mental health crisis response programs including, but not limited to, the Psychiatric Mobile Response Teams, Mobile Crisis Outreach Teams, Mental Evaluation Teams, and School Threat Assessment Response Team, and should consider, at a minimum, the following incentives in their plan, and report back to the Board in writing in 60 days:

Implementing signing bonuses;

Expanding retention bonuses to all positions involved in field-response;

Increasing the retention bonuses that currently exist;

Implementing a workforce shortage bonus;

Implementing shift differentials;

Establishing a program for sabbaticals;

Allowing flexible schedules for staff who work in field-based teams, including incorporating telework and condensed schedules;

Creating new specific items for clinicians and peers that serve in field based teams;

Providing stipends for students interested in receiving a psych technician certificate;

Partnering with universities and colleges to implement student trainee programs with the Department of Mental Health;

Enhancing the existing student loan forgiveness program; and

Conducting a Countywide hiring campaign, in partnership with Labor and local universities and colleges. (23-1324)

**21. The Creative Jobs Collective Impact Initiative and Declare Arts, Culture, and Creativity Month**

Instruct the Director of Economic Opportunity to join the Director of Arts and Culture to participate in the CJCII Steering Committee, a committee of diverse arts/community leaders within the County, and led by Arts for LA, to develop recommendations to meet CJCII goals;

Instruct the Director of Arts and Culture and the Director of Economic Opportunity, as well as the Chief Executive Officer of Arts for LA, to report back to the Board at the Board meeting of October 17, 2023 on the opportunities identified by the CJCII Steering Committee; and

Direct the Chief Executive Officer to explore the feasibility of funding Strategy 1 to Expand Grants to Organizations Serving Diverse Communities in Arts and Culture’s Cultural Policy Strategic Plan to increase funding for the Organizational Grant Program as previously directed by the Board, to directly support the aims of CJCII to increase creative job opportunities and drive more equitable outcomes throughout the sector. **22. Los Angeles County to Take Actionable Next Steps to Depopulate and Decarcerate the Los Angeles County Jails: Granting Local Authority, Advocating for Court and State Support, and Legislative Changes**

Recommendation as submitted by Supervisors Solis and Horvath: Declare the State of mental health services and overcrowding in the Los Angeles County jails a humanitarian crisis, requiring the County to move with all deliberate speed on meaningful solutions; and prioritize decreasing the number of individuals entering the Los Angeles County Jails by doing the following:

Instruct the Executive Director of the Countywide Criminal Justice Coordinating Committee, in collaboration with the Interim Director of Justice, Care and Opportunities and the Sheriff, to engage with the 45 municipal law enforcement partners, identify interested partners, and work with those partners to develop Memoranda of Understanding (MOUs), or other agreements, aimed at expanding the use of cite and release across the County;

Instruct the Interim Director of Justice, Care and Opportunities and the Interim Director of the Office of Diversion and Re-Entry, to coordinate and align their respective pre-filing diversion efforts (i.e., Law Enforcement Assisted Diversion/Let Everyone Advance with Dignity, and Department of Justice, Care and Opportunities (JCOD) Pre-Filing Diversion Pilot Programs) to plan for expansion of those efforts in a manner that maximizes resources and avoids duplication of efforts; and

Instruct the Public Defender and the Alternate Public Defender to develop recommendations, including staffing and budget needs, that will enable each office to help people resolve Failure to Appear warrants as a means of avoiding incarceration, including consideration of expanding existing expungement clinics and/or mobile services;

Prioritize increased opportunities for pre-trial release by doing the following:

Instruct County Counsel, in collaboration with the Interim Director of Justice, Care and Opportunities, to send a five-signature letter to Los Angeles Superior Court (LASC) to implement the Emergency Bail Schedule that was in place at the height of the COVID pandemic, and implement, where feasible, extended court hours to serve those residents who are not able to attend or appear at court during normal business hours;

Instruct the Interim Director of Justice, Care and Opportunities, in

collaboration with the Public Defender, Alternate Public Defender, District Attorney, and in consultation with the Executive Officer/Clerk of the Superior Court, to explore opportunities to provide additional programs and services to expand diversion and alternative sentencing opportunities throughout the pretrial process including, but not limited to, the Early Disposition Courts;

As it relates to Penal Code §1203.018, instruct the Interim Director of Justice, Care and Opportunities and request the Sheriff, in consultation with County Counsel, to develop the rules and regulations of the early release, pre-sentenced programs, as allowed by Penal Code §1203.018; authorize the use of Penal Code §1203.018 by the Sheriff to release individuals in the County jails held on bail for either felonies and/or misdemeanors who can be safely released back into the community, based on said rules and regulations of the program, and instruct the Interim Director of Justice, Care and Opportunities to file with the Board the agreed upon rules and regulations for the pre-sentenced program;

Instruct the Interim Director of Justice, Care and Opportunities to explore opportunities to subsidize transportation to and from court and other supports for individuals released pre-trial, assess the likely impact on jail population, and to develop a plan to do so, with the plan to, in collaboration with Chief Executive Officer, identify costs and possible one-time and ongoing funding sources;

Instruct the Interim Director of the Justice, Care and Opportunities, Alternate Public Defender, Public Defender, the Interim Chief Probation Officer, and request the District Attorney and the Sheriff, to work with the LASC to increase the use of split sentencing as another alternative to incarceration;

Instruct the Interim Director of Justice, Care and Opportunities, in collaboration with the Sheriff and all other relevant Departments, to develop a plan and coordinate the implementation of community services programs at each Los Angeles County Sheriff's Department (LASD) station in the County that would help to support the expansion of pre-trial releases by the LASC, and any other diversion effort by JCOD and Office of Diversion and Re-Entry (ODR); and

Instruct the Interim Director of Justice, Care and Opportunities, and request the Sheriff, in collaboration with the Public Defender and Alternate Public Defender, to report back to the Board on previous efforts to conduct video arraignments at all LASD station jails and provide a proposal for a pilot to reinstate efforts to arraign as many individuals as

possible, remotely via video conference, in an effort to reduce the number of individuals transferred from local to County jails;

Prioritize increased opportunities for post-sentence release and re-entry by doing the following:

As it relates to early release programs under Penal Code §§1203.016 and 1203.017, instruct the Interim Director of Justice, Care and Opportunities and request the Sheriff, in consultation with County Counsel, to evaluate the current rules and regulations for the Los Angeles County Sheriff's Department's early release, post-sentenced programs under Penal Code §§1203.016 and 1203.017, and make any needed adjustments; re-authorize the use of Penal Code §§1203.016 and 1203.017 by LASD to release individuals committed and/or sentenced to the County jails for misdemeanors and/or felonies who can be safely released back into the community based on the rules and regulations of the program previously developed by LASD; and instruct the Interim Director of Justice, Care and Opportunities, to file with the Board the agreed upon rules and regulations for the post-sentenced program and detail the County's collaborative effort to ensure the program's success;

Request the Sheriff to review its "shorts" release policy, starting with individuals incarcerated at Century Regional Detention Facility, for opportunities to further modify time-served requirements; review its bail thresholds to cite and release individuals with aggregate bail amounts set at \$50,000 or below; and expand the "shorts" release policy and "percentage release" program to include people sentenced under Assembly Bill (AB) 109/Penal Code §1170(h);

Instruct the Interim Chief Probation Officer to implement a high-level approval process for custody-based on Post-Release Community Supervision (PRCS) revocation and instruct the Interim Director of Justice, Care and Opportunities to work with the Interim Chief Probation Officer to find alternative measures to respond to PRCS violations that do not result in individuals being incarcerated;

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, in consultation with the Interim Director of Justice, Care and Opportunities, and County Counsel, to send a five-signature letter to Governor Gavin Newsom and the California Department of Corrections and Rehabilitation (CDCR) Secretary Jeff Macomber, to:

Expedite release of individuals being held in local custody on behalf of the State including, granting the Sheriff delegated authority to calculate credits and release individuals directly from local custody; expedite the transfer of those individuals, being held in local custody, who have been sentenced to state prison to CDCR facilities; and establish State-funded and managed alternative custody arrangements for individuals who are in custody based on the State's decision to revoke their parole and/or pending processing after receiving a State prison commitment from the court;

Instruct the Interim Chief Probation Officer, in collaboration with Interim Director of Justice, Care and Opportunities and the Chief Executive Officer, to identify costs and possible one-time and ongoing funding sources to support and expand the JCOD's re-entry and programming services;

Reaffirm the Board's commitment to depopulate and decarcerate through legislative advocacy by doing the following:

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to advocate in support of legislative proposals to:

End non-safety related towing of vehicles; and enhance implementation of the County's pre-trial services, including proposals to:

Adopt a zero-bail schedule for individuals accused of low-level offenses, infractions, misdemeanors, and some felony offenses, similar to the schedule that was put in place at the height of the COVID pandemic permanently;

Protect information provided by defendants in pre-trial services evaluations, and expand the definition of criminal justice agencies to include pre-trial release, and require the Attorney General of California to provide State summary criminal history information to County staff performing pre-trial release services, similar to AB 2354 (2021);

Direct permanent funding to Los Angeles County for pretrial services, similar to San Francisco and Santa Clara County; and



Direct any one-time funding allocated to the County through Senate Bill (SB) 129 for pre-trial services to remain available for future pre-trial services;

Amend the appropriate Government Code and other relevant statutes that would provide the Sheriff and the Department of Health Services' Correctional Health Services greater ability to implement medical releases from custody (Gov. Code §26605.5) and compassionate releases from custody (Gov. Code §26605.6);

Mandate both the LASC and LASD to share data with a County Department that is charged with depopulation of the jail and/or administration of pre-trial services and alternatives to incarceration, and

Provide funding to support re-entry (pre- or post-sentenced) programming and services;

In continued efforts to safely depopulate and decarcerate, do the following:

Direct the Acting Chief Information Officer, in collaboration with the Interim Director of Justice, Care and Opportunities, the LASC, Public Defender, Alternate Public Defender, Directors of Mental Health, Health Services, Public Health, the Interim Chief Probation Officer, Information System Advisory Body, and request the District Attorney and the Sheriff, and any other pertinent County Department, to create a data collection, evaluation, and research team focused on data tracking and modeling of all pre-sentence and sentenced populations, including:

The daily real time numbers for all P-levels;

Their current status in the judicial process;

The predicted date of release;

Tracking of all individuals waiting to be transferred to State prison, State hospitals, and any other jurisdiction;

The predicted impact on the numbers for all County re-entry interventions and services;

The predicted impact on the numbers for all County pretrial,

diversion, split sentencing, and alternative sentencing interventions and services (separating the numbers based on impact to jails vs. prison);

All available beds within the County network; and

Real-time data as to whether each of those beds are occupied or not on a daily basis, including tracking walk aways from treatment and those who abscond;

Direct the Acting Chief Information Officer, in consultation with the Interim Director of Justice, Care and Opportunities, to engage a consultant and/or academic research institution to develop tools for jail population modeling and projections, which will remain in the County's ownership and control for ongoing, future modeling;

Direct the Acting Chief Information Officer, in collaboration with Chief Executive Officer, to identify costs and possible one-time and ongoing funding sources, to support data tracking and modeling efforts, including funding for JCOD, or County Departments to hire necessary staff;

Request that the Sheriff identify pilot alternative assessment tools, other than COMPAS, for purposes of assessing eligibility for discretionary release programs;

Request the Sheriff to work with the Interim Director of Justice, Care and Opportunities to expand access to individuals in custody for community-based service providers and individuals with lived experience to provide jail in-reach and other services;

Request the Sheriff to identify alternative security classification assessment tools, other than COMPAS, for purposes of identifying individuals who pose a security threat to themselves or others;

Instruct the Interim Director of Justice, Care and Opportunities to create a catalog of all County programs that impact recidivism rates of justice-impacted and involved individuals and evaluate the effectiveness on decarceration and recidivism, including providing recommendations on creating new or expanding existing programs;

Direct County Counsel, with the Interim Director of Justice, Care and Opportunities, to assess and provide recommendations to resolve any negative impact of the closures of State prisons on the Los Angeles

County jail population that would pose challenges, including legal, to the Board's "care first, jails last" efforts;

Direct the Acting Chief Information Officer, to work with the Interim Director of Justice, Care and Opportunities, County Counsel, other relevant County Departments, and the LASC, to establish data sharing agreements so JCOD and the Jail Closure Implementation Team (JCIT) can access data to assist in jail depopulation and administration of alternatives to incarceration;

Instruct the Interim Director of Justice, Care and Opportunities, and request the Sheriff to jointly report back to the Board annually in June with an update on the use of Penal Code §§1203.016, 1203.017, and 1203.018 early releases, program effectiveness, with data-driven analysis, and any recommendations for modifying the program, as required by Penal Code §1203.018, subdivision (e);

Direct the Chief Executive Officer to work with the Interim Director of Justice, Care and Opportunities in collaboration with County Counsel, to establish a master services agreement contracting model, similar to the one used by the Department of Health Services, to expedite contracting efforts, including to secure housing, supportive services, and case management, and further direct Chief Executive Officer to ensure JCOD has the staffing and administrative support to carry out the relevant directives to further the County's efforts to safely depopulate and decarcerate the jails and in furtherance of JCOD's mission; and

Direct the Interim Director of Justice, Care and Opportunities and County Counsel to coordinate the reports back for this motion in the following manner:

Each Department named as lead within the motion directives shall provide the Interim Director of Justice, Care and Opportunities and County Counsel with its report back that includes a timeline of when it will complete the directive(s) it is responsible for, subject to review by JCOD:

Within 60 days of this motion, each Department named as a lead for a directive(s) shall provide to the Interim Director of Justice, Care and Opportunities its report back, in writing, and if it cannot complete the directive(s) within 60 days, the Department must inform JCOD, in writing, at least one week prior to the directive(s) deadline as to why it was not able to complete the directive(s) on time and provide a new deadline, and JCOD will include this in its subsequent reports back to the Board;

Within 90 days of this motion, JCOD shall collate only the reports received by the 60-day timeline into one document and submit it to the Board;

After the initial report back, the lead Departments for any outstanding directive(s) must work with JCOD and provide JCOD updates every 60 days regarding the directive(s); and

JCOD will provide quarterly reports to the Board based on the updates provided by the Departments, with these reports to supersede any previous report back responsibilities by JCIT to the Board. (23-1311)

Instruct the Director of Health Services, through the Office of Diversion and Re-Entry, and the Director of Mental Health, as well as the Public Defender and the Alternate Public Defender, and request the District Attorney, to work with the Chief Executive Officer to finalize the Program budget and proposed staffing, including a listing of existing funding available and a plan to maximize Federal and State funding, to implement the proposed programming, with the Departments to include the revised out-year estimates of budgetary needs to support continued progress in achieving the goals of removing as many P3/P4 individuals from the jail as possible in their 90-day and quarterly reports; and include any funding requests that cannot be covered with existing funding or State and Federal revenue available, and will require Net County Cost, in a future budget phase to allow the Chief Executive Officer to evaluate these requests within the context of the overall budget and numerous competing funding priorities and requests;

Direct the Chief Executive Officer to work with the Directors of Mental Health and Health Services to finalize, fund, and allocate the necessary clinical, administrative and programmatic items, and with the District Attorney, Public Defender, and Alternate Public Defender, to allocate the necessary justice-related items needed to implement the Program, including taking any steps needed to allow the Departments to immediately and successfully recruit and hire for these positions including, but not limited to, the following:

Approval of specialty exams that recognize relevant expertise and lived experience;

Using existing delegated authority, and if necessary, providing additional delegated authority to the Directors of Health Services and Mental Health for ordinance position authority and special step placements for all necessary clinical, and programmatic, and administrative support items for a period to be determined by the Chief Executive Officer; and

Extending any relevant incentives, special pay practices and pipeline programs established within Los Angeles County for these items;

Instruct the Director of Personnel to take any recruitment, examination and appointment steps necessary in order to allow the Departments to immediately and successfully recruit and hire for the necessary staffing model, including the approval of specialty recruitments, and recognition of the relevant expertise and lived experience needed for successful Program operations to serve the P3/P4 population;

Authorize the Directors of Mental Health and Health Services, to negotiate and execute new agreements and/or amendments to agreements with qualified providers, including revisions to statements of work, extension to agreement terms and/or increase contract sums, provided such actions do not exceed Board-approved funding to deliver services to the P3/P4 populations, as proposed in the Program, including negotiating on a case-by-case basis appropriate changes to the standard County insurance and indemnification provisions, and other standard County contract terms;

Instruct the Executive Director of the Homelessness Initiative, in collaboration with the Interim Executive Director of the Los Angeles Homeless Services Authority, the City of Los Angeles, and the Directors of Mental Health and Health Services, to report back to the Board in writing in 90 days on how individuals who complete their mandated justice system engagement can be moved to other housing funding streams (e.g., Measures H, Department of Mental Health (DMH)) from Office of Diversion and Re-Entry (ODR) housing funding streams, including the feasibility of changing the Coordinated Entry System (CES) so that ODR and DMH justice involved populations qualify for permanent supportive housing through the CES;

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to continue advocating to secure additional State and Federal funding to support the mentally ill incarcerated population;

Instruct the Interim Director of Justice, Care and Opportunities, the Public Defender, Alternate Public Defender, Executive Director of the Office of Diversion and Re-Entry, Director of Mental Health, and request the District Attorney, to meet periodically, but no less often than every six months, with Los Angeles Superior Court representatives to ensure the courts are informed about existing and newly added County and County-affiliated programs and facilities that are available to treat the justice-involved; and

Request the Sheriff, in consultation with Correctional Health Services, Director of Mental Health, the Interim Director of Justice, Care and Opportunities, the Chief Executive Officer, and County Counsel, to develop a written plan, including any necessary budget and staffing, for exercising his authority to implement mental health community placements, pursuant to Penal Code Sections 4011.6 and 4011.8, and report back to the Board within 60 days in writing with a plan, along with policies and procedures for these placements.
