**53-A. We Are Still In: Affirming Los Angeles County's Global Commitment to Climate Action**

Recommendation as submitted by Supervisor Horvath: Instruct the Chief Sustainability Officer to explore the County formally joining as an observer organization to the United Nations Framework Convention on Climate Change (UNFCCC) and actively engaging through the UNFCCC and Intergovernmental Panel on Climate Change's Cities and Regions process, and report back to the Board within 60 days with a progress update. Instruct the Chief Sustainability Officer to outreach to National and Global climate and sustainability leadership associations to affirm the County's commitment to global climate action, explore formally joining, and report back to the Board within 60 days with a progress update. Instruct the Chief Sustainability Officer to inventory the key strategies and metrics demonstrating how the County is advancing these global climate goals despite the federal backsliding, within 60 days. Instruct the Chief Sustainability Officer to work with relevant Directors, such as the Directors of Public Works, Internal Services, and Parks and Recreation, to engage county experts in this process. Direct the Acting Chief Executive Officer to work with the Chief Sustainability Officer to identify any nominal funds needed for membership and other expenses to support County participation in this international cooperation. **53-B.                    Extending Price Gouging Protections for Housing**

Recommendation as submitted by Supervisor Horvath: Effective January 29, 2026, extend for 30 days, through and including February 27, 2026, the protections of California Penal Code Section 396, subdivisions (b), (c), (d), (e), and (f), to limit price-gouging for applicable goods and services and in the housing rental market, and in hotels and motels, and to continue the protections of County Code, Title 8 - Consumer Protection, Business and Wage Regulations, Chapter 8.09, pursuant to Penal Code Section 396 subdivision (g). The Board finds that this extension is necessary because of complaints of price gouging which are continuing, and have been increasing, and that such an extension will protect the lives, property, and/or welfare of the residents of the County. Authorize a specified price increase of the rental price for housing not rented and not offered for rent within one year prior to the proclamation or declaration of emergency as defined in Penal Code Section 396 subdivision (j)(11)(B) as follows: for the County, increase the rental price formula for such housing from 160% of the fair market rent established by the United States Department of Housing and Urban Development (HUD) to 200% to more accurately reflect rental market conditions in the County. All other provisions of Penal Code Section 396 subdivision (j)(11)(B) shall remain unchanged. (26-0446)

**53-C.                    Coordination and Celebration of 2026 World Cup FanZones on  
Los Angeles County Properties**

Recommendation as submitted by Supervisors Solis and Mitchell:  
Suspend Section 22.1 of the Rules of the Board for the limited purpose of considering this motion. Authorize the Acting Chief Executive Officer to execute Official FanZone agreements and any necessary amendments, with the Los Angeles World Cup 2026 World Host Committee on County owned sites located at Whittier Narrows Recreation Area and Earvin "Magic" Johnson Park for the organization and staging of the Official World Cup FanZones, subject to the terms and conditions set forth in the Agreements, and authorize the allocation of Supervisorial or Department resources necessary to support FanZones at the Host Sites. Execute agreements to secure identified sponsorships for implementation of the FanZones at the Host Sites. Execute agreements to accept any grants for the implementation of the FanZones at the Host Sites. Find that the proposed actions are exempt from the California Environmental Quality Act. Authorize the Directors of Economic Opportunity, Public Works, Parks and Recreation, Arts and Culture, the Sheriff, the Fire Chief, other relevant County Departments, and the California Highway Patrol, in consultation with County Counsel, to take the following actions:

Execute agreements or amendments to County existing agreements, including sole-source agreements, when necessary, to implement FanZones at the Host Sites, including the proposed open street events near the Host Sites, so long as using the existing contracts will not reduce the Departments' ability to provide essential County services.



Execute and issue any work orders under existing County master agreements, which have been competitively solicited, including, but not limited to, through work order solicitations, to implement FanZones at the Host Sites, including the proposed open street events near the Host Sites, so long as using the existing County master agreement contracts will not reduce the Departments' ability to provide essential County services.

Authorize County Departments to receive Non-Net County Cost (Non-NCC) funds to fund the respective FanZones at the Host Sites, and authorize County Departments to use those identified Non-NCC funds to implement FanZones at the Host Sites.

**53-E. Bolstering Asian American and Native Hawaiian/Pacific Islander Mental Health on the Three-Year Remembrance of Monterey Park Tragedy**

Recommendation as submitted by Supervisor Solis: Proclaim January 21, 2026 as the “Monterey Park Tragedy Day of Remembrance” to honor the lives lost and those forever impacted by the mass shooting that took place in Monterey Park on January 21, 2023. Instruct the Director of Mental Health to report back to the Board in writing in 90 days, on the current efforts to reduce stigma and increase access and engagement of mental health services among Asian American and Native Hawaiian/Pacific Islander (AANHPI) communities in the County, including but not limited to the following:

Rate of mental health service utilization by AANHPI communities relative to estimated need.

Immigration enforcement impacts on the mental health needs of AANHPI communities through testimonials.

Continued efforts to enhance workforce diversity and increase cultural competency among staff.

Ongoing initiatives and outreach to increase access and utilization of mental health services among AANHPI communities, including the expansion of successful initiatives such as “Tea Time” utilized following the Monterey Park mass shooting.

Plans to conduct a targeted, culturally, and linguistically responsive informational awareness campaign to promote services among AANHPI communities.

Recommendations to further enhance access and utilization of mental health services among AANHPI communities, particularly amid increased immigration enforcement. (26-0390)

Kennedy, seeking to invalidate provisions in the Final Rule that will cause many Americans to lose health insurance coverage and, in turn, cause an immense strain on community resources. (26-0389)

**53-G. Holding the Line for Working Families Against Attacks on Federal Funding for Los Angeles County Residents**

Recommendation as submitted by Supervisors Mitchell and Solis: Instruct the Directors of Public Social Services and Children and Family Services, in coordination with the Acting Chief Executive Officer, the Director of the Office of Advancement of Early Care and Education, within the Department of Public Health, and other affected Departments and Offices to assess the County's exposure, given the aforementioned January 6, 2026, directive from the Federal administration initiating "funding freezes" across Temporary Assistance for Needy Families (TANF) known as CalWORKs, Child Care and Development Fund (CCDF), and Social Services Block Grants (SSBG) funded programs. Instruct the Directors to report back to the Board in writing in 14 days with impacts to: benefit payments and eligibility determinations, CalWORKs Welfare-to-Work services, childcare access for CalWORKs-linked families, and SSBG and CCDF-funded programs in DCFS and other affected departments. Direct the Acting Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Branch, to communicate identified impacts to the County's Congressional delegation, State legislative delegation, and other relevant State and Federal parties, and to advocate for full restoration of funding. Direct County Counsel to take the following actions:

Evaluate immediate legal protections for County Departments in light of the Federally induced restricted drawdown (funding freeze) for TANF, SSBG and CCDF, and report back to the Board in writing in 14 days on any financial, civil, or privacy risks created by federal demands for personally identifiable information requested in conjunction with this funding freeze.

Work with affected Departments and report back to the Board in writing in 14 days on a coordinated legal strategy that includes, but is not limited to coordination with the California Attorney General to bring legal challenges to the Federally directed restricted drawdown of these vital safety net funds. Coordination with similarly situated counties, municipalities, and States nationwide to bring relevant legal challenges. Participation in litigation or amicus filings aimed at restoring full Federal funding and protecting congressionally appropriated benefits.

Instruct the Director of Public Social Services, in coordination with the Acting Chief Executive Officer, Directors of Children and Family Services, Office for the Advancement of Early Care and Education, and other impacted Departments to report back to the Board in writing in 14 days with fiscal and operational impacts under 30, 60, and 90-day freeze conditions. Messaging for impacted constituents incorporated into the existing Keep Your Benefits campaign and incorporated into the multi-departmental, multi-platform communications action plan already underway as directed by the Board on December 2, 2025, ("Strengthening Countywide Communications on Health, Social Services and Emergency Impacts"). Opportunities for additional funding to sustain program delivery during the funding freeze including partnership with private and philanthropic partners. A coordinated communications strategy across all impacted Departments, led by the Director of Public Social Services in collaboration with Countywide Communications, to communicate the impact of the Federal funding freeze and contingency plans, if any, to the public and impacted constituents.

Instruct the Directors of Public Social Services, Children and Family Services, Office for the Advancement of Early Care and Education, the Acting Chief Executive Officer, and other relevant Department Heads to convene with impacted stakeholders and community-based organizations to assess the impacts of this funding freeze and develop coordinated strategies, including recommended emergency actions, to pool available resources to mitigate programmatic impacts, and report back to the Board in writing in 30 days on the impacts of these efforts.
