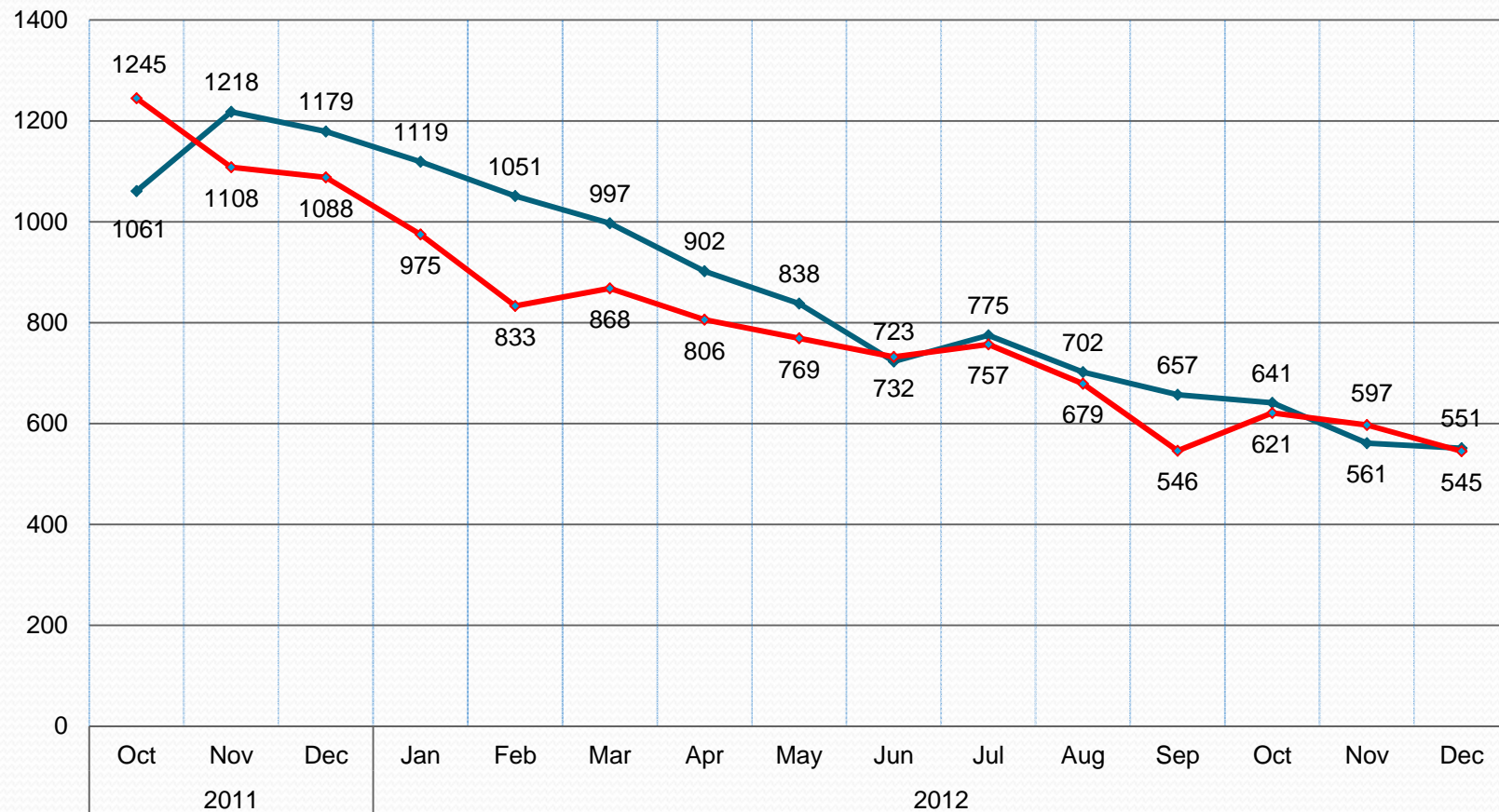

- Risk Level Assumptions Year 1

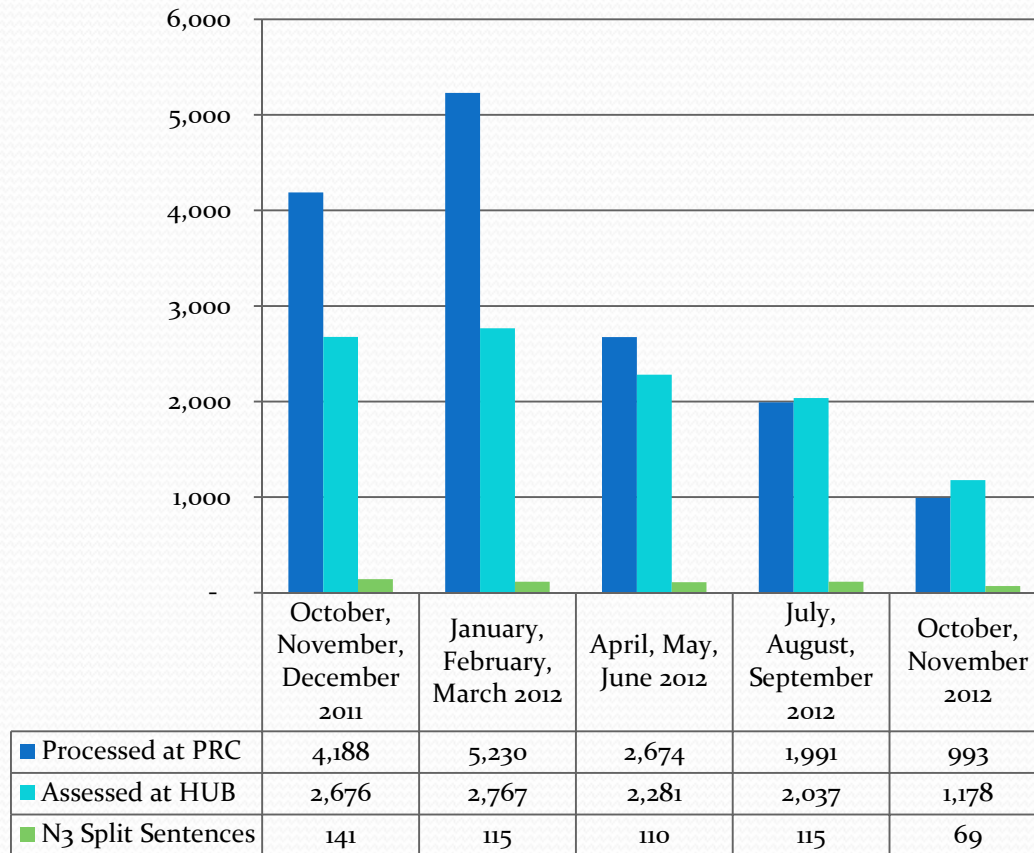
Risk Level	Assumption	Actual
Very High (ultra)	0	10%
High	49%	48%
Medium	26%	42%
Low	25%	< 1% grouped in Medium

*Very High Risk Level >30 on the Level of Service Case Management Inventory (LS/CMI)

- Assumption used for staffing basis
- Critical Needs Not Accounted For
 - Medically Fragile (Paralyzed, Seizures, Diabetic Sores)
 - De-certified Mentally Disordered Offenders (n=6)



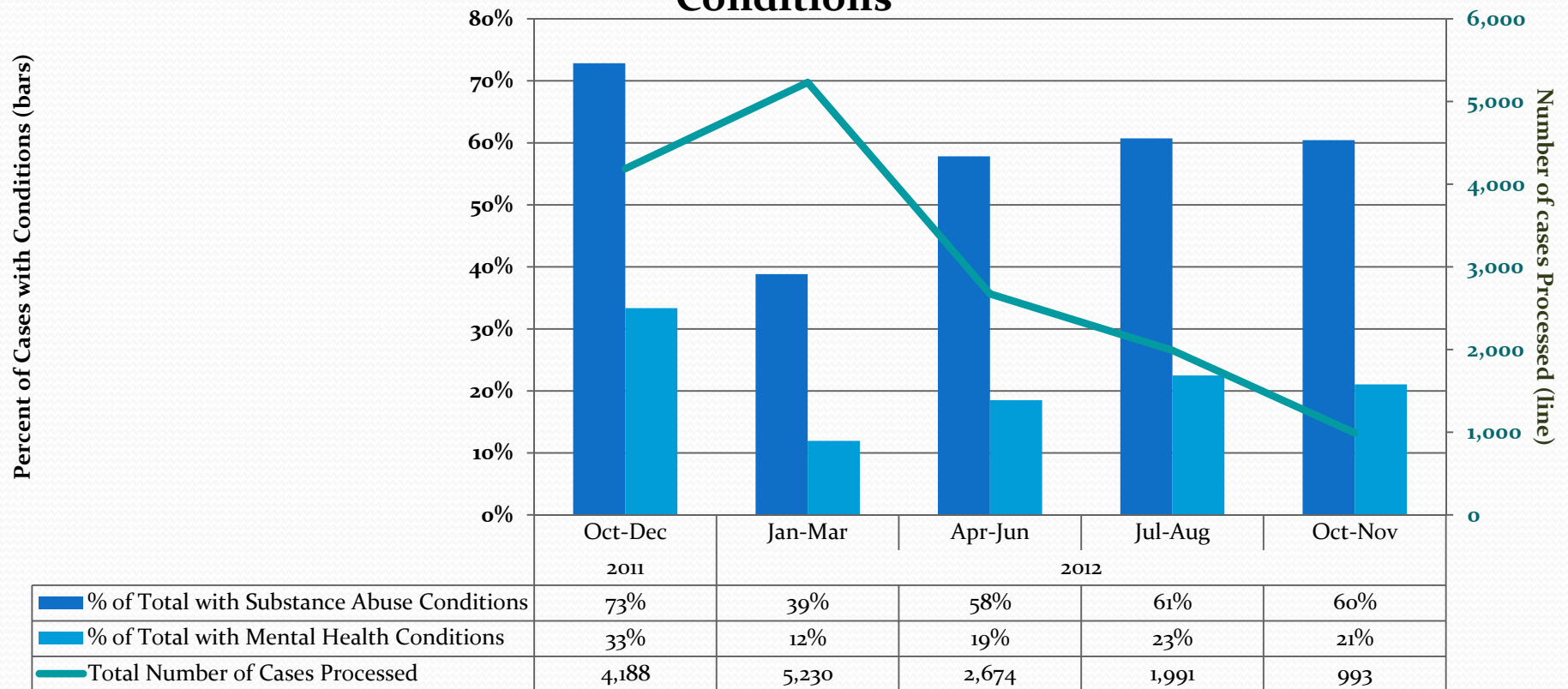

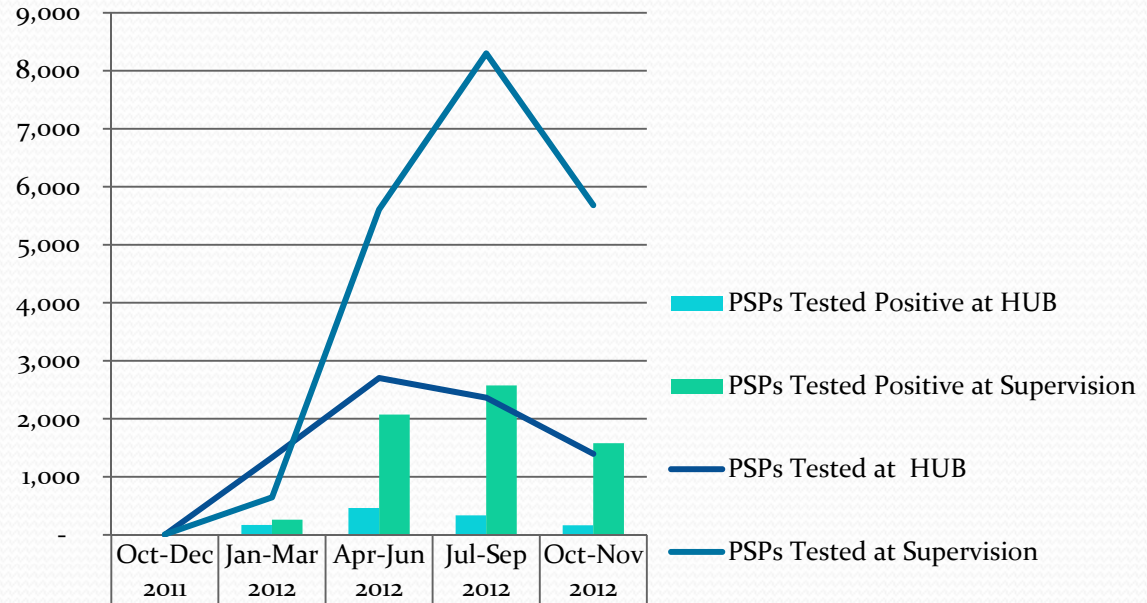
- Assumption that a large %PSPs would have substance abuse and mental health treatment needs

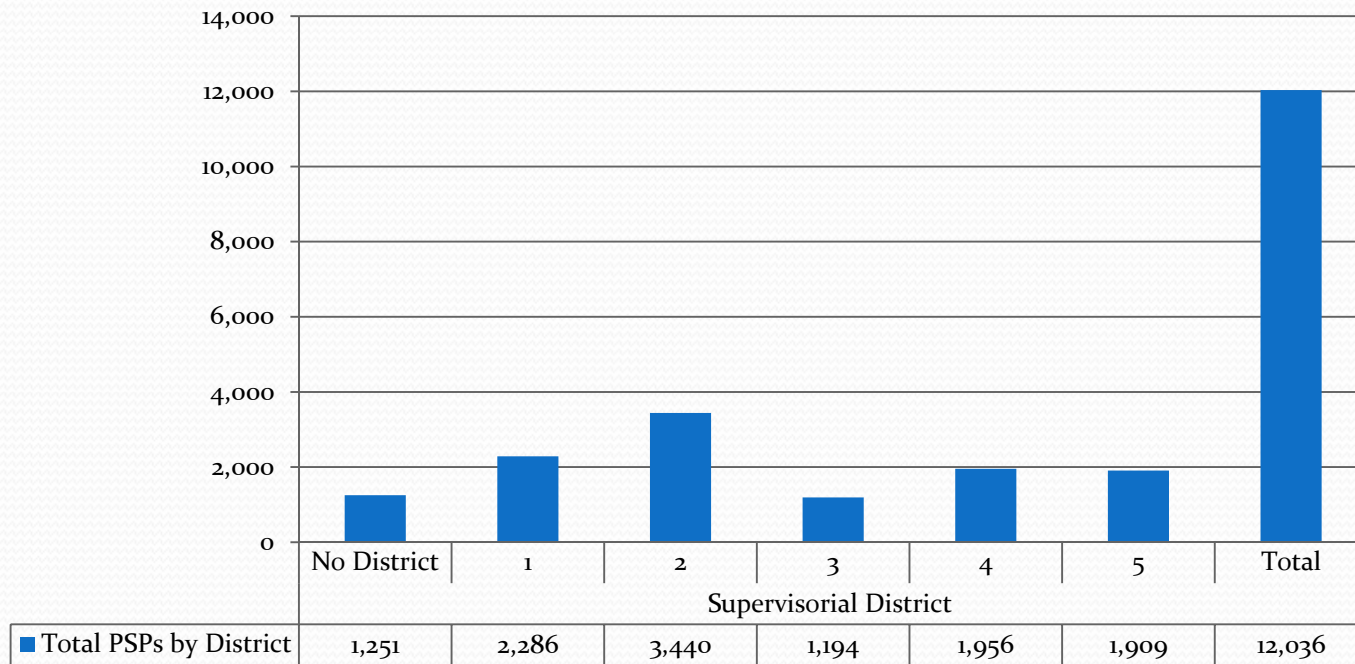

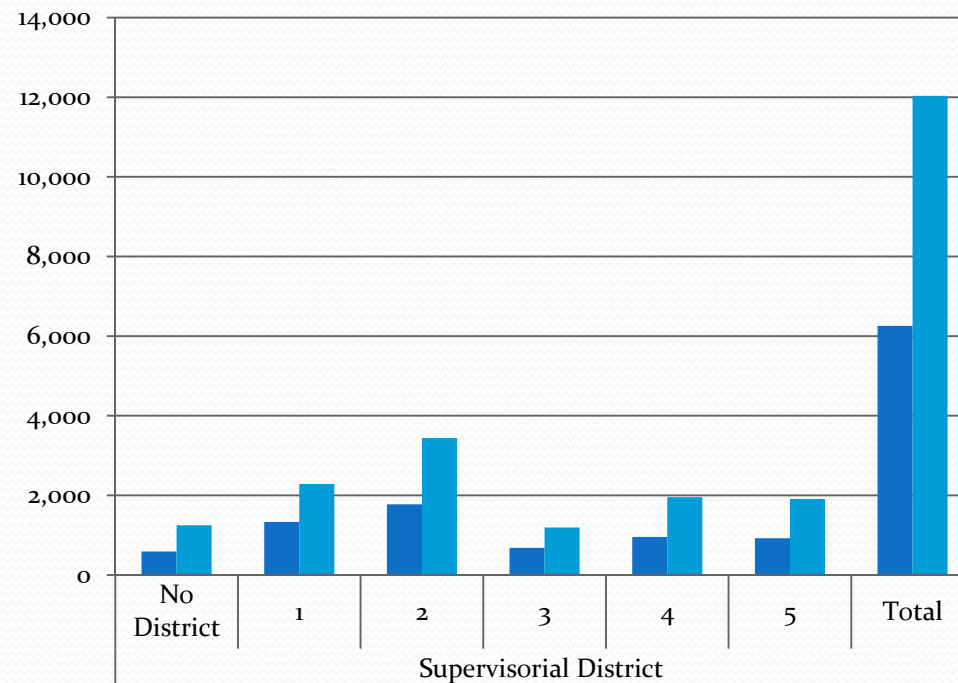

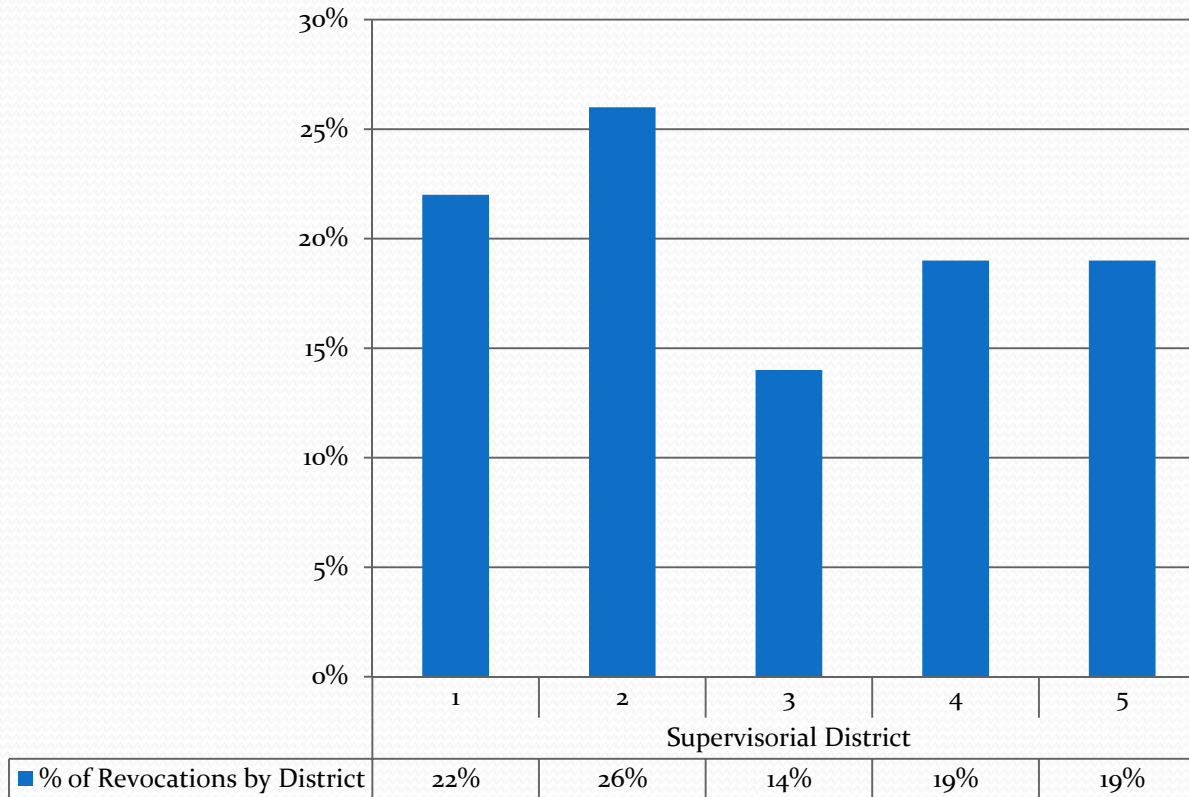

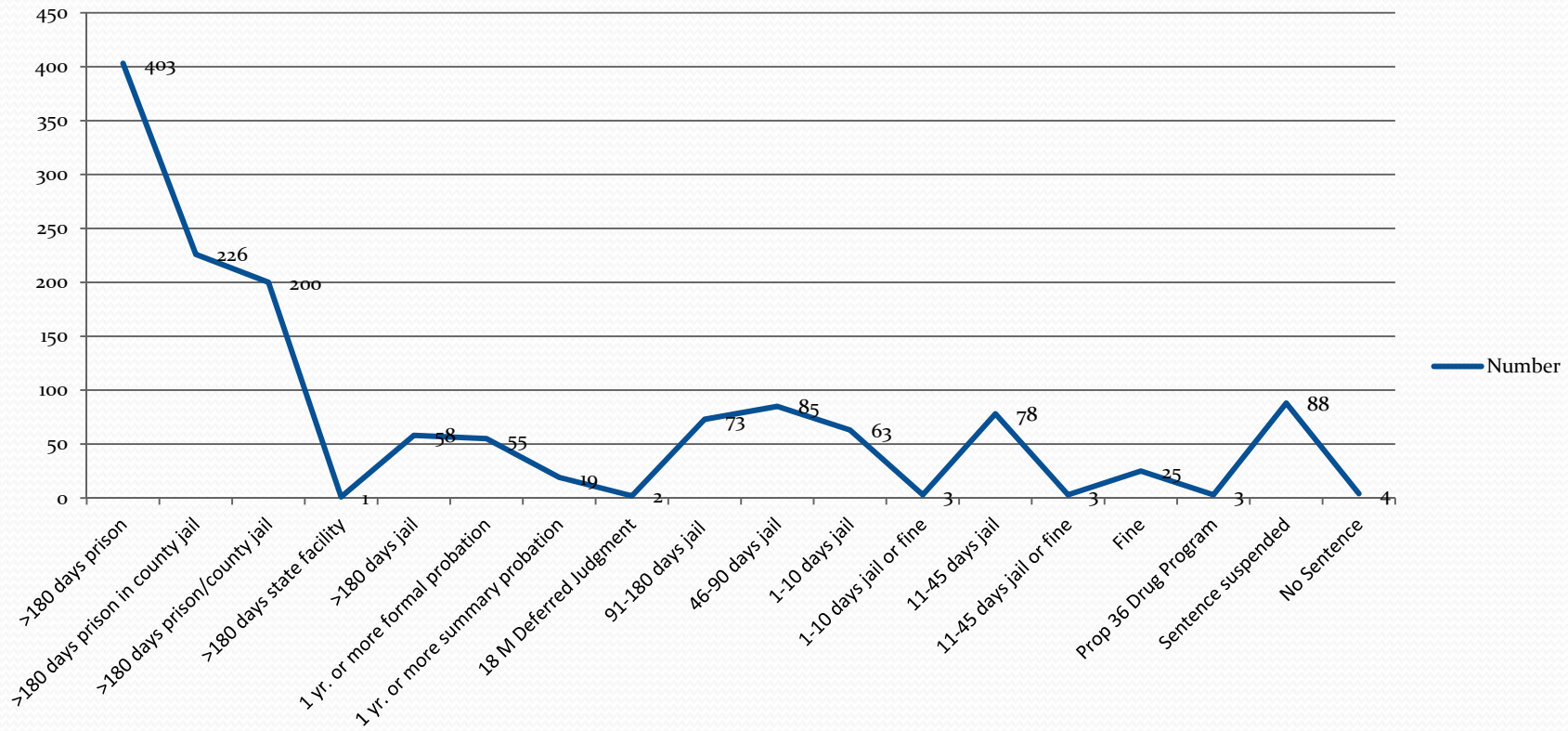
- Revocations by Supervisorial District

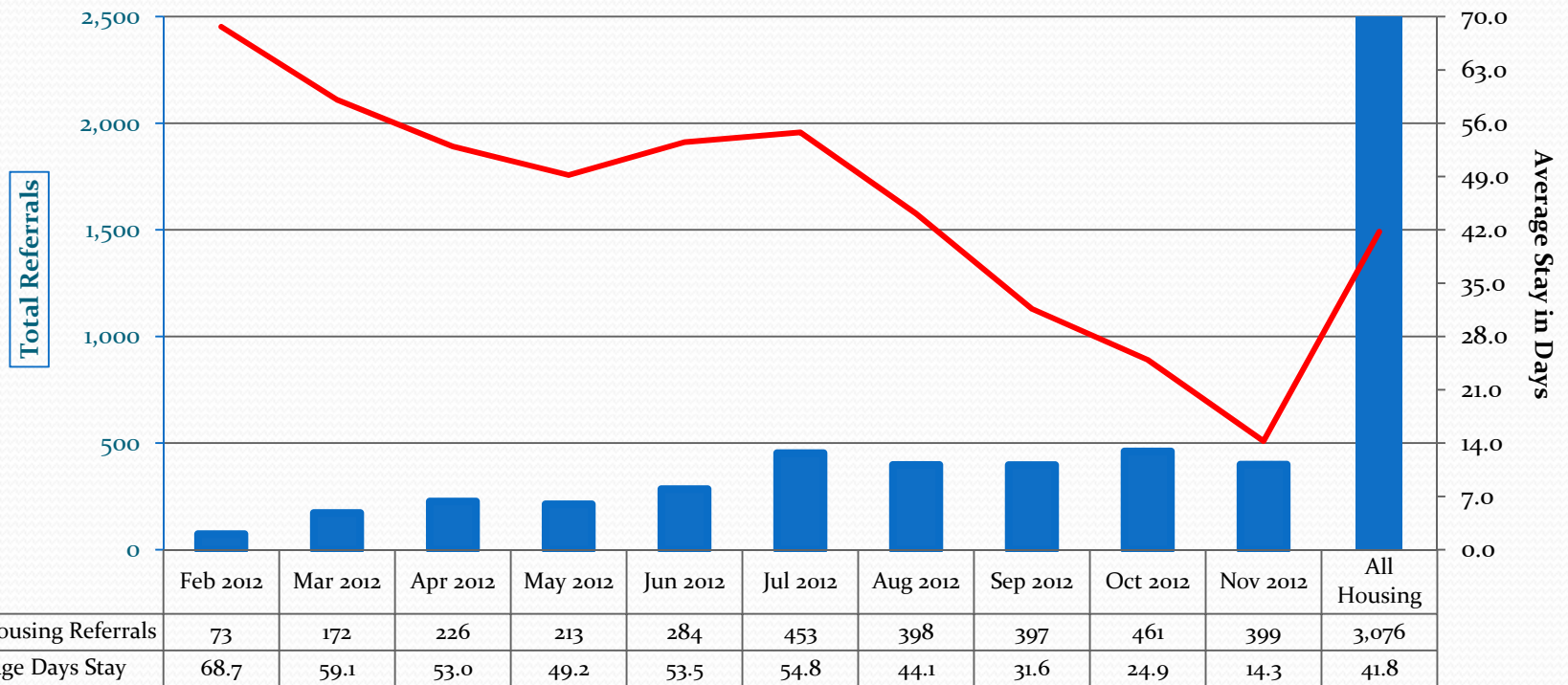
Services

 - DPH/SAPC co-located at DRC, LYN, AV and Revocation Court
 - Will co-locate at ESFV, PVY and RIO by June 30, 2013

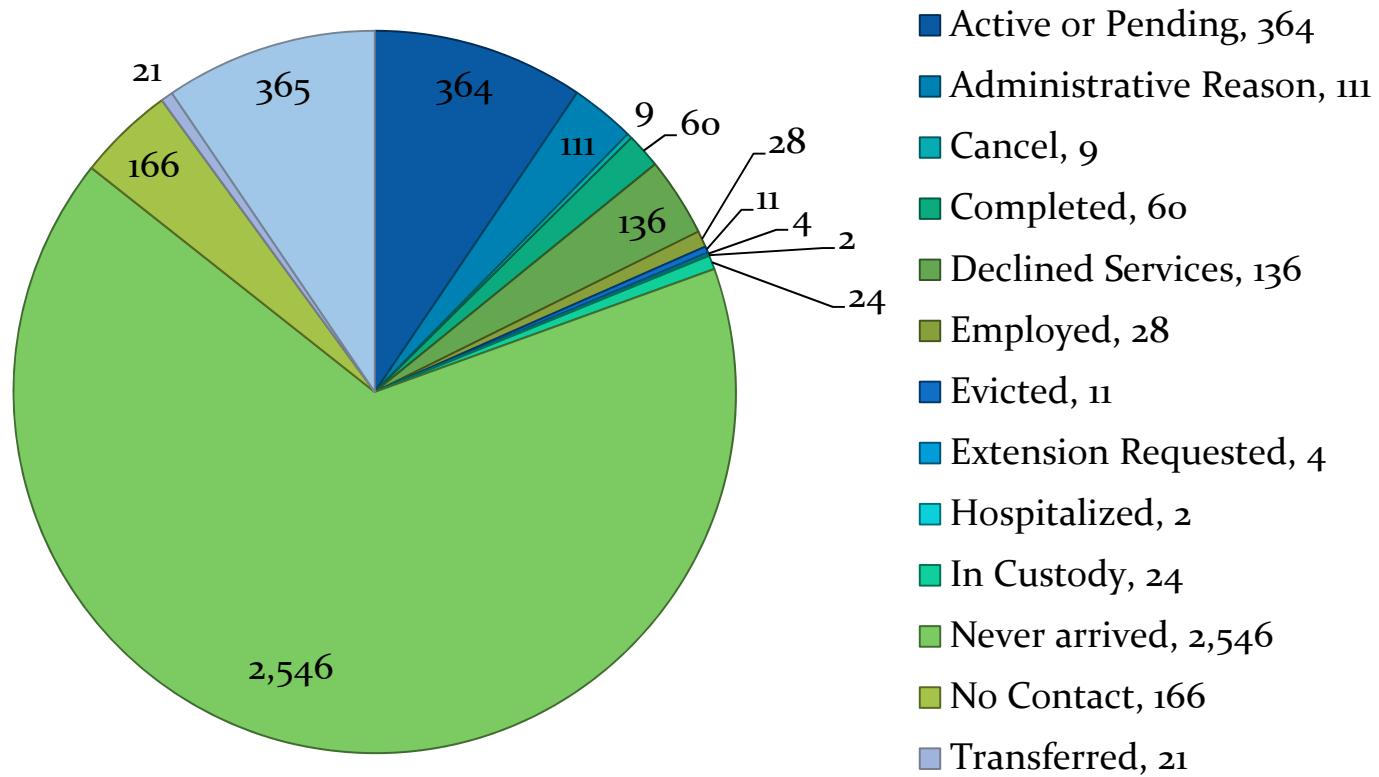
Transitional Housing Referrals February 2012 thru November 2012

- 3,483 Closed



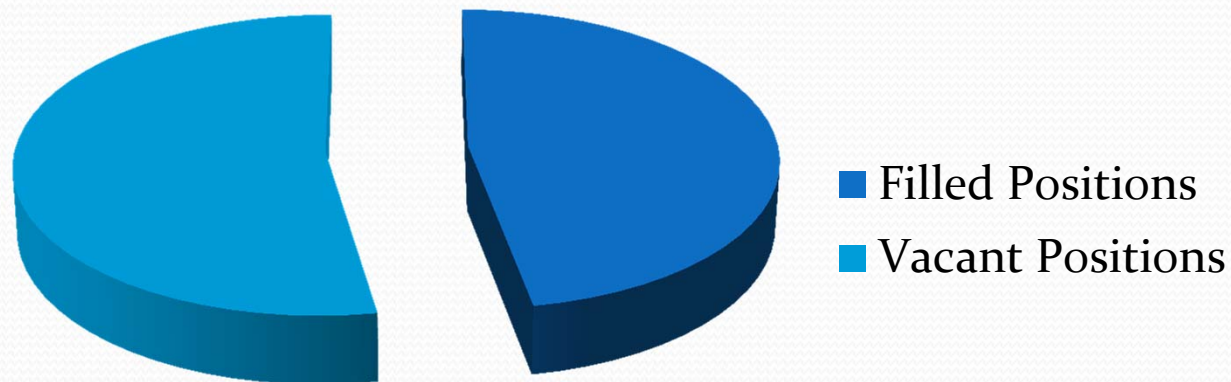


- Housing and Employment Contracts Update

 - Total positions 470, number hired 222, number vacant 248





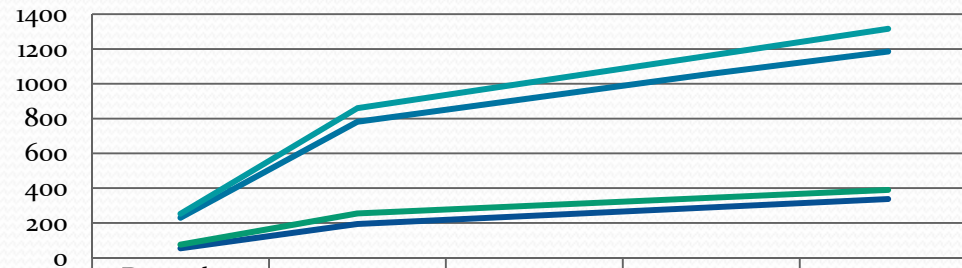
- Staffing
 - Recruitment
 - Department of Justice
 - Experience Level vs. Offender Sophistication
 - Space
 - Equipment
- Office Space
 - Only had space for 139, lacking space for 331 staff
 - Space Request submitted to CEO Real Estate for the procurement of 7 offices, to be located regionally, throughout the county. This includes the placements of office in the following areas:
 - South Los Angeles
 - West Los Angeles
 - San Fernando Valley
 - West San Gabriel Valley
 - City of Industry
 - South Bay
 - Antelope Valley



Lessons Learned

- Very High Risk require more intensive supervision
 - Mentally ill
 - Transient
 - Gang

- Housing
 - Long-term housing
 - Current contract does not assist with case management for long term permanency
 - Medical
 - No linkages to DHS for medical housing of medically fragile PSPs
 - Mentally Ill
 - Shortage of step-down facilities
 - Medically fragile and sex offenders excluded
 - Limited residential facilities for co-occurring



- Inconsistent use of applied sanctions
 - Newly promoted staff lacking field experience
 - Staff are now required to make decisions that used to be responsibility of the court
 - No consistency when sanctioning repeat offenders



Action Plan

The legend below provides a description of the levels of sanctions recommended for each violation type using non-compliance of treatment-substance abuse as an example.

1	Intermediate Sanction: Verbal Admonishment	4	Flash Incarceration (Range indicated 1 to 10 days maximum)
2	Intermediate Sanctions: Increased Supervision Level / Increased Supervision or Treatment Frequency / Added Conditions of Supervision/ PAAWS / Community Service	5	Revocation Petition (Range of recommended time indicated 11 to 180 days maximum.)
3	Intermediate Sanction: Electronic Monitoring (House Arrest) / GPS	@	Request for Absconder Arrest Warrant

- Very High Risk Caseloads
 - Lower caseload 20 to 1 for increased supervision and use of graduated sanctions
 - Implementation of Cognitive Behavior Treatment Programs
 - Collaborating with LASD to identify PSPs in custody for Just in Reach services while in custody
 - Linkages prior to release from custody



- Very High Risk Caseloads
 - Assign to Staff co-located with Law Enforcement
 - LAPD
 - 5 DPOs in place
 - Chief of Police Regional Services (COPRS)
 - 7 DPOs by 1/31/13
 - LASD Parole Compliance Team
 - 5 by 2/28/13
 - Independent Cities
 - 6 (2-Santa Monica, 2-Santa Clarita, 2-San Fernando)
 - 24 hour non-compliance hotline for providers
 - Completed on 01/03/13. The phone line is established and dedicated email address created for a referral of non-compliance and potential violation to the provider community (Healthright 360 Contractors, DMH, and DPH Providers).



- Systems modifications
 - Exception reports
 - Add-ins (intermediate sanctions, onsite drug testing)
 - Automated generation and monitoring of court reports
