## MEETING MINUTES October 23, 2023

#### **REGULAR SESSION**

A meeting of the Los Angeles County Employee Relations Commission was held on Monday, October 23, 2023 at 1:00 p.m. This was a hybrid meeting, i.e. in-person and via Zoom. The in-person meeting took place at the Kenneth Hahn Hall of Administration, 500 W. Temple St. Room 374-A, Los Angeles, CA 90012. A link for attendees was sent via email for those interested in participating in the meeting via Zoom. A phone number was provided for members of the public for public comment. This agenda was posted on the ERCOM website via the County of Los Angeles portal.

All three Commissioners attended the meeting. The meeting was called to order at 1:00 P.M.

Once that review is completed the final draft version will be sent to the Ercom agenda group and will be posted on the Ercom website. Approximately 60 days from that date of distribution a public hearing regarding the revisions will be held at the designated Ercom meeting. Currently, there is no timeline for that.

The Commission honored retired Commissioner Anthony Miller designating him, with the approval of the Board of Supervisors, as a Chair Emeritus for Ercom. Mr. Miller attended the meeting and gratefully accepted.
