2. Establishing Ordinances to Enhance Gun Regulation in Los Angeles County

Recommendation as submitted by Supervisors Hahn and Solis: Approve ordinances for introduction amending County Code, Title 13 - Public Peace, Morals and Welfare, Division 8 - Weapons, to prohibit the sale of .50 caliber firearms and ammunition, with certain exceptions, in the unincorporated County, and to prohibit the carrying or possession of firearms on County property, with certain exceptions; and take the following actions: (Relates to Agenda Nos. 61 and 62)

Instruct the Director of Regional Planning to prepare the ordinance to implement zoning regulations with a 1,000 ft buffer zone between firearm dealers and sensitive areas (i.e. "child safety zones") and between firearm dealers and other firearm dealers in the unincorporated County as set forth in the February 1, 2023 Report, and submit the final ordinance to the Board for its consideration; and

Instruct the Treasurer and Tax Collector to prepare the final amendments to County Code, Title 7 - Business Licenses, Chapter 7.46 - Gun Dealers, to enhance the regulation of firearm and ammunition dealers in the unincorporated County as set forth in the February 1, 2023 Report, and to submit the ordinance to the Board for its consideration, with these regulations to include the following:

Require ammunition dealers to obtain a Los Angeles County business license;

Restrict minors' presence in gun and ammunition stores and requires corresponding signage to be posted at entrance;

Require firearms dealers to maintain annual sales reports and make them available to the Department of Treasurer and Tax Collector (TTC) and/or law enforcement upon request;

Require firearms dealers to maintain a fingerprint log and make it available to TTC and/or law enforcement upon request;

Require firearms dealers to maintain and report inventory in real-time and make it available to TTC and/or law enforcement upon request;

Require firearms dealers to install and maintain security cameras and make footage available to law enforcement immediately upon request;

Require firearms and ammunition dealers to provide purchasers a letter regarding gun owner responsibilities and gun laws; and

Update all references to the California Penal Code in County Code Sections 7.46.010 and 7.46.030. (23-0593)

3. The Future of the Food Equity Roundtable

Recommendation as submitted by Supervisors Hahn and Horvath: Utilize the Food Equity Roundtable's Strategic Plan (Plan) as a roadmap to equitable food access for Los Angeles County and instruct the Acting Chief Sustainability Officer, to report back to the Board in writing within 90 days with the following:

Identify County leads and implementation steps for Roundtable priorities, by working in consultation with the Roundtable and County Departments listed, but not limited to, the Departments of Public Social Services, Children and Family Services, Public Health, Aging and Disabilities, Regional Planning, Public Works, Youth Development, Probation, and Economic Opportunity, and engage with the Roundtable in support of this work moving forward; and

Include a recommended set of priorities from the Plan, their associated implementation timelines, and the Departments relevant to implementation;

Direct the Acting Chief Sustainability Officer to include in the same report back a proposed structure, placement, staffing plan, etc., for an Office of Food Equity to facilitate future County efforts in support of implementing the Plan; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to continue working with the Acting Chief Sustainability Officer to advocate at State and Federal levels in support of the Roundtable's policy platform to improve food equity and food system resilience in the Los Angeles region. 6. Honor Ranch Development Project

Recommendation as submitted by Supervisor Barger: Authorize the Chief Executive Officer to negotiate and execute, and if necessary amend, extend, or terminate an Exclusive Negotiating Agreement (ENA) with TC LA Industrial Development, Inc., a subsidiary of Trammell Crow Company (Developer), for the Honor Ranch Development Project (Project) to be located on a County-owned property consisting of approximately 206 contiguous acres of undeveloped land located in the Santa Clarita Valley, for an initial 12-month term, which term may be extended at the discretion of the developer for a maximum of up to three additional six-month ENA extension periods, provided the developer meets certain stated milestones specified in the ENA, and where the ENA may be further extended for a maximum of six months due to County delays, but the total term of the ENA shall not exceed three years; authorize the Chief Executive Officer to negotiate the development agreements and any other ancillary documents, and execute any and all related or ancillary documents or amendments to the ENA and documents as contemplated by the ENA and to take such actions necessary to effectuate the ENA; and authorize the Director of Public Works, in consultation with the Chief Executive Officer, to manage the predevelopment phase of the proposed Project and to take such actions necessary to effectuate the ENA, including collecting deposits and fees in connection with the terms of the ENA, and administer the expenses and accounting associated with the ENA. 8. Support for Key Federal Gun Safety Legislation: Banning the Sale of Assault Weapons and High-Capacity Magazines and Raising the Age to Purchase Assault Weapons

Recommendation as submitted by Supervisors Solis and Hahn: Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to send a five-signature letter to Senator Dianne Feinstein with a copy to the Los Angeles County Congressional Delegation, in support of Senate Bill (S.) 25 (Feinstein) - the Assault Weapons Ban of 2023, and similar measures that would ban the sale, transfer, manufacture, and importation of military-style assault weapons, high-capacity magazines, and other high-capacity ammunition feeding devices, and S. 14 (Feinstein) - the Age 21 Act, and similar measures that would raise the minimum age to purchase assault weapons from 18 to 21. 9. Applying for the Ending Girls' Incarceration Initiative in Support of Los Angeles County's Efforts to Decarcerate Girls and Young Women

Recommendation as submitted by Supervisor Solis: Instruct the Chief Probation Officer and Executive Director of the Probation Oversight Commission, in collaboration with the Public Defender, the District Attorney, the Interim Director of Youth Development, the Director of Children and Family Services, the Superintendent of Schools of the Los Angeles County Office of Education, and most importantly, youth with lived experience, as well as engagement with the Courts, to apply for the California Health and Human Services Agency's Office of Youth and Community Restoration's and Vera Institute's Ending Girls' Incarceration Initiative by February 28, 2023; and take the following actions:

Instruct the Chief Probation Officer, Executive Director of the Probation Oversight Commission, and the Public Defender, to report back to the Board in writing in 30 days with the current status, and steps taken that addresses the County's efforts to decarcerate girls and young women, per Board Order No. 8 of November 30, 2021, "Decarceration of Girls and Young Women: Addressing the Incarcerated Youth Population in the Los Angeles County Camps and Halls", and with updates every 60 days, in writing, until completion, including, at a minimum, the following:

A status on completing the plan, with timelines and clear objectives, to decrease and decarcerate girls and gender-expansive youth;

A running census on the number of girls and gender expansive youth in the Probation's detention facilities for youth;

Identification of trends that are leading to the increase in girls and gender-expansive youth and proposed plan to address, with recommendations; and

Updates on engagement with County and community stakeholders and partners. (23-0584)

10. Action for American Heart Month 2023

Recommendation as submitted by Supervisor Solis: Proclaim the month of February 2023 as “Los Angeles County Heart Month,” affirming the County’s commitment to fighting cardiovascular disease; instruct the Director of Public Health, in collaboration with the Directors of Health Services and Aging and Disabilities, and the Interim Directors of Mental Health and Public Social Services, and other relevant Departments, to take the following actions:

Engage with health plans to promote evidence-based interventions to prevent heart disease, such as home blood pressure monitoring, reducing copays for antihypertensive medications, and removing pre-authorization for treatments that improve overall cardiovascular health;

Provide resources, messaging, and best practices to *promotoras* and community health workers to help prevent and/or manage complications from heart disease;

Engage with community-based organizations, academia, labor, and employers to promote strategies spearheaded by the American Heart Association to support cardiovascular and cerebrovascular health;

Implement a public messaging campaign utilizing social and ethnic media and distributing materials to promote heart health to key community partners to increase awareness of best practices for heart-health care;

Connect these efforts with the Department of Public Health’s efforts, pursuant to Board Order No. 18 of November 15, 2022, “Healthy Food Access for Diabetes and Prediabetes Prevention;” and

Report back to the Board in writing in 90 days with the results of the above directives. (23-0583)

11. Acting to Expand Services for the Misdemeanor Incompetent to Stand Trial Population

Substitute recommendation as submitted by Supervisor Mitchell: Instruct and authorize the Interim Director of Mental Health or the Director of Health Services, to be determined upon further discussion with the State Department of Health Care Services (DHCS), to accept \$100,000,000 in Assembly Bill (AB) 178 funds and authorize the Interim Director of Mental Health to enter into and/or amend any contracts, as necessary, to accept the funds. County Departments are not authorized to expend AB 178 funds unless they meet the requirements, as outlined below, or as stipulated in any agreement by the State; and take the following actions: (Continued from the meeting of 1-24-23)

Direct the Interim County Counsel, in coordination with the Chief Executive Officer, the Director of Health Services, the Interim Director of Mental Health, the Executive Director of Justice, Care and Opportunities Department, the Director of the State Department of Health Care Services, and/or other relevant parties, to review the Budget Act, AB 178, seek State guidance, and ensure any plans developed by the assigned Departments in response to Board Order Nos. 72-E, “Swiftly Creating More Beds for Persons Mentally Incompetent to Stand Trial (MIST) with Newly Available State Funding” and 16, “Addressing the Mental Health Crisis in Los Angeles County: Developing Mental Health Care Facilities to Help Depopulate the Jail,” from September 27, 2022, comply with the Budget Act’s provisions, with the written plans to be shared with the Board before implementation; instruct the Director of Health Services and the Interim Director of Mental Health, in coordination with the Chief Executive Officer, the Interim County Counsel and the Executive Director of the Justice, Care and Opportunities Department, to report back to the Board within 30 days with a revised written plan to implement the plans related to the MIST Funding, that among other things, addresses how the MIST Funding and Non-MIST Funding programming plans relate, and the Interim County Counsel will confirm in writing that proposed AB 178 plans comply with the Budget Act;

Instruct the Director of Health Services and the Interim Director of Mental Health, to implement the revised written plan for MIST funding upon confirmation by the Interim County Counsel that it complies with AB 178, and take the following actions:

Direct the Chief Executive Officer to authorize the Director of Health Services and the Interim Director of Mental Health, to hire, consistent with the revised written compliant MIST plan, via the Ordinance Position Authority, and authorize the Director and Interim Director to immediately recruit positions utilizing ordinance only positions; and

Authorize the Director of Health Services and the Interim Director of Mental Health to negotiate and execute Budget Act-compliant agreements, consistent with the revised compliant written MIST plan, with qualified Mental Health providers to provide acute hospital transitional beds to carry out the intent of the Board in adopting the plan, where the foregoing delegated authority includes authority to negotiate, on a case-by-case basis, appropriate changes to the standard County insurance and indemnification provisions, and other standard County contract terms;

Instruct the Director of Health Services and the Interim Director of Mental Health, and other relevant Departments, to report back to the Board in writing in six months after implementation of any AB 178 plan, and quarterly thereafter, on key metrics such as the number of MIST or non-MIST beds created, the contracted agencies providing services, the demographics of persons being served, the amount, average length of stay, and types of services (e.g. enhanced clinical care, inpatient care, mental health stabilization housing and supportive interim housing) provided, the number of clients referred to Department of Mental Health Intensive Care Division, Lanterman-Petris-Short conservatorship, Assisted Outpatient Treatment, and community-based treatment, and funding balance; and

Instruct the Director of Health Services and the Interim Director of Mental Health, to report back to the Board in writing in six months, and quarterly thereafter, if needed, on sustainable funding sources to support this program when the one-time funding is expected to be fully exhausted (i.e., Fiscal Year 2025-26 under the current plan), with the report to include strategies to explore all available potential State and Federal funding sources, including ongoing Medi-Cal funding, that will ensure the County has ongoing funds to carry on at least the same level of services for the program when the current one-time State funding is depleted. 12. Investigation into the Death of April Valentine While Giving Birth at Centinela Hospital

Recommendation as submitted by Supervisor Mitchell: Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to send five-signature letters to Governor Gavin Newsom, California Health and Human Services Secretary Dr. Mark Ghaly, State Attorney General Rob Bonta, State Senator Steven Bradford, and State Assemblymember Tina McKinnor, urging a State investigation into the care and circumstances surrounding the death of Ms. April Valentine, with a report back from State officials to Ms. Valentine's family, as soon as reasonably possible, on the outcomes of the investigation, with the letter to also request a review of Centinela Hospital's compliance with the California Dignity in Pregnancy and Childbirth Act. 13. Implementing Medi-Cal's Doula Benefit in Los Angeles County

Recommendation as submitted by Supervisor Mitchell: Instruct the Director of Public Health, in collaboration with the Director of Health Services, the Executive Director of the Anti-Racism, Diversity & Inclusion Initiative, managed care plans (MCPs), health care delivery system stakeholders, and key community partners, to report back to the Board in writing in 60 days with a proposal, including cost estimates and identification of potential State, Federal, and philanthropic funding sources (as a source of ongoing funding), to create (directly or through a contract with an outside agency) a hub for doula service providers to increase access to doula services, with the report to include an option for the hub entity to either contract with MCPs and subcontract with individual doula providers, to simplify contracting and billing, or to offer doula providers robust technical assistance to contract and directly bill MCPs or to explore both options, the report should also identify any other doula provider needs that can be addressed by the hub and incorporate proposals to meet those needs; and instruct the Director of Public Health, in collaboration with the Director of Health Services and the Executive Director of the Anti-Racism, Diversity & Inclusion Initiative, to report back to the Board in writing in 45 days on additional options to support the doula workforce and expand doula access in the County, including:

Enhanced efforts to increase the size and diversity of the County doula workforce by coordinating resources for pre-service and in-service education for doulas and doula trainees;

Opportunities to utilize existing and new funding resources to expand the Department of Public Health's African-American Infant and Maternal Mortality's capacity to support the Medi-Cal doula benefit rollout as part of a larger person-centered approach to pregnancy and birth (e.g., midwifery models of care, freestanding birth centers, group prenatal care, home visiting, etc.);

Any additional proposals to improve doula access throughout the County, including community information campaigns and methods of integrating doulas into existing birthing teams; and

Additional funding and staffing needed to carry out these proposed activities, if any, including an analysis of existing funding sources, gaps that would need to be filled to carry out this work, and potential funding sources. (23-0579)

14. Reestablish the Reward Offer in the Investigation of the Murder of Richard Allen Jefferson, Sr.

Recommendation as submitted by Supervisor Mitchell: Reestablish a \$20,000 reward offered in exchange for information leading to the apprehension and conviction of the person or persons responsible for the heinous murder of 65-year-old Richard Allen Jefferson, Sr., who was fatally shot while standing on the east sidewalk on the 1400 block of Paulsen Avenue in the City of Compton on September 19, 2018, at approximately 6:38 p.m. (20-6114)

15. Strengthening Gun Regulations in Los Angeles County

Recommendation as submitted by Supervisors Horvath and Solis: Instruct the Interim County Counsel to draft an ordinance within 90 days and report back to the Board with the proposed language, or incorporate language into pending gun licensing amendments, requiring signs to be displayed with specific language warning customers about the risk associated with access to firearms at any site where firearm sales or transfers are conducted in the locality; and to take the following actions:

Within 90 days, draft an ordinance and report back to the Board with the proposed language, requiring all firearms in a residence be securely stored in a locked container or disabled with a trigger lock; and

Report back to the Board in 90 days with options for draft ordinance language that would mandate liability insurance for gun owners in the County and the feasibility of implementing a County gun registry, or in coordination with the Sheriff's Department, ways to use existing data/records to create a gun database that is easily accessible for law enforcement first responders. 16. Declaration of Local Emergency for Homelessness - Implementation Actions

Recommendation as submitted by Supervisors Horvath and Barger: Adopt the three strategic missions - Encampment Resolution, Housing, and Mental Health and Substance Use Disorder Services (collectively, the PEH Missions), recommended in the Chief Executive Officer's report dated January 23, 2023, and instruct the Executive Director of the Homeless Initiative to develop a governance and implementation framework leveraging the Anti-Racism, Diversity and Inclusion (ARDI) equity tools to ensure equitable implementation of the PEH Missions, and establish goals and key performance metrics for each PEH Mission, with the encampment resolution and solutions to be led with care first, to ensure that when encampments are resolved, individuals living in those encampments have a safe place to go and are provided the housing and services they need; and take the following actions: (Relates to Agenda No. 1-D)

Authorize the Chief Executive Officer, in collaboration with the Interim County Counsel, Auditor-Controller, and impacted County Departments, to implement contracting and procurement changes in response to the proclamation of local emergency for homelessness (Homeless Emergency), unless otherwise required by State or Federal law:

Authorize the Chief Executive Officer and impacted County Departments, to enter into and/or amend agreements, for professional and other services, that support the Homeless Emergency and PEH Missions within the County, without adhering to the requirements of the County's Sole Source Policy or any other competitive procurement requirements and terminate said agreements as necessary, provided:

The Chief Executive Officer confirms in writing that there is good cause justification for the execution of the agreement, and/or amendment, in that it implements or is in support of a PEH Mission in response to the Homeless Emergency;

The Chief Executive Officer confirms in writing that funds have been approved by the Board, or by a Board office, in its County Homeless Prevention Initiative - Homeless Services Fund, or are otherwise budgeted Federal, State or local funds that can be used to implement or support a PEH Mission in response to the Homeless Emergency; and

The term of the agreement, including all change or work orders, shall expire no later than two years after the Board terminates the Homeless Emergency, unless the Department has obtained Board authority to extend the agreement for a longer term;

For purchases of goods, including supplies, equipment, and services needed to implement or support a PEH Mission in response to the Homeless Emergency:

Authorize the Chief Executive Officer, and instruct the County's Purchasing Agent, as applicable, to the extent legally permitted, to approve any purchases that otherwise would require Board approval under current law, regulations, or Board policies, take any procurement or other actions necessary for the expedited acquisition of all goods, including supplies, equipment, and services needed, without adhering to the requirements of the County's Sole Source Policy, Purchasing Policies, or any other competitive procurement requirements, provided the Chief Executive Officer confirms in writing that there is good cause justification for the purchase, in that it implements or is in support of a PEH Mission in response to the Homeless Emergency, and when necessary, authorize the Purchasing Agent to make purchases in excess of \$250,000 without prior Board approval;

To improve hiring in support of PEH Missions in response to the Homeless Emergency:

Instruct the Director of Personnel to approve Departmental hiring without an examination, as authorized pursuant to Civil Service Rule 13.04, for all positions that support a PEH Mission, provided the Chief Executive Officer confirms in writing that the positions support a PEH Mission, in response to the Homeless Emergency, and that relevant qualifications have been met by the applicant;

Authorize Departments, to the extent legally permitted, to provide hiring and retention incentives for positions with a direct connection to a designated PEH Mission, including, but not limited to, signing bonuses, retention bonuses, longevity bonuses, bonuses for field-based work, or housing stipends, provided the Chief Executive Officer confirms in writing that the proposed positions support a PEH Mission in response to the Homeless Emergency, and sufficient funds are budgeted to support the positions; and

Authorize the Chief Executive Officer to temporarily delegate authority, for a period to be determined by the Chief Executive Officer, to Departments to approve new ordinance-only items and special step placements for positions that support a PEH Mission, provided the Chief Executive Officer confirms in writing that the proposed positions support a PEH Mission in response to the Homeless Emergency, and sufficient funds are budgeted to support the positions;

To expedite the use of property to support interim and permanent housing for people experiencing homelessness, find that making available County property or acquiring property to support a PEH Mission meets the social needs of the population of the County, pursuant to California Government Code Section 26227, and is in the best interest of the County and the general public, and authorize the Chief Executive Officer, using funds budgeted by the Board for this purpose, to:

Negotiate, execute and amend leases or other agreements, to make available, at less than fair market value to a public agency, nonprofit corporation, or nonprofit association, any real property of the County that is not and, during the time of possession, will not be needed for County purposes, to be used to support a PEH Mission in response to the Homeless Emergency, in compliance with Government Code Section 26227 and the California Environmental Quality Act (CEQA);

Negotiate, execute, and amend purchase and sale agreements and other agreements, to acquire real property for the purposes of subsection a, above, in compliance with Government Code Section 26227 and CEQA, and subject to the Chief Executive Officer conducting customary due diligence, with the purchase price supported by an appraisal, and take all further actions necessary and appropriate to complete the transactions, including opening and management of escrow, any administrative adjustments to the transfer documents, execution of all the requisite documentation for the completion of the transfer, and acceptance of the deed conveying title to the real property to the County of Los Angeles;

Negotiate, execute, and amend funding agreements and other agreements with public agencies, nonprofit corporations, or nonprofit associations receiving real property for the purposes of subsection a, above, to fund the improvement or development of facilities to support the PEH Mission on the real property transferred, in compliance with Government Code Section 26227 and CEQA; and

Authorize the Auditor-Controller to issue warrants, as directed by the Chief Executive Officer, for the above actions and any other related costs;

To improve homeless service delivery, delegate authority to the Departments to apply for, and accept new or expanded grant agreements, that support a PEH Mission, provided the Chief Executive Officer confirms in writing that the services funded by the grant support a PEH Mission in response to the Homeless Emergency, sufficient funds are budgeted for matching or other grant requirements, and adopt and instruct the Chair to sign a resolution authorizing County Departments to apply for, and receive State, Federal, or local funds and to execute all necessary agreements for use of such funds and to take all related actions, including execution of any necessary documents;

To optimize spending in support of the Homeless Emergency, delegate authority to the Chief Executive Officer to increase or decrease allocation amounts to County Departments, as well as the Los Angeles Homeless Services Authority and Los Angeles County Development Authority, and across service types for any Board-approved budgeted funding sources administered by the Homeless Initiative, including, but not limited to, Measure H revenue and Homeless Housing, Assistance and Prevention grant funds;

Clarify and declare that, in approving the above authorities and delegations of authority, it is also the intent of the Board to ensure appropriate oversight and stewardship of public funds, and therefore, direct the Chief Executive Officer to work with all impacted Departments to develop an implementation protocol for the above directives, which includes appropriate controls, tracking, metrics, auditing and regular public reporting, and report back to the Board in writing in 45 days on the implementation protocols; and

Direct the Chief Executive Officer to begin hiring the necessary staff within HI to implement the above authorities, as specified in the Chief Executive Officer's report dated January 31, 2023, and report back to the Board during the Fiscal Year 2023-24 Final Changes budget phase, with recommended position allocations and funding. In cases of an emergency, or when a subject matter needs immediate action or comes to the attention of the Board subsequent to the agenda being posted, upon making certain findings, the Board may act on an item that was not on the posted agenda.

The majority of the Board's Tuesday agenda is a consent calendar. All matters included on the consent calendar (including Board of Supervisors items and Administrative Matters) may be approved by one motion unless held by a Board Member for discussion. During the reading of the Agenda, the Executive Officer will indicate which items have been requested to be held for discussion or continued to a future meeting, and the remaining items will be approved. Items which are set for a certain time may or may not be called up at exactly the time indicated, depending on the business of the Board. The items that are held for discussion may be taken up at any time, depending on the business of the Board. Each item includes a brief summary of the Board member's motion or department's recommended action, and in some instances, a corresponding recommendation from the Chief Executive Officer, indicated in capital letters.

Included at the end of each agenda are items which have been continued from previous meetings for further discussion and action by the Board. This portion of the agenda is commonly referred to as the "A-item Agenda." At the request of a Supervisor, the A-items may be called up for consideration at any time.
