3. Ensuring the Uninterrupted Operation of Harbor-UCLA Medical Center's Teaching Programs

Recommendation as submitted by Supervisors Mitchell and Horvath: Instruct the Director of Health Services to negotiate, prepare, execute, and operationalize a sole source agreement with The Lundquist Institute (TLI), which may include modifications to, or waivers of, the County's contracting requirements for standard indemnification and other standard County contract terms not mandated by County ordinance, to provide personnel, specialized education and administrative services, and supplies to support the academic infrastructure of the Harbor-UCLA Medical Center (Harbor-UCLA) medical education physician training programs and the operational needs of Harbor-UCLA, execute future amendments to the agreement with TLI, as necessary; the agreement and any amendments shall not be less than 15 calendar days prior to the anticipated execution of any agreement, be submitted to the Chief Executive Officer and Board in its then-current draft form with the opportunity for the Board and Chief Executive Officer to provide feedback to the Director of Health Services within five calendar days thereafter; and the Director will proceed to execute the agreement and any amendments unless there are any unresolved Board or Chief Executive Officer concerns or questions following the previously mentioned five calendar days. 4. Supporting Youth-Centered Programming at Secure Track Youth Facilities

Recommendation as submitted by Supervisor Mitchell: Authorize the Director of Arts and Culture, in partnership with the Director of Youth Development and the Interim Chief Probation Officer, to launch the Drum Corp Program at Barry J. Nidorf Juvenile Hall and at other facilities where youth are housed, with the Probation Department to provide safety, staffing, and space for the programming; and authorize the Director of Arts and Culture to take the following actions:

Negotiate, execute, and amend (if necessary) a sole source agreement, not to exceed two years, with the Inner City Youth Orchestra Los Angeles to implement the Drum Corp Program, with a maximum contract amount not to exceed a grand total of \$500,000, which will be fully supported by funds provided by the Probation Department; and

In partnership with the Director of Youth Development and the Interim Chief Probation Officer, report back to the Board in writing within 180 days on efforts to launch the Drum Corp Program and progress on its implementation, as well as funding and staffing needed to sustain this level of programming. 5. Implementing Paid Family Leave as a Gender Equity and Poverty Alleviation Strategy for the County of Los Angeles to Remain an Employer of Choice

Recommendation as submitted by Supervisor Mitchell: Direct the Chief Executive Officer to report back to the Board in writing in 30 days with an implementation framework for a pilot program, to commence January 1, 2024, that provides eight weeks of Paid Family Leave (PFL) annually, for employees receiving Flex or Megaflex benefits who take leave under the Federal Family and Medical Leave Act or California Family Rights Act, with the framework to identify potential costs and the funding source for the pilot; work with the County's Joint Labor-Management Committee to, upon mutual agreement, re-open discussion regarding adding PFL as a benefit to County employees; and report back to the Board in writing in 90 days with a plan to implement a system to track employee retention and attrition rates by tracking separation numbers in eHR that accurately reflects the demographics of those voluntarily separating from the County and the reason for separation, including the cost associated with employee attrition. 6. Assessing the Los Angeles County's Risk Management Apparatus and Risk Readiness

Recommendation as submitted by Supervisor Mitchell: Direct the Chief Executive Officer to report back to the Board in writing within 120 days with an analysis and recommendations to enhance the County's Risk Management practices, including the following:

An evaluation of existing risk management data analysis, dashboards, scorecards, and practices, along with a plan to standardize the best risk management analyses, dashboards, and practices to help inform County Department Heads' strategies to improve the liability risks of their Departments;

A recommendation on a standard the Board can establish for Departments as a baseline ceiling, such as Fiscal Year 2021-22 numbers, for the number of liability claims and percentage of their budget for payments of vehicle liabilities, general liabilities, employment malpractice, or employment practice liabilities, law enforcement liabilities, and medical malpractice liabilities;

A recommendation on the cadence the Board should use to review/reset the baseline standard, as well as revisit the claims cost and payment reduction target;

A recommendation of a reasonable reduction target by which all County Departments must reduce their number of claims on an annual basis and by the end of Fiscal Year 2026-27 (July 1, 2027);

A recommendation on the feasibility of reinvesting a portion of the savings from non-workers compensation moneys paid (savings determined by the amount the actual annual cost is below the baseline level), into an appropriate strategy to improve the County's risk resiliency, including a recommendation on the appropriate portion of the savings to be used and strategies that may be considered to improve the County's risk resiliency;

A recommendation on the timelines Departments should comply with to implement non-worker's compensation liabilities corrective action plans;

Recommendations on a framework of accountability for Department Heads to successfully implement corrective action plans and reach reduction target levels; and

Recommendations to recognize and incentivize Departments and Department Heads for meeting the annual liability claims reduction target;

Direct the Chief Executive Officer, in consultation with County Counsel and the Interim Auditor-Controller, to report back to the Board in writing within 120 days on the following:

Identification of the five most risk-vulnerable County Departments using liability claims data;

An analysis of the five most risk-vulnerable Departments which includes:

A tally of the risk management corrective action plans that were recommended to these Departments over the past five years;

Identification of the corrective action plans that were and were not implemented;

Evaluation of whether implemented corrective action plans were appropriate/thorough in addressing the risk/issue; and

Details of which unimplemented corrective action plans directly or indirectly resulted in further liabilities to the County;

Instruct the Interim Auditor-Controller to report back to the Board in writing within 90 days with a review of the County's processes for tracking risk management corrective action plans, monitoring and verifying implementation of the corrective action plans, reporting on the implementation status of corrective actions plans, and for linking prior corrective action plans with subsequent liability events, including any recommendations to improve these processes and related controls;

Direct the Chief Executive Officer, in collaboration with County Counsel, to review the risk management corrective action plan implementation every two years, starting in calendar year 2025, of the five most risk-vulnerable County Departments, and include the results of the review in the Chief Executive Officer's Risk Management Division's Annual report, biennially, and reflect the progress against the established baseline ceiling and reduction target; and

Authorize the Chief Executive Officer to contract with a third party, or leverage existing risk management consultant contracts, to assess the County's Risk

Management as it pertains to Risk Mitigation, Liability claims and Privacy apparatus and determine strengths, deficiencies, and opportunities for improvement, and report back to the Board in writing within 120 days, with the analysis, funded from existing Chief Executive Office resources, to include assessing the risk management structure, framework, operations, and budget and the cost should not exceed \$250,000, and also review existing and potential Federal and State laws to determine the County's level of exposure to risks given those laws and provide corrective action plans for the County to be more risk resilient. 7. Proclaiming June 24, 2023, as “Play Day” in Los Angeles County

Recommendation as submitted by Supervisor Mitchell: Proclaim June 24, 2023 as “Play Day” throughout Los Angeles County, and recognize the LA84 Foundation and the Play Equity Fund for their dedication and service to the community and for developing “Play Day” as a national movement and a National Day of Play for youth; direct the Chief Executive Officer, through the Countywide Communications Office, to work with all County Departments to highlight this day on the County websites and social media platforms, and encourage all County residents to go out and play on June 24, 2023; and take the following actions:

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to support Senate Bill 291 (Newman) - Pupil Rights: Recess, legislation which would advance play equity by ensuring all K-6 pupils in California have access to a minimum standard of recess while prohibiting the withholding of recess as a form of punishment or discipline; and

Instruct the Director of Parks and Recreation, in collaboration with the Chief Executive Officer, the Directors of Youth Development, Public Health and Mental Health, the Superintendent of Schools of the Los Angeles County Office of Education, and other relevant Departments and community partners, to report back to the Board in writing within 120 days with recommended actions the Board can take to accelerate closing the Play Equity Gap for youth in the County. Recommendation as submitted by Supervisor Mitchell: Establish a \$20,000 reward offered in exchange for information leading to the apprehension and conviction of the person or persons responsible for the heinous murder of Andrew Price, who died from injuries sustained in a drive-by shooting that occurred near a sidewalk on 13301 South Wilkie Avenue in the City of Gardena on November 30, 2019, at approximately 8:49 p.m. (23-2106)

10. Silicosis Prevention and Care

Recommendation as submitted by Supervisors Horvath and Mitchell: Proclaim the month of June as “Silicosis Awareness Month” throughout Los Angeles County to raise awareness of the negative health effects of silica; instruct the Director of Public Health, in consultation with the Directors of Health Services, Consumer and Business Affairs, Economic Opportunity, and Public Social Services, in collaboration with State and community partners, to report back to the Board in writing in 120 days on outreach and education plans targeting stone fabricators, employees in the industry, impacted communities, and consumers, regarding the health risks associated with silica-fabricated stone, including the following:

The development of targeted multilingual outreach and education materials and messaging to be distributed via media and physical outreach to the various groups;

Outreach efforts including, but not limited to, communications activities in partnership with the Department of Consumer and Business Affairs’ Office of Labor Equity and Office of Immigrant Affairs, the use of Promotoras, and in collaborations;

Strategies to engage workers in the stone industry to understand risks and protective measures and to get screened and receive treatment if symptomatic, and further, to offer support services where applicable, including, but not limited to, linkage to public assistance and social services programs, Healthcare enrollment, and linkage to employment opportunities;

Collaboration with the California Department of Public Health, California’s Division of Occupational Safety and Health, Cal/OSHA, the Department of Consumer and Business Affairs’ Office of Labor Equity, and others, as appropriate, on the outreach strategy and efforts to engage stone fabricator businesses to provide information and ensure compliance with existing standards and regulations;

Instruct the Director of Public Works, in collaboration with the Director of Internal Services, County Departmental facilities management staff, and others, and in consultation with County Counsel, to report back to the Board in writing in 45 days with recommendations concerning the Board potentially enacting a County ban on the future use, specification, or purchase of silica engineered stone on all County capital projects by all County Departments, which should include guidance that any fabrication and installation of already

purchased silica stone should only be done by the County and contractors following best practices and State guidance, in consultation with the Department of Public Health;

Instruct the Director of Public Health, in collaboration with the Directors of Economic Opportunity, Health Services and Consumer and Business Affairs, and in consultation with County Counsel, to report back to the Board in writing in 90 days on the options to ban the sale, fabrication, and installation of silica fabricated stone in the County, including a plan to educate and advise businesses, with options for the use of other construction materials with less health risks to workers, and an outreach and engagement plan for Department of Economic Opportunity to provide guidance to businesses who might be affected by the ban of sale of silica engineered stone in the unincorporated County, and provide them with grant, loan and technical assistance, including outreach to transitioning businesses for worker-ownership opportunities, and rapid reemployment and training, and to provide support for workers for rapid reemployment and training opportunities; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, in collaboration with County Counsel, and the Directors of Public Health and Health Services, to report back to the Board in writing in 60 days on legislative and regulatory advocacy options at the State and Federal levels to educate regarding the health risks associated with the use of silica-fabricated stone, strengthening regulatory enforcement, and banning the product. Recommendation as submitted by Supervisor Horvath: Support the ratification, certification, and publication of the Equal Rights Amendment as the 28th Amendment of the United States Constitution; direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to send five-signature letters to the authors of the following bills, House and Senate leadership, and President Joseph R. House Joint Resolution 25, by Congresswoman Aryanna Pressley, legislation which affirms the ratification of the Equal Rights Amendment, which is a bi-partisan bill with 202 co-authors;

Senate Joint Resolution 4, by Senator Benjamin L. Cardin, which Majority Leader Chuck Schumer has filed for reconsideration and would provide for certification of the Equal Rights Amendment; and

Forthcoming legislation by Congresswoman Cori Bush that would direct immediate adoption and publication of the Equal Rights Amendment, with support to only be provided if the text of the bill is in alignment with the intent of this motion, to support the adoption and publication of the Equal Rights Amendment. 16. Moving Forward with Steps to Implement CARE Court in LA County

Recommendation as submitted by Supervisors Hahn and Barger: Instruct the Director of Mental Health to take the following actions:

Work with the Chief Executive Officer to review the Community Assistance, Recovery, and Empowerment (CARE) Court program plan, and as necessary through existing, available financial resources to sustain programming, allocate the necessary clinical, administrative, and programmatic items needed to implement the CARE Court program, including taking any steps needed to allow the Department to immediately and successfully recruit and hire for these positions, including, but not limited to, the following:

Using existing delegated authority and if necessary, providing existing delegated authority to the Director of Mental Health for ordinance position authority and special step placements for a period to be determined by the Chief Executive Officer;

Utilizing the County Emergency Declaration on Homelessness hiring protocols for emergency appointments;

Approving job-related specialty exams that recognize relevant expertise and lived experience;

Extending any relevant incentives, bonuses, special pay practices for these field-based items, so long as sufficient existing resources exist to allocate and sustain such incentives; and

Immediately identifying and hiring a manager, and/or clinical and support team members, dedicated to CARE Court implementation and starting the process to identify and hire additional staff;

Coordinate with the Chief Executive Officer to identify potential properties and facilities that are needed to support CARE Court activities and personnel;

Collaborate with the Director of Public Health, through Substance Abuse Prevention and Control (DPH-SAPC), to develop referral workflow, eligibility requirements and treatment coordination plans to ensure alignment of SAPC housing resources funded by Behavioral Health Bridge Housing for the CARE participants;

Advocate for the Mental Health Services Oversight and Accountability Commission, with support from the Chief Executive Officer, to prioritize the Innovations project for CARE Court Peer/Supporter items to be heard as soon as possible, so that the Department of Mental Health (DMH) can hire and train staff to be in place by December 1, 2023;

In consultation with the Chief Executive Officer, report back to the Board in writing in 90 days on progress achieved on these items listed above, as well as general updates on the CARE Court implementation project, and every 120 days thereafter until the implementation is complete; and report back to the Board in writing in 60 days with the estimated ongoing and one-time costs of implementation, any offsetting ongoing and one-time State, Federal, and Departmental revenues, and any resulting funding gap and options to bridge the funding gaps within DMH's existing resources; and

Authorize the Director of Mental Health to negotiate and execute new agreements, including sole source and/or amendments with qualified providers, including revisions to statements of work, extension to agreement terms and/or increase contract sums, provided such actions do not exceed Board approved funding to deliver services to CARE Court populations; and enter into non-monetary agreements, including statements of work and memoranda of understanding, with other private and public entities to facilitate increased communication and information exchange to comply with the legislative mandates for service coordination, outcome reporting, and financial reimbursement of County services rendered to members of managed care plans and private insurance. Review outcomes, the quality and accessibility of services, and type of resources provided to LGBTQ+ communities, in collaboration with County Departments and other relevant stakeholders, including: visiting sites and conducting interviews with LGBTQ+ recipients of these services to the extent permitted by law; receiving input from all stakeholders, including public, private, and community-based stakeholders regarding County administered or County-contracted services; conveying information received to the Board and relevant County Departments; and, where appropriate, make associated recommendations for improvement;

Instruct the Director of Personnel to make the “Transgender Awareness: Working with Constituents and Colleagues” training part of the mandatory training for all County employees and contractors; and offer additional trainings for County employees to better serve the LGBTQ+ communities;

Direct the Chief Executive Officer, in consultation with the Executive Officer of the Board, to report back to the Board in writing during the final or supplemental budget phase with a recommended funding and staffing plan for the LGBTQ+ Commission, with the funding plan to include: a proposed budget for commissioner compensation, transportation, and other costs; LGBTQ+ Commission staffing and administrative support, including a full-time Executive Director with experience promoting, supporting, advocating, and creating programs, services, and resources for LGBTQ+ communities; and with the Executive Officer of the Board to immediately work with the Director of Personnel to begin recruitment for the Executive Director, but no formal offer shall be made without Board approval of the funding plan; and

3-D. 2023-2028 Housing and Community Development Consolidated Plan and the 2023-2024 Action

Execute CDBG Reimbursable Contracts with 48 participating cities to provide a total of \$9,076,700 in CDBG funding for eligible activities, effective from July 1, 2023 through June 30, 2024;

Execute a CDBG Reimbursable Contract with the City of Covina for the purpose of repaying a Section 108 Loan previously approved by the Board, and set aside approximately \$182,369 of the City of Covina's FY 2023-24 CDBG allocation for repayment of the Section 108 loan;

Amend the Action Plan from time to time, as necessary, to address the cancellation and/or inclusion of off-cycle projects, as well as any necessary non-monetary and monetary amendments up to \$200,000, to projects being undertaken by the County, participating cities, and recipient agencies during FY 2023-24, and include Federal regulatory changes and new HUD directives;

Terminate CDBG Reimbursable and Advance Contracts utilizing FY 2023-24 or prior year funds, when the operating agencies fail to address administrative deficiencies, CDBG Program compliance issues, or other contract obligations;

Execute agreements with Los Angeles Urban County participating cities, or other entitlement cities, to provide administrative and construction management and oversight of their CDBG and HOME Programs, including procurement, contracting for, and carrying out construction projects within these jurisdictions;
