





But don't expect his keynote to be about football. In 2012, DJ founded the Defend the Dream nonprofit, which provides low-income and inner-city youth the opportunities and resources to reach their full potential in school and in life. The foundation has transformed libraries by donating more than 25,000 children's books. Launching its first Austin outreach project in 2022, the foundation is investing nearly \$50,000 into the Oak Springs Elementary School library by installing a multifunctional space for students to read and learn.

CSA SPOTLIGHT: Hoping for the Best, Preparing for the Worst – Legal Issues in School Safety
