VALUE ADDED TAX (VAT) POLICY

CRNK is not a VAT Payer, and Slovak customers are not charged Slovak VAT (20 %).

Non-European customers are not charged Slovak VAT (20 %).

European business entities registered for VAT need to provide a valid VAT ID during the Checkout process, in which case they are charged 0% VAT. You need to declare and pay the associated value-added tax (the so-called ‘reverse charge’ procedure) in your country.

European business entities not registered for VAT and private persons (not a business entity) are not charged Slovak VAT (20 %).

PAYMENT METHOD

CRNK accepts all payment types (bank transfer payments, credit/debit card) via payment service provider GoPay. Customers may be requested to accept GoPay’s policies before processing their payments. We do not accept cheques.

ORDERING, PAYING AND DELIVERY

Select licence(s) and font(s) you wish to purchase and proceed to check out. Fill in your purchase and invoice details and finalise the order. You have to agree to our EULA to proceed. If you have paid your order online, you will receive a download link to your ordered fonts via email. The files are compressed in .zip format. If you’ve paid by bank transfer, you will receive email immediately after confirmation of payment. Please make sure to check the correct purchase of your fonts before download. Should you have any problems downloading or uncompressing the font files please contact us. Please check also your spam folder, if you do not see email from us. CRNK has right to limit the number of repeated downloads.

CANCELLATION

Fonts are software – digital product. Once the font order has been paid (you have access to files) or the font has been downloaded, it cannot be returned or exchanged. Please check the content your cart and ensure that you selected the right fonts and licenses. Should you encounter an unexpected problem with your purchased fonts, contact us by email.
