

## Heritage-Elanco Supplier Invoicing Channels\*

The following invoicing changes will go into effect early 2021 for heritage-Elanco suppliers only. While some countries will not use Ariba for invoicing due to local regulations or requirements, all suppliers will receive purchase orders through Ariba from Elanco.

Specific details related to supplier country go-live date, change of email and/or local addresses, timing for Ariba onboarding and more will be communicated to suppliers directly. Suppliers should continue to manage invoicing for heritage-Elanco orders through their existing method until notified.
