Designated Employee Representatives/Contact Information: Do you have the correct people listed to receive the results they should be getting? We can list as many DER's as you need, and delineate exactly what results they receive on an individual basis. Remember that as your staff changes, it is important to let us know so we can get new staff quickly in the system to avoid delays.. This is also critical if you use iSystoc as we need to disable their rights to information if they are no longer a DER for your company.

Workers Compensation Carrier or TPA: Have you recently changed WC carriers, or are using a new Third Party Administrator (TPA) for medically managing your employees? From a billing standpoint we want to make sure the correct insurance company or TPA is getting the bills so they can pay promptly.

Services: Are the services you currently have up to date or has there been changes to company protocols? Is a drug screen now required for post-accidents and if so what panel? Having the correct services lined up for the visit saves time and work for all involved.

iSystoc: As you may be aware, Baptist Occupational Health does offer all of our clients free access to our secure and HIPPA compliant Electronic Medical Record portal, iSystoc. This allows you and you DER's access to the needed medical records without waiting on them being e-mailed or faxed to you.
