WHAT DOES SPEEDY CASH® / RAPID CASH DO WITH YOUR PERSONAL **INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you

have with us. This information can include:

- Social Security number and income
- Account balances and Employment information
- Credit history and credit scores

All financial companies need to share customers' personal information to run their everyday business. 	 Nonaffiliates we share with can include direct marketing companies. 		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners include program managers for stored value cards.		

Other important information

You may have other privacy rights in some states under state law. To the extent that such state laws apply, we will comply with them when we share information about you. <u>California Residents</u>: We will not share your personal information except to the extent permitted under California law. <u>North Dakota Residents</u>: We will not disclose information about you with affiliated companies or with non-affiliated third-party parties, other than as required or permitted by law, without your express permission
