Refer a Friend Scheme – One4all Gift Card Offer

We love having you with us, and we'd like to get to know your Friends too! Our Refer a Friend offer gives you the chance to get rewarded for spreading the word. So, when you invite a Friend to join us, and they sign up to our Dual Fuel offer directly through us, you'll both get a €50 One4all Gift Card!

The existing customer who is going to refer a friend, will be called the Referrer for this document and the friend who will be introduced to Bord Gáis Energy ("**BGE**") will be called the Friend.

For the Referrer

To participate in the Refer a Friend programme, to become a Referrer, you must be an existing Bord Gáis Energy ("**BGE**") customer and log into or create an online account and become a Rewards Club Member. Once you've logged into your online account, you can go to the dedicated Refer a Friend page and get your unique hyperlink and share with your Friend, which is someone you know personally, who isn't already our customer and who you think will want to receive the referral link and gift card!

For the Friend

In order for you and the Referrer to qualify for a €50 One4all Gift Card, you will need to use the referral link sent to you by the Referrer and sign up for a one year fixed term contract for Dual Fuel (Gas & Electricity) with a 21% Discount off Gas & 21% Discount off Electricity (the "**Referral Offer**") via www.bordgaisenergy.ie. You'll also need to sign up for paperless billing and to pay by direct debit. The Dual Fuel (Gas & Electricity) supply service is subject to BGE's Terms & Conditions of Dual Fuel Supply for Residential Customers which can be found [here](#). You'll receive a copy of these when you sign up!

Please note that an early exit fee of €50 will apply if you leave before the end of your fixed term of one year. The above percentage discounts are off the BGE standard unit rates for gas and electricity for a period of 12 months. After the 12-month period, if you choose to continue to pay by direct debit and keep using paperless billing we'll reward you with a 5% discount off the standard unit rate for gas and electricity. Prices are effective from 1st Oct 2020 and are subject to change.

General Terms for Both the Referrer and the Friend

The €50 One4all Gift Card is subject to the Friend purchasing the Referral Offer and the Friend's contract or policy remaining active for at least 14 days after the supply start date or the policy start date. The €50 One4all Gift Card will be shared by BGE with the Friend and the Referrer by email within three months of the Friend signing up for the Referral Offer and subject to the Friend remaining a customer for at least 14 days. BGE therefore requires valid email addresses of both the Referrer and the Friend so that we can send the €50 One4all Gift Cards out. If the Friend cancels their agreement with us within 14 days after the supply start date or the policy start date or if, for any reason, the Friend's gas and/or electricity account does not become active, we will not send the Referrer or the Friend the One4all Gift Card.

The Referral Offer is only available to new customers to BGE, who avail of the offer through a Referral Link shared by an existing BGE Rewards Club member. The Friend must not hold a gas or electricity account with us at the time they receive the Referral Offer. If the Friend uses an email address which we already have assigned to another customer of ours, we will see this as a self-referral and we will be unable to award either €50 One4all Gift card.

There is no alternative to this offer, if for any reason a customer cannot avail of the Refer a Friend offer. Restrictions may apply to the use of the Gift Card which is a matter for One4all, for more information please visit <https://www.one4all.ie/terms-condition>.
