We recommend that you read these terms and conditions carefully, as they set out our responsibilities to you and the terms and conditions which need to be complied with as a recipient of this Offer. By availing of this Offer, you agree to these terms and conditions. They are separate to and distinct from any other contracts you may have with us.

What the words mean

**“Bord Gáis Energy”** or **“we”** or **“us”** means Bord Gáis Energy Limited, a limited company incorporated in Ireland with company number 463078 and having its registered address at 1, Warrington Place, Dublin 2 and, for the avoidance of doubt, includes all employees, servants, agents, contractors, and sub-contractors of Bord Gáis Energy (and all employees of any such agents, contractors, sub-contractors and its subsidiaries).

**“End Date”** means 31st March 2026 or such other date as Bord Gáis Energy determines.

**“Qualifying Product”** means the supply and installation of a Solar PV System.

**“Building Energy Rating”** or **“BER”** is a certificate and a rating that indicates a building’s energy performance

**“Solar PV System”** means an electric power microgeneration system designed to supply usable solar power by means of photovoltaics supplied, installed, and commissioned by us at your property in accordance with the Solar PV Sale and Installation terms and conditions.

**“Solar PV Sale and Installation Terms and Conditions”** means the General Solar PV Sale and Installation terms and conditions entered into between you and Bord Gáis Energy in respect of the Qualifying Product.

- We reserve the right, at our absolute discretion, to reject, withdraw, or not provide you with the this Offer

This Offer remains strictly subject to you entering into a contract and paying the remaining cost of the Qualifying Product in full, in accordance with the Solar PV Sale and Installation Terms and Conditions.

## **General**

- This Offer may not be exchanged for cash or transferred to any other person or household. Only completions carried out by Bord Gáis Energy, its subsidiaries, and/ or a third party acting on behalf of Bord Gáis Energy will be eligible for this Offer.
- This Offer will end on the End Date. After the End Date, it will not be possible to avail of the Offer other than where you have completed an application for a Qualifying Product prior to the End Date, but the installation takes place after the End Date.
- From time to time, we may also make other changes to this Offer. In such circumstances, any Offer we agreed to provide to you before changes were applied to this Offer will continue to apply, subject to any qualifying criteria.
- We reserve the right to end this Offer at any time at our sole discretion.
