EMTALA and COVID-19: When Can Hospitals Divert Patients to Alternative Screening Sites?


The federal Emergency Medical Treatment & Labor Act (EMTALA) requires hospitals to provide a medical screening exam (MSE) for any patient who comes to the emergency department (ED). Additional requirements apply if the screening reveals an emergency medical condition.¹

Diversion Options that Hospitals Can Exercise on Their Own

ALL PATIENTS—The hospital may redirect ED patients to receive an MSE at an alternative on-campus site (i.e., within 250 yards of the hospital).²

Diversion Under a State or Local Ambulance Protocol


<u>AMBULANCES</u>—State/local officials may approve community-wide protocols directing ambulances to take certain patients to certain hospitals.



Off-Campus Diversion Pursuant to CMS's 1135 Waiver (effective March 1, 2020)4

ALL PATIENTS—A hospital may redirect ED patients to an alternative off-campus screening site, consistent with the state's emergency plan.

Under Section 1135 of the Social Security Act, CMS has the authority to waive certain federal healthcare requirements (including aspects of EMTALA), in accordance with a declaration issued on March 13, 2020 by the Secretary of Health & Human Services.
