

**VIRGIN ACTIVE SINGAPORE  
FIND SHARED WINS INSIDE: MEMBER REFERRAL CAMPAIGN  
(EXTENDED)  
TERMS AND CONDITIONS**



These Terms and Conditions govern the Find Shared Wins Inside: Member Referral Campaign ("Campaign") conducted by Virgin Active Singapore Pte Ltd ("Organiser"). By participating in this Campaign, participants ("Members") agree to be bound by these Terms and Conditions.

**1. Campaign Period**

The Campaign will run from 1 March 2026, 00:00 hours (Singapore time) to 30 April 2026, 23:59 hours (Singapore time) or until further notice ("Campaign Period").

**2. Eligibility**

- 2.1 The Campaign is open to all existing Members of the Organiser.
- 2.2 Participants must be at least 18 years of age at the time of participation.
- 2.3 Employees, contractors, its affiliates and their immediate family members of the Organiser are not eligible to participate.

**3. Referral Mechanism**

- 3.1 Members must refer friends using the unique referral link ("IAF Link") generated through their member account in mylocker.
- 3.2 Referrals made outside of the IAF Link will not be eligible for the Campaign.
- 3.3 All terms and conditions related to the standard "Invite a Friend" program, not explicitly addressed in these Terms and Conditions, can be found in the "Invite a Friend" terms and conditions located at [www.virginactive.com.sg/legal-stuff](http://www.virginactive.com.sg/legal-stuff).

**4. Raffle Draw and Prizes**

- 4.1 Eligibility for Entries and Allocation of Chances
  - 4.1.1 Members will receive entries into the raffle draw for each unique friend referred and fulfils the requirements below.
  - 4.1.2 A "unique friend referred" must fulfil all of the following:
    - Invitation via Organiser's member portal mylocker using the IAF Link during the Campaign Period,
    - Members must invite a friend using the Invite a Friend by sending the IAF link via mylocker.
    - The invited friend must visit any Virgin Active Singapore clubs and complete the check-in process at reception by 30 April 2026.
  - 4.1.3 Entries will be allocated as follows:
    - Members will receive one (1) entry into the raffle draw for each unique friend referred and fulfils the requirements below:
      - Invitation via Organiser's member portal mylocker using the IAF Link during the Campaign Period
      - Members must invite a friend using the Invite a Friend by sending the IAF link via mylocker.
      - The invited friend must visit any Virgin Active Singapore clubs and complete the check-in process at reception.
    - Members will receive three (3) entries into the raffle draw for each unique friend referred and fulfils the requirements below:
      - Invitation via Organiser's member portal mylocker using the IAF Link during the Campaign Period

- Members must invite a friend using the Invite a Friend by sending the IAF link via mylocker.
- The invited friend must visit any Virgin Active Singapore clubs and complete the check-in process at reception.
- The invited friend must sign up for a "Goal Getter" or "Long Termer" membership with the Organiser during the Campaign Period.

4.1.4 For avoidance of doubt, where a referred friend both attends a trial and subsequently signs up for membership during the Campaign Period, the Member will receive a total of three (3) entries in relation to that referred friend (and not a cumulative four (4) entries), unless otherwise stated by the Organiser.

## 4.2 Winners and Prizes

4.2.1 Five (5) winners will be selected at random from all eligible entries.

4.2.2 Each winner will receive S\$1,000 credit ("Credit") which can be utilised at Virgin Active Singapore and its clubs in Singapore.

4.2.3 The Credit may be used towards:

- membership dues, or
- personal training, or
- a combination of both.

4.2.4 Where the total value exceeds the Credit balance, the Member must top up and pay the difference.

4.2.5 A Member can only win one (1) prize.

4.3 The Organiser reserves the right to substitute any prize with another of equivalent value without prior notice.

4.4 Prizes are non-transferable and non-exchangeable for cash or other items.

4.5 The raffle draw will be conducted by 30 June 2026.

4.6 Winners will be notified via their registered email with the Organiser within 30 days of the raffle draw.

4.7 Winners will be asked to confirm, via reply email, how they would like to utilise the Credit (membership dues, personal training, or a combination of both).

4.8 Winners must respond via email to the Organiser within fourteen (14) calendar days from the date of notification. Failure to respond within this period will result in forfeiture of the prize. The Organiser reserves the right to discard the forfeited prize, donate it to a charity of its choice, or use it for any other purpose at its discretion.

4.9 To receive any prize, participants must be active members in good standing with the Organiser at the time of prize collection. This means no outstanding payments, no policy breaches, and no suspensions or disciplinary action. The Organiser reserves the right to verify eligibility and disqualify any participant who does not meet these criteria.

4.10 The Organiser's decision regarding the winners is final and binding.

## 5. Consent to Use of Personal Data

5.1 By entering this Campaign, you acknowledge, accept, and agree that The Organiser may collect, use, disclose, and process your personal data, including but not limited to your full name, contact details, photographs, and video recordings, for the purposes of administering the Campaign, contacting winners, and conducting marketing, promotional, and publicity activities, in accordance with the Personal Data Protection Act 2012 (PDPA) of Singapore.

- 5.1.1 You provide your explicit consent for the Organisation to use, reproduce, display, publish, and/or distribute such personal data (including your image, likeness, and/or voice, where captured) in photographs, audio, and/or video recordings, taken in connection with the Campaign.
- 5.2 Rights and Ownership of Media
  - 5.2.1 You acknowledge and agree that any photographs, video recordings, or other media (“Media”) captured by or on behalf of the Organisation during or in relation to the Campaign shall be the sole and exclusive property of the Company.
  - 5.2.2 You grant the Organisation, its representatives, agents, licensees, and assigns, full rights to use the Media for any purpose, including but not limited to advertising, marketing, digital and print promotions, across all touchpoints and media platforms (e.g., social media, website, printed materials, broadcast media), without the need for any further consent, notification, or compensation.
  - 5.2.3 Such rights granted to the Organisation shall be perpetual, irrevocable, worldwide, and royalty-free.
- 5.3 No Compensation
  - 5.3.1 You acknowledge and agree that your participation in the Campaign and provision of personal data and/or appearance in any Media is voluntary and that you shall not be entitled to any fees, royalties, or other compensation for such use.
- 5.4 Withdrawal of Consent
  - 5.4.1 You may withdraw your consent at any time by providing written notice to [privacy@virginactive.com.sg](mailto:privacy@virginactive.com.sg). However, you acknowledge that the Organisation may continue to retain and use such Media and data already collected and/or published prior to the withdrawal, to the extent permitted under applicable laws.

## 6. General Terms

- 6.1 The Organiser reserves the right to disqualify any participant found to be in violation of these Terms and Conditions or engaging in fraudulent or abusive activities.
- 6.2 Incomplete, duplicate or invalid submissions will be deemed ineligible for the Lucky Draw.
- 6.3 The Organiser reserves the right to amend, modify, or terminate the Campaign or these Terms and Conditions at any time without prior notice.
- 6.4 The Organiser shall not be liable for any loss, damage, or injury arising from or in connection with the Campaign or the prizes.
- 6.5 This Campaign and these Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore.
- 6.6 In the event of any dispute, the Organiser’s decision shall be final and binding.
