



VIRGIN ACTIVE THAILAND FREE 7-DAY PASS

Terms & Conditions:

4. To qualify for the free 7-day pass Offer, you must be 20 years old or older and must be a local Thai resident with ID card or a foreign resident with a valid Long-Term Visa. Tourist visa will not be accepted.
5. If the invitee is under 20 at the time of joining, their parent or guardian will be required to attend our Club in person to sign Virgin Active’s Membership Agreement and all associated forms.
