



## **Leo Express competition quiz**

### **General terms and conditions**

#### **I. Organizer of the competition**

1. The Leo Express Quiz Competition (hereinafter referred to as the "Competition") takes place by completing a quiz on the Leo Express website ([www.le.cz](http://www.le.cz)).
2. The organizer of the competition is the business company Leo Express s.r.o. with its registered office in Prague 3, Řehořova 908/4, postal code 13000, ID number: 06661572, entered in the Commercial Register kept by the Municipal Court in Prague, section C, insert 286532 (hereinafter referred to as the "organizer").

#### **II. Date and location**

1. The competition runs from 1st December 2021 to 17th December 2021 until 23:59. The competition begins by completing a quiz and providing the customer's e-mail after its completion (hereinafter "duration of the competition").
2. The competition takes place only on the territory of the Czech Republic and Slovak Republic.

#### **III. Conditions of participation in the competition**

1. The competition is open to any natural person over the age of 18, except for persons under Article III. paragraph 2 of these Rules (hereinafter referred to as "competitors").
2. Employees of the organizer, business partners and suppliers of the organizer, including their employees and collaborators, as well as all persons involved in organizing and ensuring the course of the competition, as well as persons close to the above persons in accordance with the provisions of § 22 of the Act may not participate in the competition. No. 89/2012 Coll., Civil Code, as amended (hereinafter the "Civil Code").

#### **IV. The principle of competition**

1. The principle of the competition is to fill in the quiz on the website and after completing the quiz to provide your contact e-mail no later than on 17th of December 2021. The winners will be randomly drawn by the organizer from all completed quizzes with the filled in contact e-mail.

2. The organizer of the competition is not responsible for incomplete or otherwise defective answer resulting in the impossibility of its use for the purposes of the competition in connection with technical or other complications on the part of the competitor or restrictions on the part of the organizer.

3. By sending the answer, the competitor consents to the publication of the name and surname when announcing the results of the competition. The winners of the competition will be contacted by the organizer no later than 10 days after the end of the competition.

4. The organizer of the competition reserves the right not to include a competition answer that does not meet the conditions set out in these Rules or to remove it from the competition at any time during or after the competition and without justification, without claiming any compensation.

#### **V. Rewards and prizes in the competition**

1. After the end of the competition on 17th of December 2021, the organizer randomly draws 100 winners from all completed quizzes with the filled in email address. The winners of the competition will be contacted via the given email address.

2. The subject of the prize in the competition is a voucher for 50 leo credits, which can be used to purchase tickets and refreshments from Leo Express. The voucher is valid until 17th December 2022.

3. To receive the prize, the winner must be registered in the loyalty program Smile Club of the organizer.

4. In the event that the winner does not contact the organizer within 10 working days after contacting the winner by the organizer, he loses the right to win and the prize will be awarded to another competitor who will also be randomly drawn from the correct answers received according to these Rules.

#### **VI. Responsibility of the organizer for the competition and personal data protection**

1. The organizer of the competition reserves the right to make the final decision in all matters related to the organization and conduct of the competition, including its interruption, postponement, revocation or modification of their Rules. The organizer of the competition is entitled at any time during the competition to change its Rules, ie the

methods of determining the winners, types of winnings, and in exceptional cases to cancel the competition. The organizer's right to intervene in the course of the competition includes the organizer's right not to award a competitor a prize in the competition if the organizer suspects that the competitor has violated or tried to circumvent the Rules of the competition. In such cases, the organizer is entitled to exclude the competitor from the competition, without the right to any compensation. The final decision on disputes always belongs to the organizer of the competition.

2. Winnings from this competition cannot be transferred to another competitor or a third party. Winnings cannot be enforced in court. Winnings cannot be paid out in cash or otherwise provided in kind. At the same time, the organizer of the competition is entitled to change the types of prizes at any time during the competition.

By participating in this competition, the competitor gives the organizer consent to the processing of provided or made available personal data in the range of name, surname and e-mail address in order to establish contact with the competitor, evaluate the competition and offer trade and services. funds pursuant to Act No. 480/2004 Coll., on certain information society services, for a period of 2 years from the granting of consent. The contestant grants the organizer, in case he / she becomes the winner of any of the prizes, consent to the publication of his / her name and surname on the organizer's social networks and in the leo Express Magazine. The provision of data is voluntary, but is a necessary condition for participation in the competition. The competitor who provided personal data to the organizer has the right to access personal data and other rights under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on free movement. these data and repealing Directive 95/46 / EC.

4. By participating in the competition, the competitor grants a separate consent to the processing, collection and storage of personal data under the conditions listed on the website [www.leoexpress.com](http://www.leoexpress.com) in the section Privacy Policy.

## **VII. Final Provisions**

1. The Organizer is not responsible for the completeness of the abbreviated version of these Rules, which may be published on promotional or other materials in connection with the competition. These Rules are considered to be the only complete ones within the competition.



2. Participation in the competition is voluntary and the competitor expresses his / her consent to its Rules by participating in the competition. Any violation or circumvention of these Rules by competitors or an attempt to abuse them is grounds for immediate exclusion of such a competitor from the competition.
