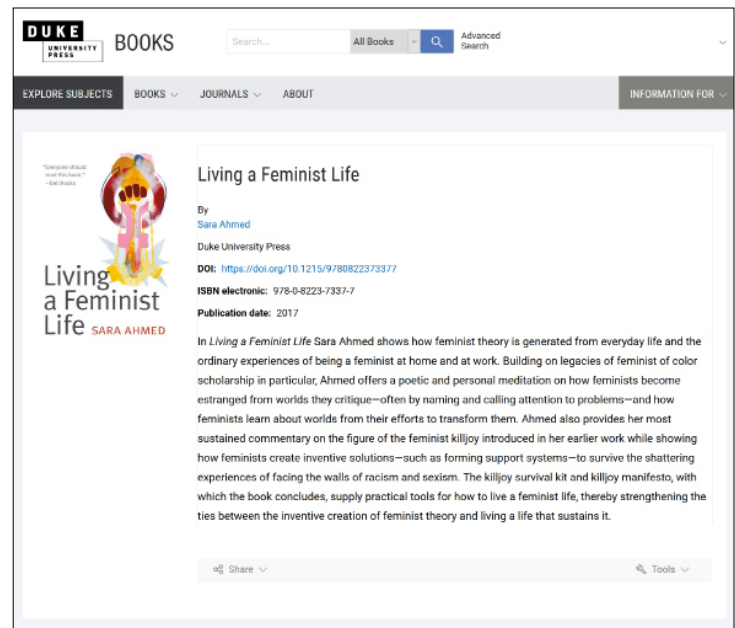
Evidence-Based Acquisition (EBA) is available for institutions seeking a flexible, usage-driven approach to building their Duke University Press ebook collections.

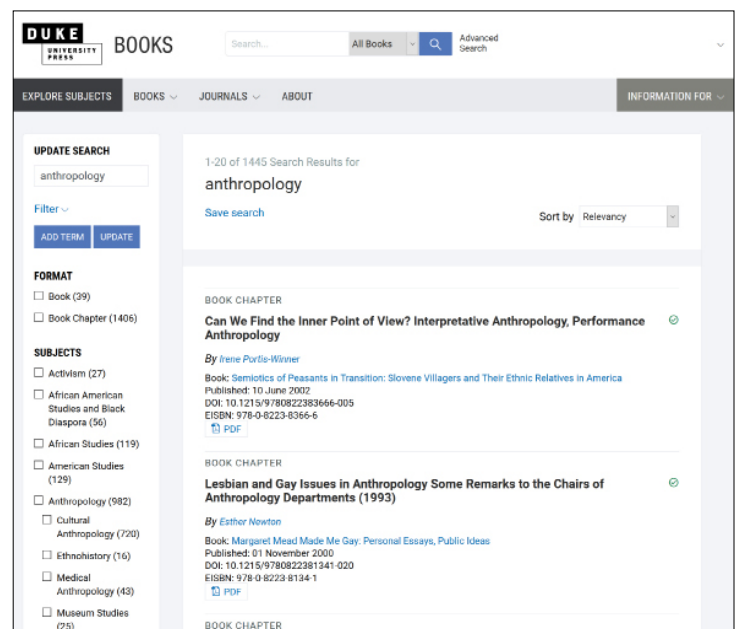
