## People in Oklahoma Connected to Benefits in 2022-2023

Thanks to federal funding that supports efforts to find and enroll low-income people on Medicare into benefits they are eligible for, 135,878 low-income older and disabled people in Oklahoma received assistance that can **help them to afford their prescription drugs and doctor visits.**

### This federal funding supports Oklahoma's:

- State Health Insurance Assistance Program (SHIP)
- 11 Area Agencies on Aging (AAAs)



### These organizations help older adults making less than \$22,000 a year apply for:

- Medicare Part D Low-Income Subsidy (LIS/Extra Help)
- Medicare Savings Programs (MSPs)



Funding also supports BenefitsCheckUp®, a free online screening and enrollment tool.

### Oklahoma Residents in Need Found Help...

Thanks to previous federal funding, in 2022-2023:

- **99,878** Medicare beneficiaries and their caregivers in Oklahoma received help with access to low-income benefits
- **36,000** people in Oklahoma used BenefitsCheckUp® to connect with benefits online

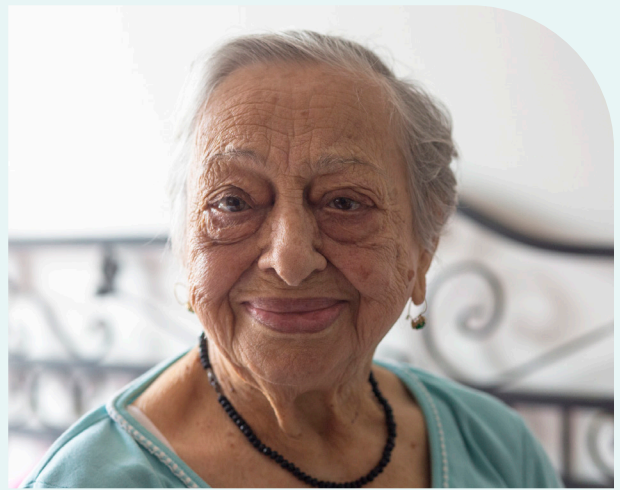
### ...But Far Too Many Are Still Missing Out

- **251,246** Medicare beneficiaries in Oklahoma are living at or below 150% of the federal poverty level and need help affording health care

## Lois's Story

Lois, 81, has chronic obstructive pulmonary disease, and her medications cost \$2,200 a month. With an income of just \$900, she couldn't afford her prescriptions, oxygen tank, rent, food, and electric bill. A benefits counselor discovered Lois qualified for the Medicare Part D Low-Income Subsidy. Within a month, Lois was paying just \$9 for a 90-day supply of medication. With the savings, Lois could pay her daily expenses and even afford new eyeglasses.
