Low-Income Illinois Residents Connected to Benefits in 2022-2023

Thanks to federal funding that supports efforts to find and enroll low-income people on Medicare into benefits they are eligible for, 390,076 low-income older and disabled Illinois Residents received assistance that can help them to afford their prescription drugs and doctor visits.

This federal funding supports Illinois's :

- State Health Insurance Assistance Program (SHIP)
- 13 Area Agencies on Aging (AAAs)
- 8 Benefits Enrollment Centers (BECs)



These organizations help older adults making less than \$22,000 a year apply for:

- Medicare Part D Low-Income Subsidy (LIS/Extra Help)
- Medicare Savings Programs (MSPs)



Funding also supports BenefitsCheckUp®, a free online screening and enrollment tool.

Illinois Residents in Need Found Help...

Thanks to previous federal funding, in 2022-2023:

- 235,376 Medicare beneficiaries and their caregivers in Illinois received help with access to low-income benefits
- 154,700 Illinois Residents used BenefitsCheckUp® to connect with benefits online

... But Far Too Many Are Still Missing Out

- 689,571 Medicare beneficiaries in Illinois are living at or below 150% of the federal poverty level and need help affording health care

John's Story

|| John had been receiving Social Security Disability for 2 years and recently started receiving Medicare. Medicare premiums were being deducted from his check, even though he qualified for a Medicare Savings Program. A benefits specialist helped him apply, and they soon discovered that the initial premium deductions were made in error. John received a refund, and he now has ongoing support to help him afford his daily expenses.
