#### **Defending Students from Anti-LGBTQ+ Hate**

Lance Preston of the Rainbow Youth Project based in Indianapolis will discuss the ways hurtful political rhetoric has affected LGBTQ+ students. The Rainbow Youth Project is suing the Chino Valley Unified School District over its policy to inform parents if a child is transgender or gender-nonconforming. This is interpreted as a forced outing policy.

#### The 1871 Chinese Massacre and its Legacy

Executive Director Michael Truong and Board Chair Dr. Gay Yuen will describe plans to create a memorial to honor the victims of the 1871 Chinese Massacre. In a largely unknown chapter of Los Angeles history, a mob of more than 500 men descended on the original site of Chinatown, lynching 19 men and boys, about 10 percent of the city's Chinese population. The memorial garden and art will work educate the public about this tragic chapter in L.A. history.



#### PARKING INSTRUCTIONS
