3. Presentation and Discussion on the San Gabriel Valley Council of Government's White Paper on Los Angeles Homeless Services Authority Reform. (21-4006)

Marisa Creter, Executive Director, San Gabriel Valley Council of Governments (SGVCOG) presented on SGVCOG's work on homelessness and its white paper on Los Angeles Homeless Services Authority (LAHSA) reform.

Commissioner Greuel inquired about earmarked State funding allocated to SGVCOG. Commissioner Porter inquired about proportional representation in homelessness governance based on per capita homelessness.

Ms. Creter provided that LAHSA funds service providers and not cities.

Commissioner Rodarte inquired about local support for the expansion of Measure H innovation funds and for continuation of Measure H.

Commissioner Evangelis inquired about the limitations on Measure H funding, including prohibitions on funding local law enforcement for outreach purposes. Co-Chair Dusseault commented on councils of government (COG) and contract cities providing input to the County on Measure H spending and on future funding from other sources.

Co-Chair Dusseault also commented on funding services for acute needs.

Joseph Lyons, Richard Corral, April A. Verlato, Jody Schulz, Karen Davis, Mike Miller, Melissa Varela, Ronson Chu, Diana Mahmud, and Alex Furtado addressed the BRCH. Interested person(s) also submitted written testimony.

4. Presentation and Discussion on the County of Los Angeles's Report on Los Angeles Homeless Services Authority's Governance. (21-4007)

Ms. Arlene Barrera, Auditor-Controller, and Ms. Cheri Todoroff, Interim Director, Chief Executive Office Homeless Initiative (CEO-HI) presented on a report to the Board of Supervisors on LAHSA's structure and function.

Commissioner Shevlin inquired about regular reporting requirements for LAHSA. Ms. Barrera provided that Auditor-Controller supervises an annual audit of LAHSA. Co-Chair Dusseault provided that LAHSA undergoes regular internal auditing and auditing by the State and other funders. Commissioner Greuel inquired about audits of County departments that receive Measure H funding. Co-Chair Horvath inquired about streamlining contract administration and payout to awardees and LAHSA's advance payment process. Ms. Barrera provided that auditors identified time delays for payouts because sub-sub-contractors' claims were held up by sub-contractors of LAHSA. Commissioner Shevlin inquired about the potential or need for a management audit. Commissioner Porter commented that the County ensures advances, but other funding sources do not advance award payouts or advance under restrictions.

Commissioner Shevlin commented on concerns about city programs limited by one-time funding from the innovation fund and on the need for legislative change.

Commissioner Rodarte inquired about the use of Measure H funding for the construction of interim housing. Commissioner Evangelis inquired about the level of proscription of Measure H funds provided to LAHSA.
