I. CALL TO ORDER / INTRODUCTONS

II. GENERAL PUBLIC COMMENT

There were no public comments.

III. APPROVAL OF THE MINUTES

Chair Mitchell, County Supervisor, Second District

There were no requests for revisions to the minutes of the September 14, 2022 meeting. Los Angeles County Public Defender Ricardo Garcia made a motion to approve the minutes. This was seconded by Los Angeles County Alternate Public Defender Erika Anzoategui.

ACTION: The motion to approve the minutes of the September 14, 2022 meeting was approved without objection.

IV. L.A. vs. HATE

Terri Villa-McDowell, Program Coordinator, L.A. vs. Hate, County Commission on Human Relations

Terri Villa-McDowell, Program Coordinator of L.A. vs. Hate within the County Commission on Human Relations, provided a status update on L.A. vs. Hate and collaboration with local law enforcement partners.

As background, a presentation on L.A. vs. Hate was made at the CCJCC meeting held on April 13, 2022. At that meeting, Chair Mitchell requested that the County Commission on Human Relations (HRC) report back later in the year on collaboration efforts with local law enforcement partners.

Ms. Villa-McDowell stated that HRC has been working with CCJCC to build out the action steps for law enforcement personnel to support all county residents who experience or witness acts of hate.

Regular meetings have been held with a working group consisting of law enforcement personnel, including hate crime coordinators, representing the Los Angeles Police Department (LAPD), Los Angeles County Sheriff's Department (LASD), and regional police departments.

The following topline goals have been agreed upon:

- Encouraging the reporting of hate incidents and/or the referral of victims to 211, where resources are available.
- Support first responders and agency relations by providing community-informed best practices on victim treatment, referral processes, and available resources.

The following is currently in process:

- Partnering with law enforcement to educate personnel about the L.A. vs. Hate program and the services that it provides to victims of hate:
 - In collaboration with CCJCC, HRC is making presentations to regional Police Chiefs Associations to ensure that they are aware of the program, and to get their feedback on additional partnership opportunities.
 - A presentation was made to the Southeast Police Chiefs Association on October 13th, which opened the door to a train-the-trainer model.
 - Additional presentations are being scheduled with the South Bay Police Chiefs Association and the San Gabriel Valley Police Chiefs Association.
- HRC is working on developing a video that walks officers through the program.
 This could be made available during roll call, on POST, or through other department/agency training mechanisms.
 - The script of this video is currently in review with the working group.
- Materials for law enforcement personnel have been developed to distribute to the public/victims of hate about the L.A. vs. Hate program.
 - HRC is working with individual agencies to add language about L.A. vs. Hate to existing brochures, websites, and other materials that are supplied to victims of hate.
 - HRC has also developed a brochure and a business card, both of which can be printed and provided to departments/agencies at their request.

Next steps include the following:

- CCJCC will be helping to coordinate dissemination of program materials (card, brochure, and language) to agencies around the County.
- Finalize the video and partner with agencies to get it in front of rank and file officers.
- Meet with remaining regional Police Chiefs Associations.
- Continue exploring data sharing and policy change conversations with a view toward long-term solutions.

Supervisor Mitchell inquired about the use of interactive bystander training. Ms. Villa-McDowell confirmed that HRC has been working with community groups on interactive bystander training, and that efforts will be made to present this in different languages. Supervisor Mitchell emphasized the importance of being culturally competent in these efforts.

V. INFORMATION SYSTEMS ADVISORY BOARD (ISAB)

Thomas Kooy, Director, ISAB

Thomas Kooy, Executive Director of the Information System Advisory Board (ISAB), provided a status update on ISAB's current projects and priorities to facilitate data sharing and systems integration within the criminal justice system. ISAB is a standing subcommittee of CCJCC.

As background, ISAB was established in 1982 and that the Charter was updated in 1992 under the auspices of the CCJCC. The ISAB Charter was last updated in September 2021.

Mr. Kooy provided an overview of activity with both ISAB Enterprise Systems and ISAB Enterprise Management.

Each of the ISAB Enterprise Systems were discussed, which included a review of maintenance and enhancements as well as future system/planning needs. The following five ISAB Enterprise Systems were included in this presentation:

- Consolidated Criminal History Reporting System (CCHRS) Criminal History
- Proactive Information Exchange (PIX) Criminal Justice Information Exchange

- DNA Order Tracking System (DOTS) DNA Order Tracking
- Justice Automated Information Management System (JAIMS) Justice Metrics and statistics.
- Justice Video Conference System (JVCSS) Justice Video Conferencing

Mr. Kooy next discussed ongoing activity and aspects of ISAB Enterprise Management. The following items were reviewed:

- Project Portfolio Management (PPM)
- Enterprise Data Governance and Information Management (DG/EIM)
- Enterprise Digital Evidence Management System (eDEMS)
- Justice Care and Opportunities Department (JCOD)

VI. VICTIM SERVICES

Tanishia Wright, Director, Bureau of Victim Services, District Attorney's Office

Sharon Woo, Chief Deputy in the District Attorney's Office, introduced Tanishia Wright, Director of the Bureau of Victim Services (BVS) in the District Attorney's Office. Ms. Wright provided an overview of services and support available through BVS.

BVS has locations throughout the county and the following three divisions to assist victims:

1. Director Services:

Advocates provide assistance to crime victims in courthouses and law enforcement stations throughout Los Angeles County

2. Claims Verification Unit:

Victim Compensation Assistance

3. Restitution Enhancement Program:

Victim Restitution Assistance

Ms. Wright noted that trauma informed victim services are offered. This includes approaches delivered with an understanding of the vulnerabilities and experiences of trauma survivors, including the prevalence and physical, social, and emotional impact of trauma.

Mandatory victim services that BVS offers under Penal Code Section 13835.5 include:

- Crisis Intervention
- Emergency Assistance
- Resource & Referral Counseling
- Victim Compensation Assistance
- Return of Property
- Orientation to the Criminal Justice System
- Court Escort/Support
- Case Status/Disposition Information
- Restitution Assistance

Optional victim services that BVS offers under Penal Code Section 13835.5 include:

- Creditor/Employer Intervention
- Restitution Information & Referral
- Notification Court Calendar Changes
- Funeral Arrangement Assistance
- Temporary Restraining Order Information
- Witness Protection Assistance/Relocation

Ms. Wright also discussed the following:

Holiday Giving Drive

 In 1984, the Los Angeles County District Attorney's Office established an annual Holiday Giving Drive to bring gifts and cheer to victims, especially young children, who were seriously injured and traumatized by crime or lost a parent to homicide. The funds to purchase gifts are raised from District Attorney personnel as well as outside agencies.

BVS K-9 Unit

 Facility dogs help child victims and other vulnerable victims of crime during interviews, preparation for testimony, and testimony at preliminary hearings and trials.

Supervisor Mitchell inquired about the time it takes for a victim to receive a payment and who is eligible. Ms. Wright stated that BVS is seeking to decrease the turnaround time to provide payments to individuals and to do so equitably. They are also exploring ways to address issues of concern regarding eligibility.
