1. Welcome and Introductions

Greg Wilson, Co-Chair, welcomed attendees and led introductions.

2. Co-Chairs' Report

- a. Highlights from July 19 Planning, Priorities and Allocations (PP&A) Committee Meeting
 - Miguel Martinez, Co-Chair, provided the report. AJ King, Comprehensive HIV Plan (CHP) Consultant, held a data presentation at the July 19th PP&A meeting. The presentation slides can be found in the July PP&A meeting packet.
 - Kevin Donnelly informed the PPW that PP&A will be meeting on August 16th at 1pm. This will be an extended meeting to accommodate time to discuss changes in funding for the HIV care system in LA County as well as the CHP.
- b. Knowledge, Attitudes, and Beliefs (KAB) survey to assess Commissioner's understanding and capacity to engage effectively in integrated planning
 - Dr. William King, Co-Chair, presented the knowledge, attitudes, and beliefs (KAB) survey to assess the Commissioner's understanding and capacity to engage effectively in integrated planning to the PPW. The survey can be found in the meeting packet. M. Martinez reiterated that the purpose of the survey is to help inform the PPW on ways to integrate prevention into local planning efforts.
 - Dr. King provided an explanation of the Centers for Disease Control and Prevention (CDC)'s status-neutral approach to HIV prevention and care. The document can be found in the meeting packet.

• Paulina Zamudio noted that the survey will help determine where further training is needed regarding HIV prevention.

c. **New meeting time starting August 24 | 4:00 PM to 5:30 PM**

• Starting August 24, 2022, the PPW will be meeting from 4:00 PM to 5:30 PM. The purpose of this change is to allow for increased attendance.

3. Discussion: Select Key Areas of Focus or Activities for the Remainder of 2022

a. Breakout Groups | What is missing from the list of potential activities?

- The PPW co-chairs each led a breakout room to discuss what should be added to the PPW workplan. Key points from the discussion were as follows:
 - The group discussed the possibility of a marketing campaign to support awareness of resources about HIV-related services.
 - A conversation about how to truly target populations to create standards and focus was held.
 - Information on injectable PrEP for HIV program navigators is needed.
 - ➤ Efforts to target monolingual populations regarding prevention information are needed.
 - ➤ The group explored ways to expand conversations around harm reduction beyond syringe exchange.
 - The Division of HIV and STD Programs (DHSP) is in the process of assisting smaller organizations to apply for requests for proposals (RFPs).
 - > The group discussed linking mental health with biomedical care.
 - ➤ Holding a minimum number of prevention-focused presentations can help increase prevention awareness within the Commission on HIV (COH).
 - ➤ The group discussed requesting data on housing and the impact of being unhoused on accessing prevention resources.

b. Group Work | Rank/Prioritize Key Activities

 The PPW will review the workplan and rank priorities to allow for discussion at their next meeting.

4. Comprehensive HIV Plan 2022-2026 Updates

- AJ King, Comprehensive HIV Plan (CHP) Consultant has been conducting community listening sessions for each of the seven priority populations, including Latinx MSM, Black/African American MSM, women of color, transgender persons, people who inject drugs, people under 30 years of age, and people over 50 years of age.
- Kevin Donnelly inquired about how syndemics are being included in the CHP. A. King stated that other STDs will be included in the CHP, particularly syphilis and its relationship to HIV.

5. Next Steps and Agenda Development for Next Meeting

a. Long-acting injectables for prevention presentation on August 24 by Dr. William King ***Meeting time 4-5:30PM**

 Dr. King will hold a presentation on long-acting injectables for prevention at the August 24th PPW meeting. Dr. King asked the group if there are any specific questions they would like to address for this presention. A. King identified questions regarding the painfulness of the injectables and how to address missed doses. P. Zamudio requested information on how injectables can be used as both HIV prevention and treatment. M. Martinez requested information on resources on how to integrate injectables into clinical spaces.

6. Public Comment + Announcements

- G. Wilson announced that August is Black Gay Men's Wellness Month. In the Meantime Men will be offering different opportunities for panel discussions that focus on the wellnes needs of Black gay men.
- Paul Chavez stated a study for the MenB vaccination series for meningitis showed a 40% decrease in gonorrhea acquisition. P. Chavez requested if this can be included in Dr. King's August 24th presentation.
- G. Wilson requested if attendees can share any information on the monkeypox vaccine, if available.

The meeting was adjourned by G. Wilson.

2	Conduct a thorough evaluation of existing directives to infuse prevention focus. We should include quantitative data so that as we infuse new prevention focus, we're moving towards directives that are empirically-based and against which we can measure progress	
2	Request data regarding HIV/STD testing, diagnosing, and PrEP for aging population. I'm not prioritizing this separately, but as part of creating dashboards, we should break out data for the highest risk populations, including, if appropriate, ageing individuals.	12/30/22
2	Advocate for a minimum number of prevention-focused presentations each year. These topics should be dictated in part by the results of the KAB survey and include dashboard data to provide a quantitative foundation for the presentations.
