Dr. Schmidt called the meeting to order at 9:45 a.m. He announced that the special meeting had been called to review the position paper prepared by the Community Relations Task Force on Proposition 8 and SB 1, the Behr Bill.

Task Force on Community Relations - Carolyn Ellner, Chairperson, reported that the task force had presented its statement on the Jarvis-Gann Initiative two weeks ago. After its adoption, the task force studied the Behr Bill and Proposition 8, read related material and interviewed a number of people. The task force concluded that the Behr Bill is a strong and financially sound bill which will bring relief to the homeowner, renter, and senior citizen in a responsible, productive way. A statement was drafted and mailed to the members recommending that the commission strongly support Proposition 8 and the Behr Bill.

Following a discussion period, Dr. Ellner moved that the Economy and Efficiency Commission recommend that voters vote YES on Proposition 8 and the Behr Bill. The motion was seconded by John Byork and passed unanimously.

Warren Schmidt explained that, since this was a special meeting, many of the members had previous commitments and could not attend. However, the record should show that Jerry Epstein, Richard Gunther, Larry Neri and Larkin Teasley had reported that they were in support of the statement and recommendation. Leo Majich, who previously supported the Jarvis-Gann Initiative, has changed his position and is now supporting Proposition 8.

Executive Secretary Report - Burke Roche reported that the commission was receiving a number of requests for speaking engagements and interviews. The Committee for No on 13 is coordinating the replies to editorials. On KNX there have been five editorials, so there have been five rebuttals, and Warren Schmidt made one of them.

On the Jarvis-Gann Initiative, Warren Schmidt and he gave a presentation to the Committee on the Affairs of the Aging, and May 31 he is scheduled to participate on a panel discussion at Glendora Town Hall.

On the secession issue, John Campbell and he made a presentation to the El Segundo Women's Club, and Catie Burke is scheduled to participate in a panel discussion on Channel 28. She will also tape an interview for radio station KBIG. Mary Jane Kidd will do a half-hour interview on radio KMAZ.

Chairperson Report - Dr. Schmidt reported that Burke Roche and he had presented the report IMPACT ON NEW COUNTY FORMATION to the Board of Supervisors on Tuesday. On motion of Supervisor Hayes, seconded by Supervisor Ward and unanimously carried, the following Board Order was passed.

"The commission was directed to circulate the report to the news media, libraries, educational institutions, and to community groups and was given authorization to print the necessary 2,000 copies. The commission was thanked and commended for its report."

Dr. Schmidt introduced three visitors - Pat Yeoman, Chairperson of the Grand Jurors' Association, Edith Bogen and Herb Shane, members. He said that organization and the E & E Commission have a lot of common concerns, and there are a number of occasions when they can unite their voices.

The meeting was adjourned at 10:23 a.m.
