#### II. PRESENTATIONS AND DISCUSSIONS

3. Presentation and discussion by The Whole Child: Constanza Pachon, Chief Executive Officer. (21-4308)

This item was tabled to be presented after Agenda Item No. 4

Ms. Constanza Pachon presented on The Whole Child, its services, and its experiences contracting with LAHSA. Ms. Pachon provided that LAHSA has competing priorities. She commented on wanting greater assistance from LAHSA, excessive auditing of contractors, and the disconnect between LAHSA leadership and middle managers.

Commissioner Rodarte inquired about whether LAHSA has solicited and implemented input from contractors. Co-Chair Horvath inquired about who requests or requires the audits.

Dr. Geneviève Clavreul addressed the BRCH.

4. Presentation and discussion on approaches to increase access to and improve the effectiveness of substance abuse services: Gary Tsai, Director, Substance Abuse Prevention and Control (SAPC), Department of Public Health. (21-4453)

Dr. Gary Tsai presented on the work of Substant Abuse Prevention and Control (SAPC) and providing substance use disorder (SUD) treatment to people experiencing homelessness.

Commissioner Horvath inquired about working with LAHSA to house people experiencing homelessness who receive SUD treatment services and about special funding for SUD treatment and housing.

Co-Chair Dusseault inquired about coordination of state funding allocated for housing and SUD treatment. Commissioner Evangelis inquired about SAPC participation in outreach.

Ms. Reba Stevens addressed the BRCH.

5. Presentation and discussion by Bridge to Home: Mike Foley, Executive Director. (21-4454)

Mr. Mike Foley presented on the significant growth of homeless services and LAHSA with recent programs like Project Roomkey. He commented on LAHSA staff turnover and having worked with multiple project managers on a single contract. He commented on contractors having to respond to LAHSA audits and requests for documents. Mr. Foley recommended that LAHSA partition into smaller, more focused entities, e.g., a distinct entity for LAHSA outreach services.

Commissioner Sedano inquired about LAHSA's outreach services and those provided by community-based organizations. Commissioner Rodarte inquired about outcome metrics and goals for service providers.

6. Presentation and discussion by The People Concern: John Maceri, Chief Executive Officer. (21-4457)

Mr. John Maceri presented on the need for a central, independent authority and the absence of a comprehensive, holistic system; resource inequality across service planning areas; and the need for flexible, outcomes-based contracts with appropriate funding for service providers, exemplified by the County's Housing for Health Program.

7. Presentation and discussion on approaches to increase access to and improve effectiveness of mental health services: Jonathan E. Sherin, Director, Department of Mental Health. (21-4455)

Dr. Jonathan Sherin presented a high-level perspective, calling for a more aggressive approach to handle the crisis as a public health and public safety emergency. He recommended exploring triage communities as an emergency measure. Dr. Sherin also commented on the absence of a central authority in the geographic county and in the County of Los Angeles, and that the County should be a central, organizing authority. He commented that the continuum of care should be a conduit for federal assistance and not service provision.

Commissioner Wendy Greuel joined the meeting at 10:26 a.m.

Co-Chair Dusseault inquired about the responsibility to monitor the gap between existing resources and needs and coordinating responses with appropriate resources. Commissioner Rodarte inquired about reducing reluctance to accept housing. Commissioner Greuel inquired about prevention and developing a countywide response.

Ms. Reba Stevens addressed the BRCH.
