#### 1. Welcome and Introductions

Xelestiál Moreno-Luz, Co-Chair, welcomed attendees and led introductions.

#### 2. Co-Chairs Report

a. Last Meeting Recap (October 24, 2023) Meeting was cancelled.

#### b. TGI Health Summit Recap

X. Moreno-Luz shared highlights from the TGI Health Summit. The event took place on November 2, 2023 at The Village at Ed Gould Plaza of the Los Angeles LGBT Center. The event was organized by staff from REACH LA, the USC Department of Population and Public Health Sciences, the Trans\* Lounge program at the LA LGBT Center, and the Commission on HIV. There event was attended by over 100 people. Coordinator staff and partner agencies noted they received good feedback about the event from participants. X. Moreno-Luz added that planning efforts for 2024 will focus on increasing attendance, expanding programming options, and collect feedback from participants via a post-event evaluation. Devlin Diaz and Miro Dali both shared that they enjoyed their experience at the event and recommended to consider adding more time between workshop sessions to allow attendees more opportunities to visit and engage with agencies doing outreach in the courtyard area. Lizette recommended to conduct a brief training with staff/volunteers assigned to the registration table to help answer questions and mitigate any troubleshooting issues that may arise on the day of the event.

#### c. Co-Chair Nominations

Jose provided an overview of the co-chair role and responsibilities as well as the nomination process. D. Diaz nominated X. Moreno-Luz for co-chair; she accepted the nomination. Co-chair nominations for the second seat will remain open until someone is nominated and elected by the Caucus.

#### 3. Executive Director/Staff Report

#### a. Commission on HIV Annual Conference Recap

Jose shared highlights from the Commission on HIV Annual Conference. The event took place on November 9, 2023 at the Vermont Corridor and featured a variety of presentations on key topics such as: The County's response to the Intersection of HIV and Substance Use and Harm Reduction; PrEP, Long-Acting PrEP, and Doxy PEP; Housing and People living with HIV; Community Discussion on Intergenerational Perspectives on Community Building and Resilience; and Enhancing Access to Mental Health Services for PLWH. The presentation slides are available on the Commission website. A recording of the meeting is available upon request.

#### 4. **DISCUSSION**

#### a. Draft 2024 Workplan and Meeting Calendar

X. Moreno-Luz led a discussion on the draft 2024 workplan and the meeting calendar development. The Caucus decided to cancel the December 2023 meeting and reconvene on January 23, 2024. The Caucus will plan to host a Harm Reduction Summit in April 2024 to share updates for harm reduction efforts targeting the LGBT community as well any upcoming studies. The Caucus will host a panel discussion in May focused on International Day Against Homophobia, Transphobia, and Biphobia.

#### 5. Meeting Confirmation and Agenda Development for Next Meeting

The next meeting will be virtual on January 23, 2024 via WebEx. The Caucus will discuss and adopt the 2024 Caucus Workplan and Meeting Calendar.

#### 6. Public Comments and Announcements

X. Moreno-Luz shared that REACH LA is hosting a Harm Reduction survey launch event at the DTLA Arts Center on December 8, 2023 from 6pm-9pm. The survey seeks to collect information on the changing climate of substance use in LGBT+ communities.

D. Diaz shared that the Adolescent Medical Trials Network will have a study focused on measuring the impact of giving financial and law support to TGI members on new HIV infections. The study will take place in May; more information will be shared at the April Caucus meeting.

M. Dali shared that the recovery center near Vine/Hollywood offers help for patients seeking help with chem-sex. They added that the Vine street Clinic they run studies for helping people quit meth. They will share more information at the April Caucus meeting.

L. Kristianto shared that the Division on HIV and STD Programs will hold a social media campaign for World AIDS Day. The campaign will partner with Page Person—an elder trans woman, dress designer-- and Gunner Deathrage—influencer, dress designer. The campaign will feature dressing constructed out of expired condoms to promoted world AIDS day and resources such as getprotected LA and other HIV testing access, prevention, and treatment resources. The campaign will be featured in the TransinLA Instagram page and Facebook.

The meeting adjourned at 11:20am.
