- 7. Overview, Discussion, and Action on the Landscape of Homelessness by the Chief Executive Office (CEO) and the Los Angeles Homeless Services Authority (LAHSA).
 - a. D'Artangan Scorza, Ph.D., Director of Racial Equity, CEO Anti-Racism, Diversity, and Inclusion Initiative (ARDI)
 - Tiffany Duvernay-Smith, Lived Experience Advisory Group Coordinator, LAHSA
 - c. Heidi Marston, Executive Director, and Molly Rysman, Chief Programs Officer. LAHSA
 - d. Cheri Todoroff, Director, CEO Homeless Initiative (21-3563)

Ms. Duvernay-Smith provided an overview of the Lived Experience Advisory Board (LEAB) and the Homeless Youth Forum LA (HYFLA). She expressed the importance of including, and engaging with, people with lived experience. Commissioner Dusseault inquired how to get the perspective of people with lived experience on the issue of governance as distinct from operations. Ms. Duvernay-Smith encouraged the BRCH to engage with the LEAB to connect the BRCH with the larger community of people with lived experience. Commissioner Porter stated her interest in future meetings with people with lived experience to get feedback on governance. Ms. Rysman invited the commissioners to attend public meetings of the LEAB on the first Friday of every month at 10:00 a.m.

Ms. Marston and Ms. Rysman provided an overview of LAHSA and the history of federal, state, and local homelessness policies. Ms. Rysman opened the presentation with a land acknowledgement. Commissioner Greuel requested additional information about continuums of care at a future meeting. Commissioner Evangelis inquired about the difference between LAHSA's role as a system administrator versus as a funding or grant administrator. Ms. Rysman provided that Los Angeles County is unique because of the many sources of funding for homelessness services from federal, state, and local governments and private philanthropy. Commissioner Evangelis inquired about funding for related services, including mental health services. Ms. Rysman and Ms. Marston advised LAHSA maintains partnerships with County departments with distinct funding streams for their services. Commissioner Horvath inquired whether LAHSA lobbies the state and federal governments regarding the complexity of limitations on funding for homeless services. Ms. Marston provided that LAHSA does work with legislators on bill language and Ms. Rysman provided the federal government is creating new tools that may reduce funding complexities. Commissioner Porter inquired whether LAHSA could lead more on housing supply. Ms. Rysman indicated unit acquisition is becoming more important. Ms. Wickham requested the BRCH turn its attention to Dr. Scorza's presentation and then return to Ms. Marston and Ms. Rysman's presentation.

Dr. Scorza provided an overview of the importance of doing work principled on equity and justice. Dr. Scorza opened the presentation with a land acknowledgement. Commissioner Porter inquired if CEO ARDI was working with LAHSA on equity issues. Dr. Scorza shared LAHSA has its own equity office and the ARDI is working within the County to implement the recommendations of the LAHSA Commission's Ad Hoc Committee on Black People Experiencing Homelessness. Commissioner Dusseault inquired whether County departments are working on equity at the level of specific interventions, below the abstract level. Dr. Scorza indicated the ARDI is working with County departments to meet program, project, and outcome design needs.

Ms. Marston and Ms. Rysman continued their presentation. Commissioner Dusseault requested additional information on systems gaps and requested confirmation of the cost analysis provided in the presentation. Commissioner Evangelis inquired whether the costs presented included the construction and operation of temporary and permanent shelters. Ms. Marston indicated the construction cost is presented separately from the ongoing operations cost.

Ms. Todoroff provided an overview of the CEO Homeless Initiative, Measure H funding, and ongoing strategic planning. Commissioner Greuel requested more information on how much Measure H funding is going to each County department. Ms. Todoroff indicated CEO Homeless Initiative would prepare that information and described how less-proscribed funding was used to fill the gaps between proscribed-use funding. Commissioner Dusseault inquired how the work of the BRCH would coordinate with Measure H strategic planning. Commissioner Dusseault requested information on how much Measure H funding was going to each city. Ms. Todoroff indicated that CEO Homeless Initiative would prepare that information. Commissioner Horvath stated his interest in more granular information on Measure H funding, including outcome metrics to understand whether the funded programs are working.
