# III. APPROVAL OF November 5, 2009 and December 3, 2009 MINUTES

### IV. CHAIRMAN'S REPORT

Chairman Barcelona thanked Commissioner Reznik, fellow Commissioner and President of the Jewish World Watch, for her speaking engagement on the plight of eastern Congo residents during the Antelope Valley Hispanic Chamber Commerce luncheon. Chairman Barcelona stated that Commissioner Reznik did a phenomenal job and distributed a full page article on her presentation.

Chairman Barcelona introduced new Commissioner Arne Kalm. He stated that Commissioner Kalm was appointed by Supervisor Michael Antonovich and proceeded to read Commissioner Kalm's biography.

Commissioner Kalm thanked Chairman Barcelona for his warm welcome and stated that he is honored to serve as a Commissioner with the E&E Commission. He stated that he looks forward to spending time and working with fellow Commissioners over the ensuing months. Commissioner Kalm stated that there are only three seminal things about him: one was alluded to in the biography that Chairman Barcelona read; another is that he is an immigrant from Eastern Europe. He also stated that English is his third language and during his years of growing up his heart was with the captive nations of Eastern Europe; and he has an engineering background and that all of his life he has enjoyed the application of technology and innovation.

Commissioner Kalm stated that he has been a businessman all of his life, and that he recently retired and his interest is in financial analysis, corporate planning, and some advisory work. He stated that he has limited experience in public policy other than the fact that he served a couple of years in Sacramento as a member of the State Employment Training Panel, which is a seven person board. Commissioner Kalm stated that he will enjoy working with all the Commissioners and thanked the Commission again for the warm welcome.

#### 2. Civil Service Reform-- Commissioner Otto, Commissioner Cox



Commissioner Otto reported that the Task Force has been very active meeting with a lot of key players. She stated that the Task Force is using the meetings as an exploratory opportunity to find out the opinions from senior management within the County about what works and what doesn't with the Civil Service System.

Commissioner Otto also noted that the Task Force's effort has been directed towards the development of the scope of work for the project. She stated that the Task Force has learned from all the meetings that the Civil Service System is a critical issue throughout the County. She informed the Commission that the Task Force is having a meeting immediately following the monthly meeting to further develop the scope of work from all the data gathered so far.

Commissioner Otto stated that sometime in late January the Task Force will comeback with a more defined scope of work that they believe will be beneficial to the County, make a difference in addressing some of the civil service issues, and help the Commission move forward with this particular study.
