Ms. Mary Wickham, Executive Director, Blue-Ribbon Commission on Homelessness (BRCH), provided that, pursuant to action by the Board of Supervisors, the BRCH would continue meeting virtually due to the ongoing state of emergency due to Covid-19.

Ms. Rysman opened the presentation with a land acknowledgement.

Commissioner Shevlin inquired about local preference considerations for housing placements. Co-Chair Horvath inquired about data systems, the process of identifying behavioral health service needs, and outcomes for mental health services. Commissioner Greuel inquired about the decisionmaking process for Measure H funding allocation. Commissioner Porter inquired about ensuring geographic coverage for services. Co-Chair Dusseault inquired about the responsibility for monitoring system

- 3. Presentation and discussion by the Faith Collaborative to End Homelessness: Co-Chair Steven Yu, Co-Chair Allyson Crosby, and Member Amara Ononiwu. (21-4169)

Mr. Steven Yu, Ms. Amara Ononiwu, and Mr. Dan Davidson presented on faith-based organizations (FBO) and homeless services and provided recommendations.

Commissioner Evangelis inquired about LAHSA coordination with FBOs. Ms. Ononiwu provided that FBOs face administrative hurdles to becoming funded service providers. Mr. Davidson provided that FBOs participating as decision-makers on day-to-day operations of the Pasadena Continuum of Care has been beneficial.

Mr. Adam Raymond and Mr. Moises Lopez presented on the City of Glendora's experience with homelessness and funding homeless services.

Commissioner Greuel commented on the difficulty in calculating Measure H returns to cities because they may not include Measure H funding of County services for a city's homeless population. Commissioner Rodarte inquired about communication between the County or LAHSA and cities and whether cities understood Measure H necessarily to fund services as opposed to housing construction.

5. Presentation and discussion by person with lived experience, Reba Stevens. (21-4213)

Ms. Reba Stevens presented on her lived experience and on equity issues for Black people experiencing homelessness and school-aged youth experiencing homelessness and the Regional Homelessness Advisory Council (RHAC).

7. Presentation and discussion by The Shower of Hope: Mel Tillekeratne, Executive Director and Co-Founder. (21-4167)

Mr. Mel Tillekeratne presented recommendations and concerns about current homeless services, including an influx of non-local people experiencing homelessness into Los Angeles County, geographic disparities in service provision, alternatives to housing first models, and needs for additional mental health and substance use disorder services. Mr. Tillekeratne also commented on training and wages for outreach workers and the request for proposal (RFP) process.

8. Presentation and discussion by Union Station Homeless Services: Anne Miskey, Chief Executive Officer; and Shawn Morrissey, Senior Director of Advocacy and Community Engagement. (21-4215)

Ms. Miskey provided that related systems need to be held accountable for inflow into homelessness, on the administrative burdens on homeless services providers, and on the lack of funding for administration and staff. Ms. Miskey also provided concern about cities interrupting a regional response based on best practices and that cities could best help by building housing supply. Mr. Morrissey provided the continued importance of a true housing first model and concerns about enforcement and lack of an adequate treatment system.

Co-Chair Dusseault inquired about opening up access to HMIS to cities from the perspective of service providers.
