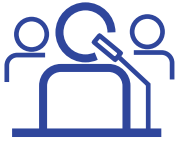

9. Exploring the Feasibility of Bringing Information and Referral Contracted Services In-House

10. Advancing Countywide Efforts to Address Environmental Hazards - Establishing the Office of Environmental Justice and Climate Health

Recommendation as submitted by Supervisors Hahn and Solis: Instruct the Director of Public Health to adopt the roadmap in the October 17, 2022 report entitled, "Evolving and Advancing the Board Directed Priority: Environmental Justice and Climate Health," and create the Office of Environmental Justice and Climate Health; work in collaboration with relevant County Departments including, but not limited to, the Acting Chief Sustainability Officer, the Interim Fire Chief through the Health HazMat Division, the Directors of Regional Planning and Public Works, community partners and coordinating agencies, to complete the following:

A Strategic Plan that finalizes the priority policy areas of focus, in consultation with community stakeholders and the Community Prevention and Population Health Task Force; and

Within 30 days, appoint an Interim Director, utilizing an existing position, to oversee the Strategic Planning process;

Instruct the Director of Public Health, in collaboration with the Chief Executive Officer, through the Budget and Classification and Compensation Division, to submit a budget request that includes long-term staffing and funding recommendations for any additional resources that the Office of Environmental Justice and Climate Health may need beyond the existing staff, including a recommendation for the appropriate allocation for the permanent and Interim Director role; and instruct the Director of Public Health, with input from the Chief Executive Officer, to report back to the Board with quarterly progress reports until the Strategic Plan is published, on the implementation of the aforementioned, including Strategic Plan status updates and vacancy rates for existing positions. 11. Crisis Residential Treatment Program Providers for Rancho Los Amigos and Olive View Restorative Care Villages

13. Transfer Ownership of Homekey Commerce Acquired through Homekey Round 1

Recommendation as submitted by Supervisor Hahn: Approve the proposed transfer of Homekey Commerce, located at 7701 East Slauson Avenue, and execution of a gratis transfer agreement with Hope on Slauson, LP (Project); find that Homekey Commerce is "Exempt Surplus Land" pursuant to Government Code Section 54221(f)(1)(A), as it meets the requirements of Government Code Section 25539.4, which authorizes the transfer of County property for affordable housing use, as more than 80% of the property will be used for housing, and 79 of the 81 total units will be restricted by recorded covenant for a period of 55 years to households earning no more than 30% of Area Median Income, therefore, the transfer of Homekey Commerce is not subject to the California Surplus Land Act, Government Code Section 54200, et seq., processes for disposition of County surplus property; find that the Project is exempt from the California Environmental Quality Act; and take the following related actions:

Authorize the Chief Executive Officer to negotiate and execute a gratis transfer agreement with Hope on Slauson, LP, transferring ownership of Homekey Commerce, subject to restrictive covenants requiring that the property be used for permanent supportive housing consistent with the requirements of the Homekey Program and Government Code Section 25539.4, for a term of 55 years, and Hope on Slauson, LP being added to the Homekey 1 Standard Agreement for Homekey Commerce;

Direct the Chief Executive Officer to take any action, and approve and execute any ancillary documents that are necessary to effectuate the closing of the transaction contemplated by the terms of the transfer agreement, and pay any associated transaction costs; and

Adopt a resolution, authorizing the Chief Executive Officer or Board assignees, to amend the Homekey Standard Agreement for Homekey Commerce to add, as required under the direction of the California Department of Housing and Community Development (HCD), Hope on Slauson, LP, FFAH V Hope on Slauson, LLC, Foundation for Affordable Housing V, INC., AEDIS Slauson AGP, LLC, AEDIS Real Estate Group, Inc., and LSA Capital, Inc., to the Standard Agreement, and take any further actions required by HCD for participation in the Homekey Program. 15. Creating Strategies to Preserve Affordable Housing - Expanding the Community Land Trust Partnership Program and Rehabilitating Properties for Affordable Housing

Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Chief Executive Officer, in coordination with the Executive Directors of the Los Angeles County Development Authority and the Anti-Racism, Diversity and Inclusion Initiative, Chief Executive Office, to evaluate the Community Land Trust Partnership Program (Program) based on metrics to include demographics of stabilized households, including average adjusted median incomes, development costs, acquisition and rehabilitation timeline, and longevity of affordability compared to other County housing strategies, resident engagement in rehabilitation planning and education regarding building finances, introduction of community and tenant ownership concepts, integration with community-driven stabilization strategies in areas at high risk of displacement, and any additional measure identified by the Anti-Racism, Diversity and Inclusion Initiative, and in addition to recommendations generated through the evaluations based on these metrics, the report back to the Board should include geographic allocation of funding, the vetting process for potential acquisitions, the process of completing any required improvements, immediate and projected long-term outcomes of the Program for households/residents, lessons learned for future programs, analysis of funding sources and partnerships, including the Los Angeles County Affordable Housing Solutions Agency, for continuing to scale the Program, and recommendations regarding supportive policies including, but not limited to, the Tenants Opportunity to Purchase Act and the County Land Bank; and take the following related actions: (Relates to Agenda No. 1-D)

Direct the Chief Executive Officer and the Executive Director of the Los Angeles County Development Authority, in consultation with the Interim County Counsel and the Treasurer and Tax Collector, to implement the Program and to include both non-Chapter 8 and Chapter 8 properties, and follow the process and considerations resulting from the Board's direction, including creating Program guidelines, advertising the availability of the funding source, accepting applications from organizations seeking prequalification to receive funding, identifying nonprofit, community-based organizations which steward land in perpetuity to maintain community-benefiting uses and long-term affordability, and which through a shared equity model, preserve affordable housing and expand homeownership opportunities by providing lower-income households with the opportunity to manage and own their housing, as described in the Chief Executive Officer's July 26, 2022 report entitled, "Progress Report: Developing a Pilot Community Land Trust Partnership Program," and convene prequalified participating entities as required for efficient program coordination and implementation;

Find, pursuant to Government Code Section 26227, that the implementation of the Program and funding from the Affordable Housing Programs Budget in an amount not to exceed \$14,000,000 for the purchase of the non-Chapter 8 and Chapter 8 properties by prequalified participating entities to access funding for the acquisition and/or rehabilitation, with the intention of at least one property in each Supervisorial District, to maintain as long-term affordable housing for no less than a 99-year term, is necessary to meet the social needs and public purposes of preserving affordable housing, which benefits the County;

Direct the Chief Executive Officer to allocate from the Affordable Housing Programs Budget an amount not to exceed \$14,000,000 of one-time funding, from the Fiscal Year (FY) 2022-23 Affordable Housing Programs Budget unit, for the Program, for prequalified participating entities to access funding for the acquisition and/or rehabilitation with the intention of at least one property in each Supervisorial District, and to maintain as long-term affordable housing for not less than a 99-year term;

Authorize the Executive Director of the Los Angeles County Development Authority to act as the agent of the County for the implementation and monitoring of the Program;

Direct the Chief Executive Officer, in conjunction with the Executive Director of the Los Angeles County Development Authority, to consult with the Anti-Racism, Diversity and Inclusion Initiative (ARDI) to ensure that racial equity metrics, including addressing specific needs of Black communities to ensure full benefit from this Program, are incorporated into the Program guidelines, and utilized within the evaluation framework, and assess ARDI's resource needs; and

Direct the Chief Executive Officer to execute a funding agreement, or amendments to existing funding agreements with the Los Angeles County Development Authority (LACDA), for up to \$14,000,000 from the Affordable Housing Budget unit for the Program, which includes any administrative costs for LACDA, for administration of the Program, which includes authority to LACDA to deposit into an escrow account for the prequalified participating entities to acquire property. 16. Launching the Land Bank Pilot Program

Recommendation as submitted by Supervisors Solis and Kuehl: Find, pursuant to Government Code Section 26227, that the implementation of the Land Bank Pilot Program (Pilot) is necessary to meet the social needs of the population of the County and achieve the public purposes of increasing the stock of affordable housing which benefits County residents; direct the Chief Executive Officer to allocate from the Affordable Housing Programs Budget, an amount not to exceed \$10,000,000, of one time funding, from the Fiscal Year 2022-23 Affordable Housing Programs Budget unit, for the Pilot to fund the acquisition, holding, and development of land into affordable housing, and execute agreements and any necessary amendments and/or amend existing agreements with consultants and nonprofit organizations as needed for the administration of the Pilot; and direct the Chief Executive Officer to take the following related actions:

Designate dedicated County or consultant staff to lead all efforts related to implementation of the Pilot and the development of a framework for a permanent Land Bank Program, inclusive of a robust outreach process with cities, nonprofit organizations, community-based organizations, and stakeholders, and the framework should consider a model in which a new nonprofit entity is established to lead Land Bank activities;

Identify and purchase at least one property in each Supervisorial District utilizing the following guidelines under the Pilot:

Acquisitions shall be located within the Highest, High, or Moderate Need Category as identified by the Anti-Racism Diversity and Inclusion Initiative Equity Explorer Map;

Staff may use one or more of the following criteria to identify potential acquisitions, in collaboration with each Supervisorial Office: site is located within two miles of the Los Angeles River; within two miles of major infrastructure improvements; and between 0.5 and 2.0 acres and could support 30 units of housing or more;

Concurrence from the respective Supervisorial Office is required prior to moving forward with any acquisition; and

Acquired properties shall be developed primarily with affordable housing as feasible, with potential acquisitions to be reviewed with staff from other Departments, as well as the Los Angeles County Development Authority to ensure the site is appropriate for affordable housing;

Develop a step-by-step guide for projects undertaken through the Pilot, with a guide to include coordination and outreach with cities and stakeholders, preparation of an operations and maintenance strategy and budget for each site for each acquisition, and preparation of site-specific affordable housing development models in partnership with the respective Supervisorial Office; and

Report back to the Board in writing in 90 days and submit progress reports every 90 days thereafter until completion of the Pilot. (22-4205)

17. Mom-and-Pop Landlord Assistance Program

Clarify that a landlord is not criminally or civilly liable for pursuing and filing an unlawful detainer action, if the landlord has a reasonable belief that a tenant's self-certification is fraudulent, or that the tenant cannot carry the burden to prove the affirmative defense provided by the resolution;

Clarify that a tenant has the burden to prove the basis of their affirmative defense, including the merit of any self-certification of a financial impact related to COVID-19 made pursuant to this resolution; and

Clarify that the tenant protections in the revised resolution shall be in effect until December 31, 2022, except the no-fault protections as noted above. (22-4240)
