4. Budget Adjustment to Support Care First, Jails Last: Advancing the County's Care First Jails Last Priorities

Recommendation as submitted by Supervisor Kuehl: Approve an appropriation adjustment to transfer \$59,988,000 from the Department of Health Services (DHS)-Health Services Administration (HSA) budget unit, including funding provided to HSA via Intrafund Transfer from the Office of Diversion & Re-Entry, to the Justice, Care and Opportunities Department (JCOD), to establish the Office of Adult Programs within the JCOD and to transfer \$24,404,000 from the Care First and Community Investment (CFCI) CFCI-DHS Level 2 to the CFCI-JCOD Level 2, to ensure JCOD has operational and budgetary purview of all CFCI funding allocated support the work of the Office of Adult Programs. **4-VOTES** (22-4032)

5. Reaffirming Set Rotation for Chair Pro Tem of the Board of Supervisors

Recommendation as submitted by Supervisor Kuehl: Nominate Supervisor Janice Hahn to serve as the Chair of the Board, effective 12:00 p.m. on Monday, December 5, 2022, until the election or succession of her successor; nominate the next Supervisor for the Third Supervisorial District to serve as the Chair Pro Tem, effective 12:00 p.m. on Monday, December 5, 2022, until the election or succession of his/her successor; reaffirm the rotational schedule for the Office of Chair Pro Tem moving forward and to continue continuously until altered as follows:

2023-2024 - Fifth District; 2024-2025 - First District; 2025-2026 - Second District; 2026-2027 - Third District; and 2027-2028 - Fourth District;

In the event the rotation falls on a District with the Supervisor in his or her first year, that incoming Supervisor shall be skipped for election to Chair in favor of the next Supervisor in line, consistent with the rotational schedule and, instead, that incoming Supervisor be nominated as Chair Pro Tem, with the rotational schedule continuing to apply until changed by the Board; amend Section 7 of the Board Rules to add the following language:

The nomination and election for the Chair Pro Tem shall follow the rotational schedule approved by the Board on December 8, 2015 and reaffirmed on November 1, 2022. Should the rotation fall on a District wherein a Supervisor would serve as Chair in his or her first year, that Supervisor-Elect shall not serve as Chair their incoming year. Instead, the Chair shall pass to the next Supervisor in the rotational schedule and the Supervisor-Elect shall serve as Chair Pro Tem their first year. The rotational schedule shall continue thereafter and remain unchanged, unless amended by the Board; and

Instruct the Executive Officer of the Board, to incorporate this policy into any other guideline documents as required within 60 days. (22-3972)

6. Malibu Half Marathon and 5K Event 2022 Fee Waiver

10. Addressing the Rising Rates of Respiratory Syncytial Virus

Recommendation as submitted by Supervisors Barger and Hahn: Instruct the Director of Public Health to work with the Superintendent of Schools of the Los Angeles County Office of Education, community service providers, and other partners, to develop multilingual and culturally competent messaging for parents, families, and caregivers on the risks of Respiratory Syncytial Virus (RSV), best practices and precautions to take to protect infants, children, and other vulnerable populations from RSV, and when to seek additional treatment or hospitalization, and report back to the Board in writing in 60 days with a status update; instruct the Director of Public Health, in coordination with Board offices, professional organizations, medical providers, and community partners, to amplify messaging about the importance of receiving childhood vaccinations for vaccine preventable diseases; and instruct the Director of Public Health to consult with the Director of Health Services and private hospitals, on pediatric RSV case and hospitalization level data, and any developing stress on the system from RSV pediatric patients, and report back to the Board in writing in 60 days with a status update. 11. Initiating Support for the Residents of the Cali Lake Recreational Vehicle Resort

Recommendation as submitted by Supervisor Barger: Instruct the Director of Regional Planning, in coordination with the Directors of Public Works and Public Health, and the Interim Fire Chief, to report back to the Board in writing in 14 days with a summary of the status of the County's review of the Cali Lake Recreational Vehicle (RV) Resort application for a new Conditional Use Permit and provide a summary of their findings related to potential use of the facility for long-term living options; instruct the Executive Director of the Homeless Initiative, Chief Executive Office, in conjunction with the Director of Consumer and Business Affairs, the Executive Director of the Los Angeles County Development Authority, and the Interim Executive Director of the Los Angeles Homeless Services Authority, to report back to the Board in writing within 30 days on the results of their site visit of the Cali Lake RV Resort; instruct the Executive Director of the Homeless Initiative, Chief Executive Office, in collaboration with the Director of Consumer and Business Affairs, the Executive Director of the Los Angeles County Development Authority, the Interim Executive Director of the Los Angeles Homeless Services Authority, and relevant County Departments and agencies, to report back to the Board in writing within 45 days on current homeless prevention programs and resources to assist impacted residents of the Cali Lake RV community and identify any additional prevention options for the Board's consideration, with the report to include the following:

Recommendations for potential funding sources, housing options, and assistance programs for residents;

An assessment of existing mobile home and RV parks in the Service Planning Area 2 - Santa Clarita Valley Region with availability to accommodate Cali Lake residents; and

An overview of the availability of Affordable Housing Program resources to fund replacement RVs for residents with older vehicles who are interested in housing at another RV park; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to send a five-signature letter to Governor Gavin Newsom and the California Department of Housing and Community Development, to request that the State establish a different "draw down" timeline for the Cali Lake RV resort which would enable the County to develop the aforementioned homeless and housing options, and inquire about any surplus RVs less than 10 years old to utilize as replacements for individuals residing in RVs older than 10 years. 12. Establishing Regional Veterans Resources

Recommendation as submitted by Supervisor Barger: Instruct the Director of Military and Veterans Affairs, in collaboration with the County's Center for Strategic Partnerships, the Director of Mental Health's Veteran Peer Access Network, and other necessary stakeholders, to report back to the Board in writing in 90 days on one-time and ongoing funding for the following:

One-time funding to retain a consultant, working with stakeholders to design and develop the services and programs that would be provided at the Arts and Veterans Center in the Santa Clarita Valley (Center), as well as one-time funding for potential capital improvements to the Center; and

Ongoing sustained funding for the services and programing that will be provided at the Center;

Instruct the Director of Military and Veterans Affairs to work with other County Departments, State and Federal Partners and other Non-Governmental Organizations to pursue increased opportunities for collaboration including establishing Memoranda of Understanding, Memorandum of Agreements, and Association Agreements, to enhance services for targeted populations such as those residing further from Veteran Affairs (VA) medical centers, facilities, and resources, and report back to the Board in writing in 180 days on opportunities to pursue State and Federal grants and partnerships to support aging veterans; recommendations to support veterans in rural communities that have decreased access to VA facilities such as the Sepulveda Ambulatory Care Center or the West LA VA Campus; and transportation options and telehealth opportunities to increase access to benefits and services for aging veterans; and take the following actions: Develop and execute a memorandum of understanding with the Director of Aging to design strategies to support aging veterans and connect them to resources provided by relevant local, CalVet, VA, and non-profit organizations and services; and

Develop an Affiliation Agreement with the Elizabeth Dole Foundation to become a Hidden Heroes County in support of our caregivers and families; and

Instruct the Director of Public Health, in collaboration with relevant Departments, to report back to the Board in writing in 90 days with recommendations on how best to collect and use information on "veteran status" to equitably serve veterans across the County. (22-4028)

13. Boosting Employment Opportunities for Veterans, Military Service Members, and their Families

Recommendation as submitted by Supervisor Barger: Instruct the Director of Personnel, in coordination with the Director of Military and Veterans Affairs, and in collaboration with the Director of Economic Opportunity, and other relevant Departments, to take the following actions:

Report back to the Board in writing in 180 days on the County's current veterans' workforce development efforts, with recommendations to partner with other veteran serving programs to develop career pathways, training opportunities, and employment opportunities both in the public and private sector, including:

Recommendations and a plan for the County to track employee veteran status;

Recommendations to ensure that all County new hires who are veterans receive information on the benefits and resources available to them with the opportunity to meet with a County Veterans Services Officer (VSO) to apply for benefits;

Programmatic and policy recommendations to ensure County employees that are concurrently serving in the National Guard or reserves of the armed forces receive the support necessary when any training, activation, or mobilization is required for their service, including options to access testing and opportunities for promotions;

Overview of the County's veteran preference policies and recommendations to ensure that policies are aligned with the Federal Office of Personnel Management's Veterans' preference policy, opportunities to fast-track veterans that are referred by our Workforce Development system America's Job Center of California (AJCC), options to provide increased opportunities for spouses of veterans, and recommendations to ensure that all County Departments have uniform policies in awarding veterans' preference with a mechanism to ensure no candidate is arbitrarily being denied veterans preference;

Proposed policy changes to allow veterans with National Guard Report of Separation and Record of Service (NGB-22s) the opportunity to be eligible for veterans' preference and relevant veterans' services and benefits in the County, including employment services through the Veterans AJCC;

Recommendations for legislative recommendations to lobby the State for increased resources and benefits, as well as funding opportunities for local governments to better serve veterans;

Feasibility of updating County policies to increase access to services, including options to award veterans' preference for veterans with Other Than Honorable (OTH) Discharges, such as those discharged under discriminatory Don't Ask Don't Tell policies, or as a result of untreated Military Sexual Trauma or Post Traumatic Stress Disorder;

Recommendations for legislative recommendations to lobby the Federal government to expand access to services and benefits for veterans including those with NGB-22s and those with OTH Discharges, including increased opportunities for discharge upgrades; and

Include information on the Departments that are eligible to take Veteran Affairs Work Studies and recommendations to expand options to other Departments;

Report back to the Board in writing in 120 days with recommendations to improve and enhance the County's Veteran Internship Program (VIP) to ensure it is providing veterans and military spouses meaningful pathways for County careers, including the following:

Increased opportunities and expectations for all County Departments to take on interns from the VIP program;

Options to assist veterans not hired by the County upon completion of the VIP program internship with other workforce development programs and career pathway opportunities including referrals to the Veterans AJCC, and collaborating with the network of veterans resource centers in higher education, and targeted opportunities for training using workforce development funding; and

Include recommendations for prioritized and targeted outreach and recruitment to veterans, such as veterans experiencing homelessness, into pipeline programs for County employment based on existing County programs including, but not limited to, VIP, Preparing Los Angeles for County Employment, and Countywide Youth Bridges;

Implement and create an externship framework for Department of Defense SkillBridge service members for all County Departments to identify and attract candidates, especially skilled individuals, that align with the critical needs of the Departments; report back to the Board in writing in 90 days on implementation of the program, with the framework of the SkillBridge program to include provisions for service members to be classified as either veteran fellows and/or interns during their County service; and

Develop and enter into any necessary memoranda of understandings, contracts, and/or agreements with the Office of the Deputy Assistant Secretary of Defense, International City/County Management Association, United States Department of Labor VETS program, the United States Army Reserves Public Partnership Program, and/or other relevant partners, to create the framework for the County SkillBridge Program and other employment opportunities. Recommendation as submitted by Supervisor Barger: Recognize November 11, 2022 as "Veterans Day" in Los Angeles County and reaffirm our continued support of our nation's veterans and service members; adopt a resolution declaring the County's participation in the National Association of Counties' Operation Green Light public awareness campaign from November 7 through November 13, 2022; and take the following actions:

Illuminate by green light the Bob Hope Patriotic Hall, the Grand Park fountain, and all other County facilities with the capability to do the same during these dates;

Encourage our cities, businesses, communities, partners, and the military and veteran community in the County to join by participating in Operation Green Light; and

Instruct the Director of Military and Veterans Affairs, in collaboration with relevant County Departments and stakeholders, to explore funding opportunities, including State and Federal grants; and report back to the Board in writing within 120 days on training opportunities to enable first responders across the County to access California Peace Officer Standards Training, Certified Veteran Culture for First Responders training, and Substance Abuse and Mental Health Services Administration Cultural Competency for Serving the Military and Veterans to increase opportunities to provide increased diversion for veterans in crisis by connecting them with the Veterans Affairs for treatment and care. 17. Los Angeles County Efforts to Support Residents with Student Loan Debt Relief

Recommendation as submitted by Supervisors Solis and Mitchell: Instruct all County Departments, leveraging support from the Director of Consumer and Business Affairs, to include information about the student loan debt relief program on their respective websites, electronic newsletters, and other modes of communication for those without internet access to ensure eligible clients apply; instruct the Director of Personnel to work with all County Departments to inform County employees about the student loan debt relief program; direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to send a letter to President Joseph R. Biden and the United States Department of Education Secretary Miguel Cardona:

Commending the Administration on its three-part plan, delivering on the President's promise to cancel student debt for low- to middle-income borrowers; and

Supporting the United States Department of Education's proposals to institute a new income-driven repayment plan for student loans, fix the Public Service Loan Forgiveness Program, increase the maximum Pell Grant, and make community college free; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to commend Governor Gavin Newsom, Senate President Pro Tem Toni Atkins and Assembly Speaker Anthony Rendon for their commitment, and support legislation, if needed, to ensure that the student debt loan relief recovered by Californians is not taxed; and

Instruct the Director of Consumer and Business Affairs, in consultation with the Director of Personnel, Interim County Counsel, and the Chief Executive Officer to report back to the Board in writing in 120 days to explore all options for the County to purchase unpaid or defaulted student loan debt of County employees earning less than County area median income for the purposes of poverty alleviation and economic mobility, including recommendations that explore the following:

Most appropriate type of student loan debt for the County to purchase;

Method to prioritize the County classifications for which the County could purchase the debt of the employees within those classifications;

Recommendations for how to track long-term impact of any debt buy-down program, including a mechanism to measure long-term impact;

Requirements to ensure debt is purchased from employees who have already vested with the Los Angeles County Employees Retirement Association and methods to recoup debt payment should employee leave the County within five years of the debt being purchased;

Proposed criteria workers would have to meet in order for debt to be purchased; and

Opportunities for the County to fill critical vacancies by purchasing unpaid student loan debt as an incentive; and

Instruct the Director of Consumer and Business Affairs and its Center for Financial Empowerment to publish and distribute information about possible scams associated with the student debt relief. (22-4048)

18. Supporting Changes to the Federal E-Rate Program to Accelerate Digital Equity

Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, in collaboration with the Acting Chief Information Officer, the Director of Internal Services, the Superintendent of Schools of the Los Angeles County Office of Education, and the County Librarian to do the following:

Advocate for changes and/or waivers to the Federal Communications Commission's cost allocation rules for the Federal Universal Services Schools and Libraries (E-Rate) Program that would enable schools and libraries to serve as neighborhood hubs for community broadband networks using E-Rate-eligible services; and
