III. APPROVAL OF FEBRUARY 4 and APRIL 7, 2016 MINUTES

Chairman Barcelona asked if there were any objections or changes to the minutes of the February 4, 2016 and April 7, 2016 Commission meetings. Hearing no changes, the motion was then Moved, Seconded, and Adopted. The minutes of the February 4, 2016 and April 7, 2016 Commission meetings were approved.

IV. REPORTS

A. DISCIPLINARY PROCESS: INVESTIGATIVE AND HEARING PHASES

Executive Director Eng reported that the only change in the latest revision is recommendation number three, in which the statute of limitation on when an employee can file a grievance or a complaint against the County was removed. He stated that he sent out the updated final draft report to all Chief Board Deputies and barring any further changes, it is good to go directly to the Board of Supervisors in about a week.

B. COMPARATIVE FEES STUDY

Commission Vice Chair and Task Force Chair Doten reported that the task force is really honing in on the final draft of the Fee Study. She stated that the latest draft was emailed out to each Commissioner in advance of this meeting. She stated that the task force has come up with three recommendations for the Supervisors to consider adopting as they move toward the budget process.

Executive Director Eng stated that the task force needs an approval on whether to include the names of the Departments in the study since it was a small sample. He stated that the report is due in May and the Commission will not meet again until June. Chair-Emeritus Philibosian stated the Commission could do a conditional approval to allow the Executive Committee to make a final vote after the task force gathers additional feedback. Chairman Barcelona asked for a motion and hearing no objections, the motion was then Moved, Seconded, and Adopted.

C. COUNTYWIDE CRIMINAL JUSTICE COORDINATING COMMITTEE (CCJCC)

Chair-Emeritus Philibosian reported that CCJCC discussed a semi-annual report called T.R.A.P., a task force for regional auto-theft prevention. He stated that this is a task force composed of the Sheriff Department, LAPD, and representatives of other independent police departments. He stated that the task force is funded through vehicle license fees so it is not coming directly out of the County or City budget. He stated that there are 3 squads of 16 investigators who go Countywide and hit particular hot spots for auto theft and they are quite successful. He stated that the rate of auto theft has gone up 13% statewide and 18% countywide and their rate of protection has also gone up 18% so they are keeping pace with crimes.

Chair-Emeritus Philibosian also reported a discussion on Prop 47. He stated that the whole point of Prop 47 was to save money in the criminal justice system by downgrading certain offenses and putting people in county jails rather than state prisons; and the money saved would go back to the County to help in rehabilitation of released prisoners and help victims.



He stated that when asked the question, "Have you seen any state money yet?" the answer is always "no".
