- 9) We give ourselves permission to learn from our mistakes.

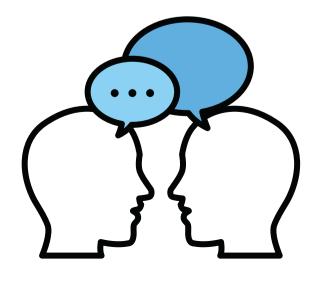

# WHAT IS MONKEYPOX?

Monkeypox is a viral infection transmitted through close personal contact, including kissing, sex, and other skin-to-skin contact. Fatality during the current outbreak is estimated to be very low.

## WHAT ARE THE SYMPTOMS?



## RASH, BUMPS, OR BLISTERS

These may appear anywhere on the body, including the genitals. This may look similar to syphilis, herpes, or other common skin rashes.







Symptom onset ranges from 5-21 days

## WHAT YOU CAN DO







## **STAY INFORMED**

Remain calm. This is a rapidly changing situation. Visit the CDC website for up-to-date guidance.

## **CONTACT**

If you have symptoms, call (do not visit) your health care provider, and ask about testing.

## **ISOLATE**

If you have symptoms, stay at home, wear a mask, and cover lesions to protect others.

#### 1. Welcome + Introductions + Check In

o Shary Alonzo, Co-Chair welcomed attendees and led introductions.

### 2. Executive Director/Staff Report

### • Operational and Programmatic Updates

 Cheryl Barrit announced to the group that the Board of Supervisors (BOS) will likely extend the continuation of virtual meetings for the next 30 days.

#### Program Directive Update

- Feedback from the Women's Caucus (WC) was incorporated into the most recently updated Planning, Priorities & Allocations (PP&A) Committee program directives document, which can be found in the meeting packet.
- Recommendations added include holistic care for mobile clinics, exploring funding options for informal childcare, and telehealth services.
- PP&A Committee will meet Tuesday, May 17, 2022 to review the directives; all are invited to attend.

### 3. Co-Chair's Report

- Dr. Mikhaela Cielo, Co-Chair provided a summary of the April WC meeting. Key points were as follows:
  - The Division of HIV and STD Programs (DHSP) is finalizing its RFP to fund expanded childcare services in formal settings. However, the WC would like to continue looking into informal childcare funding, i.e., friends, family, informal settings.

- The WC recommends more services specifically for women living with HIV, such as support groups that can provide a safe space.
- The WC recommends that funding be granted to organizations to provide transportation and childcare allowing women to attend non-medical, supportive service appointments and community events.
- It was noted that the workforce capacity survey, which is being developed by consultant, AJ King, to help inform Comprehensive HIV Plan (CHP) should be offered in Spanish, include dental services and that culturally appropriate language be incorporated. Additionally, the WC expressed that the survey was too long and that a small incentive should be provided to all those completing the survey versus offering a raffle.

### 4. DISCUSSION | Planning for Next Virtual Event

### Biomedical Prevention Awareness for Women i.e., injectables OR Sexual Health for Aging Women

- The WC chose sexual health for women as the topic for their next virtual event. Dr.
  Guadalupe Morales-Avendano recommended hosting an event centered on sexual
  health for all women, as opposed to only for aging women, and coordinate a
  separate event for aging women living with HIV and sexual health. The group
  concurred.
- S. Alonzo expressed interest in hearing from women who are long-term survivors of HIV.
- The WC decided to host a two-part event, with the first hour conducted in Spanish and the second hour conducted in English. This will provide an opportunity to include the Spanish-speaking community.
- o Potential discussion topics include: 1) HIV disclosure and dating, 2) how to approach the conversation regarding PrEP, and 3) regaining sexual confidence.

### • Identify Potential Speakers

- G. Morales-Avendano will reach out to a sex therapist who can present on the topic.
- o Ilish Perez, DHSP will reach out to two consumers who can speak at the event.
- Joseph Green identified Sunnie Rose Berger from Life Group LA as a potential speaker.

#### • Set Date for Presentation

 The event is scheduled to take place on Monday, July 18, 2022, in lieu of the July WC meeting; time to be determined.

## How the Council Performs Its Work

Subcommittees consisting of members of PACHA may be established to perform specific functions within the Council's jurisdiction. Subcommittees make preliminary recommendations for consideration of the full council. Currently, PACHA consists of three subcommittees: The Ending the HIV Epidemic in the U.S. and the National HIV/AIDS Strategy Subcommittee, Stigma and Disparities Subcommittee, and the Global Subcommittee. The Department Committee Management Officer is notified upon establishment of each subcommittee and is provided information on its name, membership, function, and estimated frequency of meetings.

Management and support services are provided by the Office of Infectious Disease and HIV/AIDS Policy, Office of the Assistant Secretary for Health, U.S. Department of Health and Human Services (HHS).

Meetings are held at the call of the Chair(s), with the advance approval of a full-time Government official, who also approves the agenda. A Government official is present at all meetings.
