I. CALL TO ORDER

With the presence of a quorum, Chairman Peever called the meeting to order.

II. INTRODUCTIONS & ANNOUNCEMENTS

Chairman Peever asked those present to introduce themselves.

II. PRESENTATION

Dr. Caswell Evans
Director of Public Health Programs
Los Angeles County
Topic: Programs and the Future of Public Health

Dr. Evans opened with a discussion highlighting the problems and cause of issues within the Public Health department. Three main salient points of Dr. Evans were the specific functions of assessments, policy and the assurance that necessary services from a public health perspective are available in the community. He elaborated on the future issues facing the public health domain and relayed a sense of the preventative mind state required to keep pace with the increasing population.

V. OLD BUSINESS - TASK FORCE REPORTS

Family and Children Services

Commissioner said the Children Services Commission ordinance issues have been deferred. The Board and the Committee are coordinating policy which is still a work in progress.

Contracting of Drug and Alcohol Abuse

The County is spending \$65 million on treatment of alcohol and drug abuser's but can only handle 30,000 to 40,000 people a year. The high recidivism rate is also a major concern of the administration. Members of the Task Force are looking for ways contracting can benefit the system.

Cultural and Recreational Departments

The Board of Supervisors asked the Commission to cease the study of the consolidation effort. Commissioner said that the task force is working on a business plan for increased private control and support of the Arboreta setup. The issue is now in the hands of the Chief Administrative Officer's Office.

Asset Management

The Task Force is concentrating on Security Services. Although information on the subject has been accumulated over time there is still no closure on this matter.
