1. Welcome and Introductions

Xelestíal Moreno-Luz, Co-Chair, welcomed attendees and led introductions.

2. Co-Chairs Report

a. Last Meeting Recap (January 23, 2024)

X. Moreno-Luz noted that at the January 23, 2024 meeting, Jade Ali was elected as co-chair for the Caucus. She added that the Caucus drafted their 2024 workplan and meeting calendar and began planning for the Harm Reduction Institute in April 2024.

b. Adopt 2024 Workplan and Meeting Calendar

J. Rangel-Garibay provided an overview of the 2024 draft workplan and meeting calendar. He noted the major changes to the documents are marked in red. These changes include three activities that aim to align the Caucus' activities with the charge of the Commission. See the meeting packet for a copy of the documents.

3. Executive Director/Staff Report

a. Operational and Programmatic Updates

C. Barrit provided an overview of the PSRA process. She explained that the Commission on HIV is the Federally mandated HIV planning council for the County of Los Angeles established by the Health Resources and Services Administration (HRSA) and the Board of Supervisors (BOS). She noted that the Commission's subgroups have the opportunity to provide recommendations to the Planning Priorities and Allocation (PP&A) Committee to help inform their deliberations during the PSRA Process. X. Moreno-Luz asked what the timeline is for the Caucus to draft recommendations to the PP&A Committee and what the process has looked like in the past. C. Barrit suggested that the Caucus review the Women's Caucus recommendations from previous years to kickstart a brainstorm session among the Transgender Caucus members. She added a recommendation for the Caucus to draft a memo to the PP&A Committee to formally transmit the recommendations and document the activity. See the meeting packet for a copy of the PSRA handouts discussed.

X. Moreno-Luz initiated a brainstorming session prompting attendees to share any ideas for recommendations. Devil Diaz suggested the Caucus consider recommending a requirement that housing services provider agencies to develop policies that protect the rights of TGI clients. He added that the contracted agency definition of "women" needs to be inclusive of TGI clients. Rita Garcia suggested the Caucus consider recommending support funding for training and staff development opportunities for contracted agencies to provide trauma-informed services to TGI

clients. She added a recommendation to support funding for Peer Support services that assist TGI clients in navigating the healthcare system. Miro Dali suggested the Caucus consider recommending that contracted agencies review their “wet” vs. “dry” housing policies for HIV-specific housing. Diamon Paulk added a recommendation to change policies related to HIV-specific housing to improve retention of TGI clients. X. Moreno-Luz added that the goal should be to create systems that protect clients do not surveil them. Talia Huerta added that a key strategy is fostering a safe space for TGI clients and explaining to them the reason certain policies are in place. The more upfront provider agency staff are with the clients, the more likely they are to listen, understand, and abide by the policies. C. Barrit recommended that the Caucus consider collecting community feedback and recommendations during the upcoming Harm Reduction Institute event in April.

4. DISCUSSION

a. 2024 Workplan and Meeting Calendar

The Caucus adopted their 2024 workplan and meeting calendar as revised. The Caucus decided to reinstate their March meeting and utilize that time to continue their brainstorming session. The Caucus also decided to cancel their May community engagement activity centered around International Day Against Homophobia, Transphobia, and Biphobia and will utilize the meeting to finalize their recommendations and draft a memo they will send to the PP&A Committee.

b. Harm Reduction Institute | Planning and Updates

X. Moreno-Luz shared updates regarding the Harm Reduction Institute. The event will take place on April 29, 2024 from 9am-3pm at the Vermont Corridor. The event will feature a presentation by REACH LA staff on the results from their Harm Reduction Survey, followed by a panel discussion with the Health Equity Action Liaisons (HEAL). In the afternoon, there will be presentations from the UCLA and CHLA research study opportunities. The event will conclude with a Naloxone training and a self-defense training; these activities will take place concurrently. Participants can expect to receive an evaluation survey for the event at its conclusion. The expected attendance is 30-50 people.

Caucus members recommend that the event planners develop marketing materials and a brief pitch to share with their respective community groups. T. Huerta noted that she can assist with disseminating marketing materials and promoting the event on the Division on HIV and STD Programs (DHSP) transgender-focused social media channels. R. Garcia echoed T. Huerta’s sentiment and offered to work with the communications team at the Translatina Coalition to disseminate the materials as well.

Caucus members recommended to consider having a resource table or tabling component at the event to invite other organizations to share their efforts including any grassroots TGI-led groups that can contribute to the Harm Reduction Institute. Additionally, Caucus members recommended to add some time on the event agenda to introduce harm reduction and provide a brief overview of substance use in Los Angeles County. COH staff will follow-up with staff at the Substance Abuse Prevention Control (SAPC) Program to invite someone to conduct this report. D. Paulk offered to share print materials with information on Narcan that can be distributed at the event and supplement the onsite training.

The Caucus co-chairs and COH staff will follow-up with the presenters from UCLA and CHLA to discuss their presentations and answer any pending questions regarding their involvement.

5. Meeting Confirmation and Agenda Development for Next Meeting

The next meeting will be on March 26, 2024 location to be determined and will be announced at least 2 weeks prior to the meeting. The Caucus will review the Women's Caucus recommendations and continue their brainstorming session to inform their draft memo to the PP&A Committee.

6. Public Comments and Announcements

- D. Paulk shared that she is meeting with the LA Pride organization to discuss planning of a conference for TGI people that would take place at the beginning of or in Mid-July. She also noted that the next Pillow Talk will take place on March 21, 2024 at The Gathering Spot. Lastly, she mentioned the cohort membership for the HIV.E program she manages will move to a rolling-basis enrollment. There are currently 10 slots available. The program offers a \$100 stipend and members will be tasked with helping plan upcoming Pillow Talks and provide input for the TGI Conference in partnership with LA Pride later in the summer.
- T. Moreta and T. Huerta shared details about the LA Trans Women study and encouraged attendees to help with recruiting community members to participate in the study.
- Kevin Pizarro shared information on current and upcoming HIV studies at the UCLA Center for AIDS Research and Education (CARE). He noted he is interested in increasing recruitment of TGI individuals in research studies and shared brochures with more information.
- D. Diaz shared that his organization hosts a research subcommittee as part of Connect to Protect LA on the 4th Thursday of the month from 10am to 11:30am. The goal is for attendees to share research insights on current, ongoing, and upcoming research projects. The meeting is virtual, and all are encouraged to attend.

7. Adjournment

The meeting adjourned at 12:03pm.

- ❖ Service standards are written for service providers to follow
- ❖ Service standards establish the minimal level of service or care that a Ryan White funded agency or provider may offer
- ❖ Service standards are essential in defining and ensuring consistent quality care is offered to all clients
- ❖ Service standards serve as a benchmark by which services are monitored and contracts are developed
- ❖ Service standards define the main components/activities of a service category
- ❖ Service standards do not include guidance on clinical or agency operations
