COMMISSION NEWS

20th ANNUAL LEADERSHIP CONFERENCE



The Quality and Productivity Commission (Commission), in collaboration with the Board of Supervisors and the Chief Executive Office. hosted the 20th Annual Leadership Conference at the Music Center, Grand Ballroom. The year's theme was "Winning With Trust Through Innovation" with an objective of strengthening public trust and confidence through government innovation.

Commissioner William B. Parent served as this year's Leadership Conference Ad Hoc Committee Chair and also as the Master of Ceremonies during the Conference. He welcomed over 150 attendees to the in-person Conference and hundreds more who watched via live streaming.

Supervisor Lindsey P. Horvath gave the opening remarks on behalf of the Board of Supervisors and thanked

County staff for their service and noted that they are an inspiration for all they do, especially in the face of adversity these last few years. She also spoke on how we build, secure, and maintain trust with constituents and stakeholders accountability leads and builds trust. She also underscored the need to begin with trust especially those in leadership roles in order to tackle challenges like homelessness and climate change.

Fesia A. Davenport, Chief Executive Officer, kicked off the Conference with a reminder that trust is earned and provided examples of what the County workforce do every day—through services and programs—to strengthen public trust and confidence in government. County innovations include the launch of the 988 crisis response system and the new Countywide Speakers Bureau, implementing the Guaranteed Income Program,

and enlisting promotoras to bring vital health messaging to communities.

Dr. Raphael Sonenshein (Executive Director, Pat Brown Institute for Public Affairs at California State University, Los Angeles) moderated the panel speakers (Dr. Va Lecia Adams Kellum (Chief Executive Office, Los Angeles Housing Services Authority), Dr. Jackie Contreras (Director, Department of Public Social Services), Dr. Barbara Ferrer (Director, Department of Public Health) and George Gascón (District Attorney, County of Los Angeles) to discuss what is trust and how, as leaders, they build trust in their departments and the communities they serve.

The Innovation/Technology Speaker Michael Allen (Laserfiche), defined generative intelligence (AI) and how the potential misuse of AI can impact trust in organizations as well as responsible and effective use of AI. AI can help edit documents and presentations, generate meeting notes from audio recordings, transform web development, and automate repetitive and tedious tasks, thereby increasing productivity.

Overall, each speaker added their personal experience and examples from their respective organizations on building, earning, and maintaining trust. We thank all speakers for sharing their time and expertise at this year's Conference. We also thank the Leadership Conference ad hoc Committee members - Commissioners William B. Parent (Chair), Dion Rambo (Vice Chair), Jacki Bacharach, Nichelle Henderson, Shawn Landres, Ed McIntyre, Yasmine-Imani McMorrin, Jessica Gama (Productivity Manager, Probation) and Andrea Barnes (Productivity Manager, Child Support Services) for their leadership in planning the Conference.

WELCOME NEW COMMISSIONER DEREK HSIEH

Commissioner Derek Hsieh was appointed to the Commission on February 23, 2023. In accordance with County Ordinance 3.51 Quality and Productivity Commission, he is one of two Labor appointees to the Commission. He is currently the Vice Chair for the Coalition of County Unions, and Executive Director at the Association for Los Angeles Deputy Sheriffs (ALADS).



The ALADS is an organization that represents approximately 8,000 Deputy Sheriff's and District Attorney Investigators employed by the County of Los Angeles. He reports directly to the ALADS President and the seven-member Board of Directors and is ultimately responsible for developing, overseeing, and carrying out the organizational policies and ensuring the overall success and effectiveness of ALADS. He leads ALADS' 25+ member staff and manage the activities of numerous professional services vendors and contractors. His reoccurring responsibilities include the annual corporate budget, oversight of all final human resource decisions, capital projects, facility management, strategic planning, communications, labor relations task & formal negotiations as well as all business functions required to accomplish organizational objectives.

Externally, he serves as fiduciary on a number of boards, panels, and committees that manage a wide spectrum of employee benefits and programs including large medical and retirement plans, coalitions of employee groups and unions, and sit as a Vice President on the Los Angeles Federation of Labor (AFL-CIO). Prior to Los Angeles County, he was a Patrol Supervisor/Officer with the Anchorage Police Department (Alaska) for over 20 years and served as Captain in the US Army for almost 16 years before that.

The Executive Support Division provides specialized knowledge, expertise, and support to the Fire Chief and Executive Team in the

creation and dissemination of internal and external communications and sustainable policies and practices. Additionally, Ms. Oliva collaborates with the Fire Chief; Executive Team; stakeholder groups (Women's Fire League, Stentorians, Bomberos and Los Bomberos, and Asian Pacific Islander); the Anti-Racism, Diversity, and Inclusion Initiative; and Women and Girl's Initiative to cultivate and foster an equitable, diverse, and inclusive workplace by implementing initiatives, programs, and campaigns through FIRE Forward to create a greater sense of belonging for all personnel and the residents we serve.

During her tenure with the Department, Ms. Oliva served as the Executive Assistant to the Fire Chief and Administrative Services Manager to the Chief Deputy of Emergency Operations, and also spent nine years as the Grants Management Section Manager responsible for needs determination, administration, and expenditure auditing for federal, State, and private foundation grants, totaling over \$10.1M annually.

Earlier in her career, Ms. Oliva spent ten years climbing the ranks in various administrative capacities serving both the Fire Department's emergency and business operations bureaus; and, was assigned to an Incident Management Team as a Finance Section Chief for six years.

Ms. Oliva received her Bachelor of Arts Degree in Psychology from California State University, Los Angeles and is also a graduate of the Los Angeles County Executive Leadership Development and Management Development Programs. Ms. Oliva participates actively in professional associations, including the Los Angeles County Management Council, Los Angeles County Women's Leadership Conference Committee, and was pleased to join the Quality and Productivity Managers' Network Executive Committee as the 1st Vice Chair in 2021 and Chair in 2023.

Ms. Oliva resides in Alhambra with her two sons.
