#### 2. Constitutional Revision Commission

Task Force Co-Chairman Abel showed a short video from the **Joint Senate-Assembly Field Hearing on the State-Local Fiscal Relationship** that was hosted by the Metro Forum Project on March 27, 1998. The video focused on the importance of local control and the unintended consequences of Proposition 13.

Task Force Co-Chairman Abel asked Mr. Staniforth to report on the status of the CAO's related project. Mr. Staniforth stated that Mr. Janssen and his staff are still actively involved in this project and we expect communication from them after their work on the upcoming budget is completed.

Commissioner Farrar stated that there needs to be a forum for dialog among communities. This need is an opportunity for counties to take a leadership role in providing this forum. The EEC can act as a catalyst and recommend that the county take this opportunity. There are nearly 90 political jurisdictions in California and there is no apparent leadership except for counties.

#### 3. Commission Web Page Development

Commissioner Lucente stated that redesigned commission web site is online. Press releases were sent to government agencies and the press. The web site has received responses from this effort. The maintenance manual is expected to be completed by the end of May. The EEC also has new letterhead which incorporates the logo from the web site.
