47-A. Budget Adjustment and Approval of Change Orders to Complete the Olive View-UCLA Medical Center Fire Alarm and Nurse Call Systems Replacement Project

Recommendation as submitted by Supervisor Kuehl: Find that the previously approved Olive View-UCLA Medical Center Fire Alarm and Nurse Call Systems Replacement Capital Project Nos. 89117, 87382 and 87394 (Project) are within the scope of the Board's previous findings of exemption under the California Environmental Quality Act (CEQA), and that work included in the currently proposed change orders, and to be carried out through Board-approved Job Order Contract (JOC), as well as the related directives included herein are also exempt from CEQA; approve the revised total Project budget of \$83,916,000 for the Project; authorize the issuance of additional short-term notes through the Los Angeles County Capital Asset Leasing Corporation in the amount of \$8,190,000 and approve the Fiscal Year 2022-23 appropriation adjustment to finance the proposed actions described above to fund remaining expenditures of the Project; and instruct the Director of Public Works to take the following actions:

Finalize negotiations and execute individual change orders with PENTA Building Group for each of the following unforeseen conditions: noncompliant framing at the patient headwalls for an amount not to exceed \$1,500,000, mold removal in patient care areas for an amount not to exceed \$1,900,000, replacement of 17 noncompliant fire alarm panels for an amount not to exceed \$600,000; and installation of a clean agent fire suppression system in the hospital's data room for an amount not to exceed \$600,000; and

Utilize a Board-approved JOC to replace smoke dampers in nonpatient care areas, and to address other existing, noncompliant conditions encountered throughout the course of construction within the limitations of Public Contract Code Section 20128.5. (22-3846)
