Heidi Oliva, PMN Chair, Fire Department, and **Commissioner Scott Palmer, QPC/PMN Co-Liaison**, welcomed Productivity Managers to the meeting.

(Children and Family Services), Inna Sarac, PQA Co-Chair (Fire), Patricia Soltero Sanchez, PQA Co-Chair (Health Services – Rancho Los Amigos National Rehabilitation Center), Jennifer Coultas, Training and Education Chair (Child Support Services), and Stephanie Maxberry, Executive Advisor (Economic Opportunity).

Heidi stated that it is an honor to represent the PMN as Chair this year. She is looking forward to working with Commissioners, Commission staff and leading the Network in achieving the Commission's goals. She also thanked Arman Depanian who served as Chair during the last three years (2020-2022). He did an incredible job during his tenure. Arman became Chair at the start of the pandemic and led the Network through a tough three years. The Executive Committee is glad that he has agreed to continue to serve as 2nd Vice-Chair this year. His experience and knowledge will be invaluable. She also made the following remarks:

- The PMN Holiday Reception was held on December 7, 2022, at the San Antonio Winery. At the reception, it was announced that the Network will have a hybrid schedule for 2023. The February and August meetings, as well as the Holiday reception will be held in-person, and the May and November meetings will be held virtually.
- She also welcomed back Commissioner Scott Palmer, as QPC-PMN Co-Liaison to the Network. Commissioner Yasmine-Imani McMorrin as Co-Liaison. The PMN looks forward to working with Commissioners Palmer and McMorrin throughout the year and appreciates their continued support.
- A New Managers' Orientation meeting was held on February 1, 2023. Six new Managers attended to learn about their role with the Commission.
- Presentations at the PMN Meeting included Dr. D'Artagnan Scorza, Executive Director, Anti-Racism, Diversity, and Inclusion (ARDI), who gave an update on

ARDI efforts, and Susan Linschoten, Chair, and Arman Depanian, Co-Chair, Productivity Investment Board Advisory Committee, who provided training on the Productivity Investment Fund (PIF).

2023 Commission Announcements

Commissioner Scott Palmer welcomed everyone to the meeting. He stated he enjoyed working with the Network last year and looks forward to working with them again this year. He provided the following Commission updates:

 Assembly Bill 361 will end on February 28, 2023. This Bill had allowed Boards/Committees/Agencies created by the Board of Supervisors, with required Brown Act meetings,

- to have virtual meetings. Effective March 1, 2023, the Commission will resume inperson meetings for all Brown Act meetings. This includes the Productivity Investment Board and the full Commission meetings.
- The Commission is currently working on the 20th Annual Leadership Conference. It is scheduled for Wednesday, June 14, 2023. He asked Managers to save-the-date on their respective Department Head calendar's as well as their own.
- The Commission has also started planning the 36th Annual Productivity and Quality Awards program. Applications are due at the end of June 2023. Managers are encouraged to start looking now at potential projects within their departments.
- The Commission has 18 Department Visits scheduled this year. Although the Commission prefers to have in-person visits, the Commission will also allow virtual visits this year. It will be up to your respective Department head to decide what works best for them and his/her staff.
- The Commission is currently soliciting Productivity Investment Fund proposals. The next deadline to submit proposals is April 7, 2023, by 5:00 p.m.

Managers appreciated learning what the ARDI Initiative is about and contextualizing the County's needs. This included information on factors that influence opportunities, neighborhood structural characteristics that interfere with

individual choices, understanding structural racism-definitions, and the County's vision for racial equity and the ARDI mission. The dialogue after the meeting was very engaging and gave Managers food for thought as they return to their respective departments to share the information they received
