# 2. Increasing Fair Chance Hiring Throughout Los Angeles County

Recommendation as submitted by Supervisors Mitchell and Solis: Approve an ordinance for introduction entitled the Fair Chance Ordinance for Employers, amending County Code, Title 8 - Consumer Protection, Business and Wage Regulations, by adding Division 6 - Worker Protections and Chapter 8.300 - Fair Chance Ordinance for Employers, and includes an operative date for administrative enforcement of September 3, 2024; instruct the Director of Personnel, in addition to the directives addressed to the Department of Human Resources on Board Order No. 12 of February 28, 2023, ordinance motion, to do the following within 60 days of the Board's adoption of the Fair Chance Ordinance for Employers: (Relates to Agenda No. 72)

Submit a draft Fair Chance County Board Policy to the Audit Committee for approval, with the draft to contain the key protections and rights for applicants and employees of the County who have prior criminal history and employer obligations consistent with the Fair Chance Ordinance for Employers;

Prepare a revised Policy, Procedure, and Guideline (PPG) 514, Designation of Sensitive Position and Conviction History Assessments, to conform to the key protections, rights and employer obligations as contained in the Fair Chance Ordinance for Employers, with the PPG to contain provisions for enforcement and accountability by County Departments, entities and hiring managers, and include engagement with labor partners regarding the revised PPG 514 with a target date for implementation by September 3, 2024; and

Instruct the Executive Director of the County Equity Oversight Panel, in collaboration with the Director of Personnel and the Executive Director of Racial Equity, to do the following within 60 days of the Board's adoption of the Fair Chance Ordinance for Employers:

Include "persons with criminal history" as a protected category within the County Policy of Equity;

Report back to the Board in writing with an implementation plan for enforcement and accountability of the County's internal administrative Fair Chance policies and procedures, including the process for complaint intake, investigation, disposition and options for resolution of Fair Chance complaints received from County applicants and employees;

Instruct the Director of Economic Opportunity, in collaboration with the Director of Consumer and Business Affairs and other internal and external partners, including philanthropic organizations, to report back to the Board in writing within 60 days with an implementation plan for outreach and education for employers with a target launch date of April 29, 2024, to be completed before the operative date of the ordinance on September 3, 2024, including a staffing and funding plan; and

Authorize the Directors of Economic Opportunity and Consumer and Business Affairs to select a consultant(s) for outreach and education on the ordinance, negotiate with the selected consultant, and execute an agreement, with the total contract amount not to exceed \$500,000 for a term of no more than one year, to be funded within the Department of Economic Opportunity's current budget with no additional funding needed; and further authorize the Director of Economic Opportunity to execute any amendments to the agreement, as necessary, once they have been approved. Instruct the Executive Director of Racial Equity, and the Director of Personnel, in collaboration with the Chief Executive Officer, the Sheriff, the Executive Director of the Human Relations Commission, and relevant community-based organizations, to create and produce training videos for County personnel and for local law enforcement agencies to educate and promote culturally sensitive anti-Black hate prevention methods and responses, including resources and tactics for increased safety for victims and bystanders. Input from the Los Angeles Homeless Services Authority's Lived Experience Advisory Board and the Homeless Youth Forum of Los Angeles, on any enhancements or gaps in current prevention programming serving older adults and transition age youth; and

Work with the Board-established Prevention and Promotion Systems Governing Committee to prepare a live presentation focused on the homelessness and housing domain that will be brought before the Board by June 4, 2024, and should include a timeline and action plan for short-and long-term solutions through prevention-based programs and resources. # 19. Creation of a Compact Mobile Food Operation Fee Waiver/Subsidy Program

Recommendation as submitted by Supervisors Solis and Mitchell: Adopt the Option 1B Subsidy Program (Program) for the Department of Public Health's (DPH) Compact Mobile Food Ordinance Fees as described in the Chief Executive Officer's January 19, 2024 report entitled, "Report Back on Funding to Address the Department of Public Health's Permit Fees," with the following parameters:

Eligible vendors will receive a subsidy of 75% toward their Compact Mobile Food Ordinance Fees through June 30, 2025, up to \$500,000 in total subsidies;

Eligibility will be limited to vendors with annual net revenues of less than \$50,000 who have never held a permit with DPH to vend food (i.e., vendors who are new to the regulated marketplace), and who are applying for a new food vending permit;

Vendors must be a resident of an unincorporated County area or compact mobile food vendor in the unincorporated County area; and

Vendors must complete an educational workshop offered by the Department of Economic Opportunity (DEO) to qualify for the subsidy;

Instruct the Directors of Economic Opportunity and Public Health to collaborate on the design of the Program with the primary purpose of incentivizing vendors to join the regulated marketplace, where the Program must take into account the many barriers vendors face when interacting with government and be linguistically and culturally competent;

Direct the Chief Executive Officer to amend the Board-approved American Rescue Plan (ARP) Coronavirus Local Fiscal Recovery Funds (CLFRF) Spending Plan to include \$300,000 in funding for the Program, which will be funded via ARP CLFRF's revenue loss provisions, with this increase to correspond with a \$300,000 reduction of funding for the DPH-administered Community Testing program in the Board approved ARP CLFRF Spending Plan, this \$300,000 is in addition to \$200,000 in ARP Local Assistance and Tribal Consistency Fund appropriation already in DEO's budget for the Program, for total funding of \$500,000; and

Instruct the Director of Economic Opportunity, in collaboration with the Director of Public Health, to report back to the Board in writing within 45 days, and quarterly thereafter, until the full amount of the funding subsidy is expended or until the Program ends on June 30, 2025. (24-0543)

# 20. Preventing Homelessness Among Survivors of Domestic Violence

Authorizes approved cottage food items prepared in a permitted cottage food operation to be served from a CMFO; and

Makes violations of State law and the County Code by an operator or employee of a compact mobile food facility or a sidewalk vendor punishable only by an administrative fine. (23-1813)
