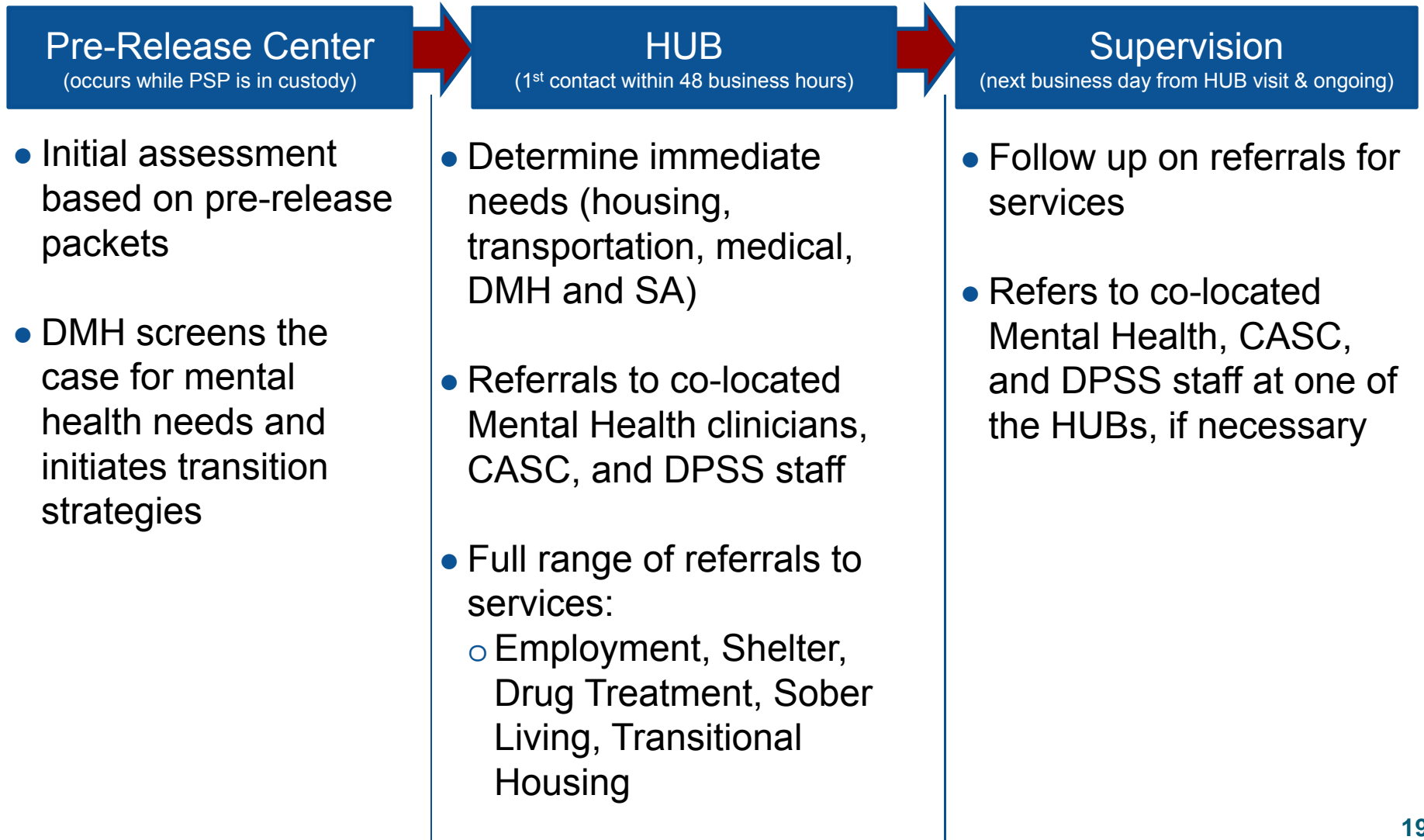

Mentally Disordered Offenders (MDOs)

Five (5) individuals who were former MDOs are currently receiving services from DMH, having returned to jail with an average of two (2) incarcerations each and an average length of jail stay of 54 days.

- One of these individuals is now employed and continues in outpatient treatment.
- One individual had multiple 5150s, was LPS conserved, and admitted to a State Hospital at a cost of \$250,000 annually.
- Three (3) individuals are currently receiving housing services through the Department's IMD Step-downs. Step-down services include case management, individual and group therapy, medication management, and linkage.

Emerging Issue

Beginning July 1, 2013, revocations for state parolees will be heard in the local Court system. Supervision and treatment services for State parolees will remain a State responsibility. Restructuring and downsizing of Parole Outpatient Clinics may increase demand on county inpatient and residential care services.

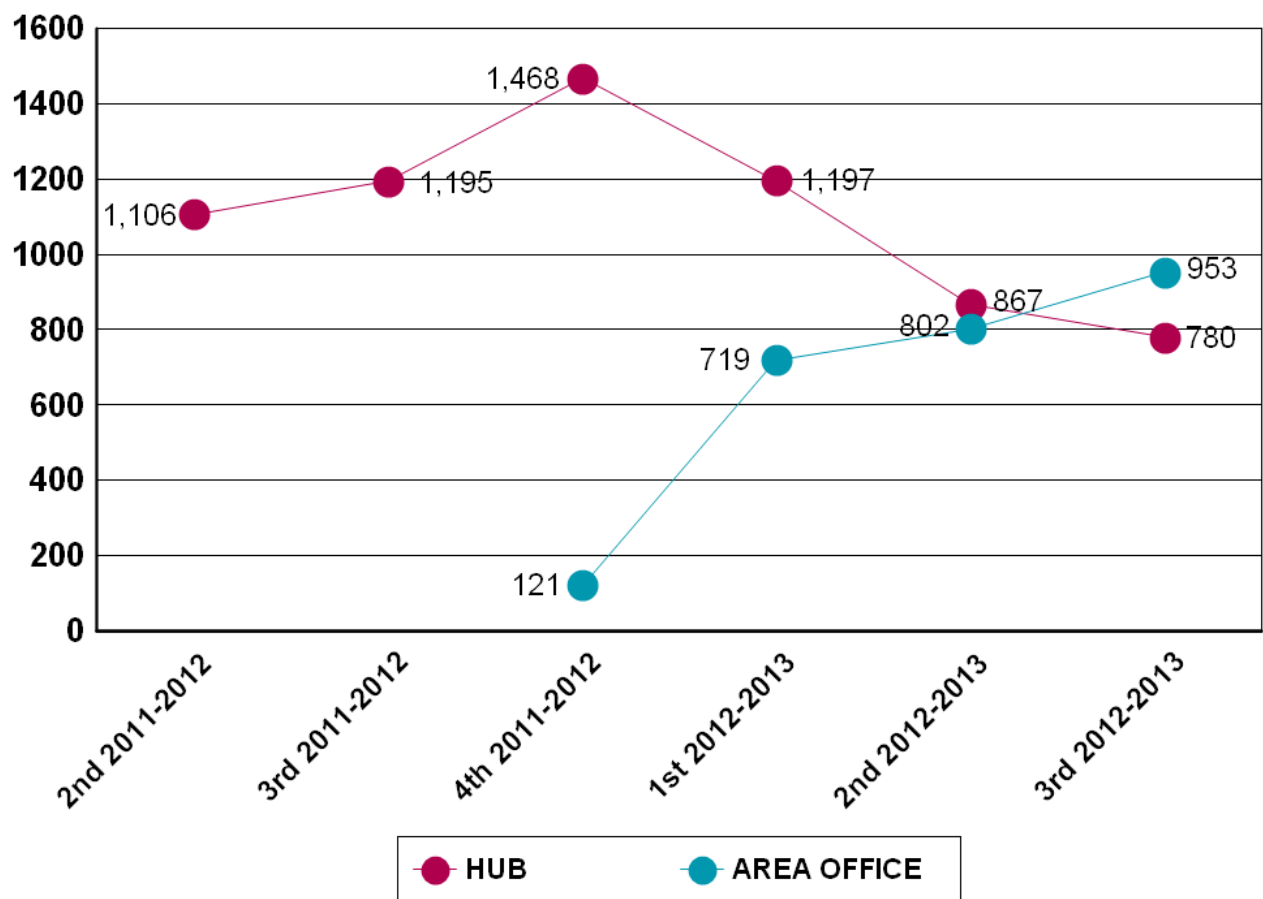

AB 109 Probation Substance Use Disorder Referrals

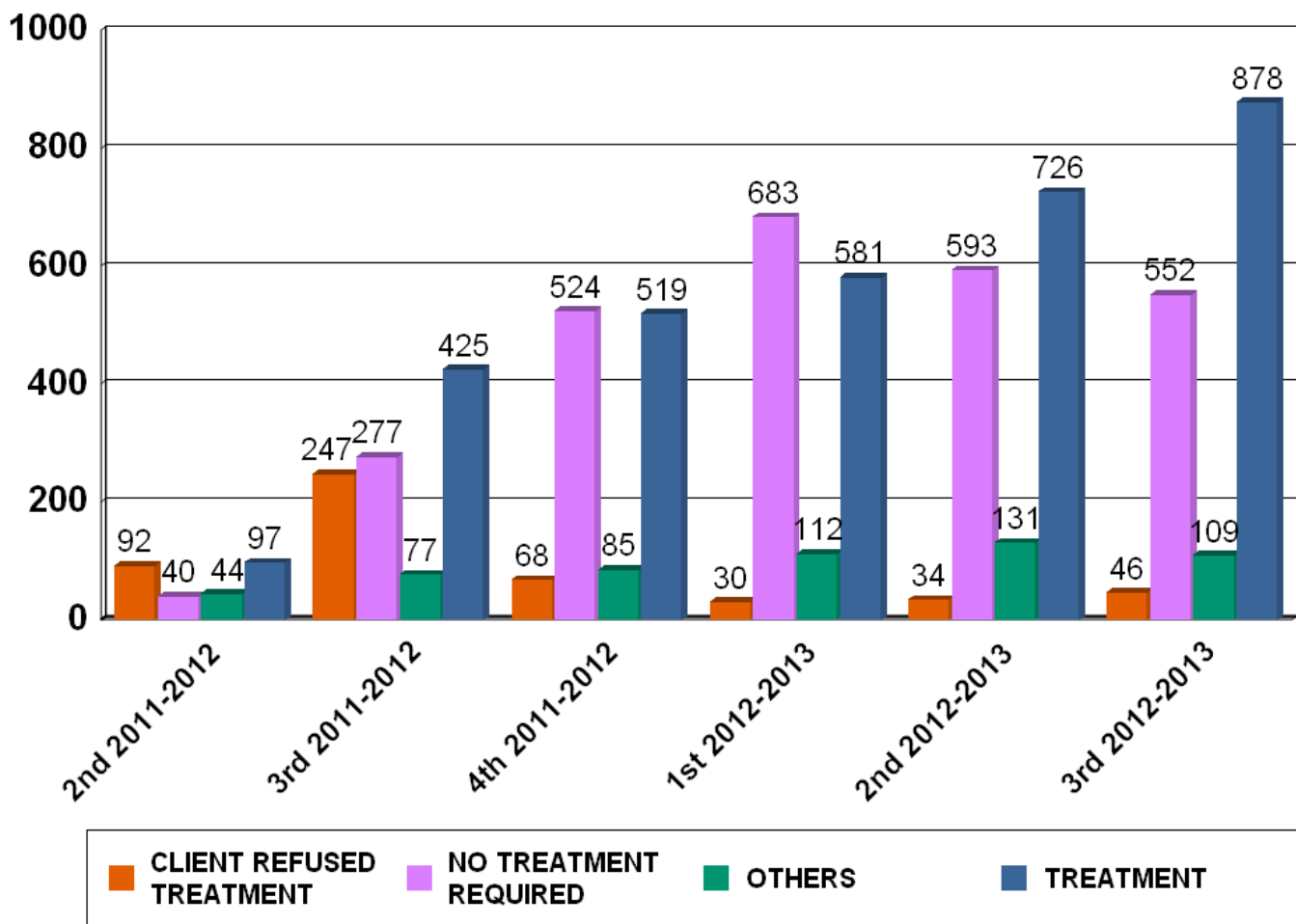


Description:

CASC Assessments Completed (Total CASC Workload)

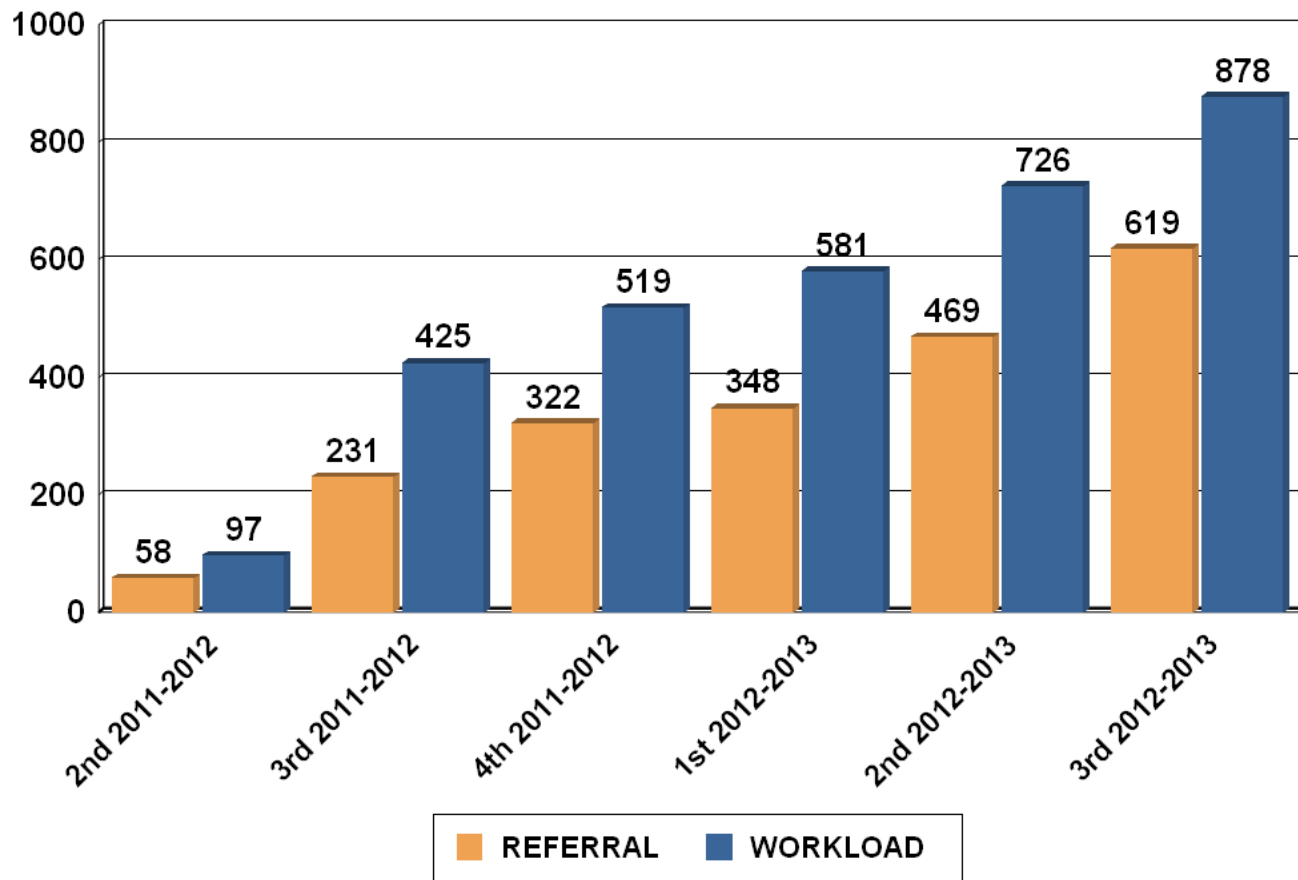


Description:

CASC Assessments Related to Treatment Recommendations



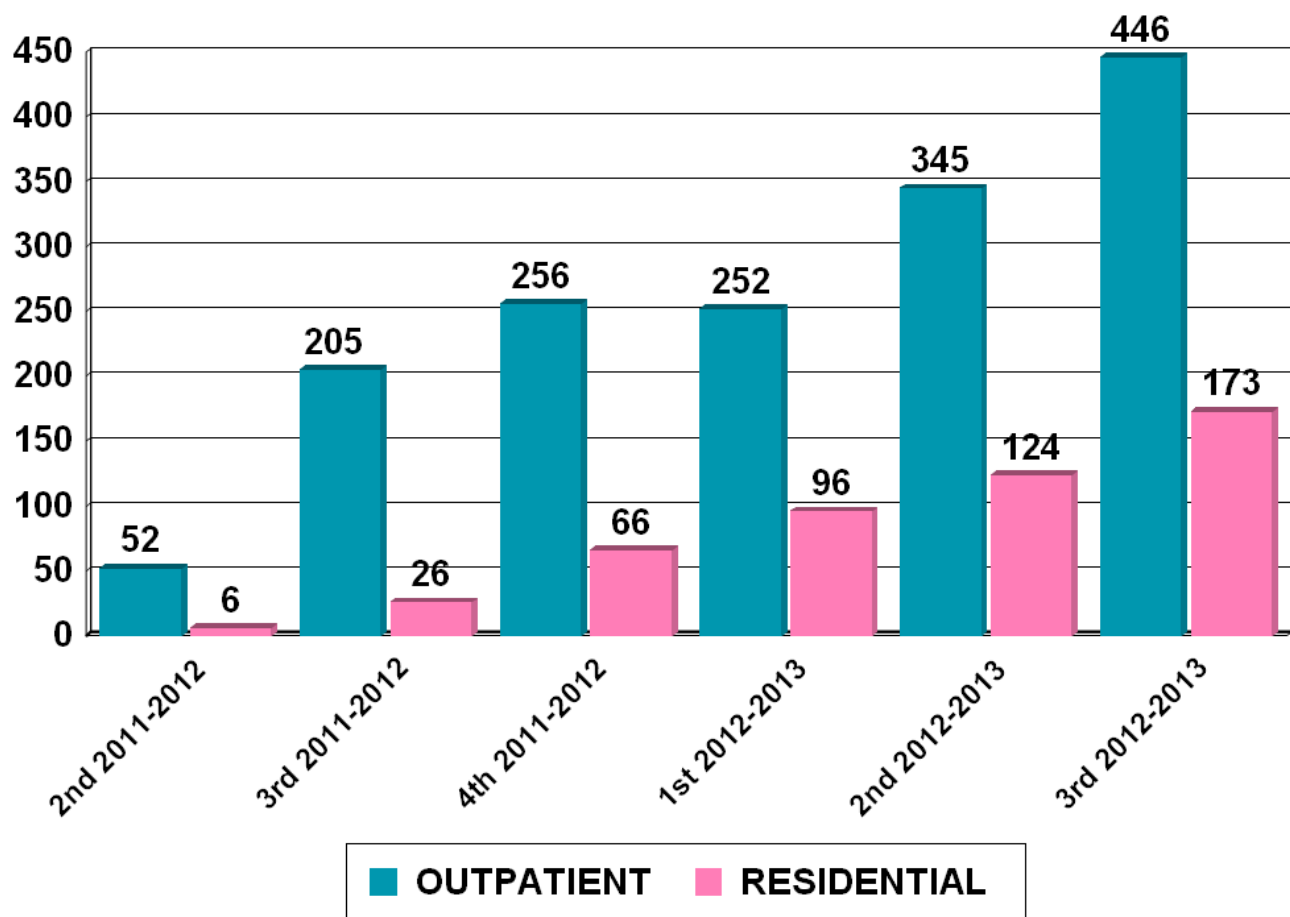
Description:

- Provider location change

Notes: Within a quarter a participant can have multiple contacts with CASC which result in a treatment recommendation. Each individual recommendation for treatment is counted.

CASC Treatment Referrals by Treatment Modality

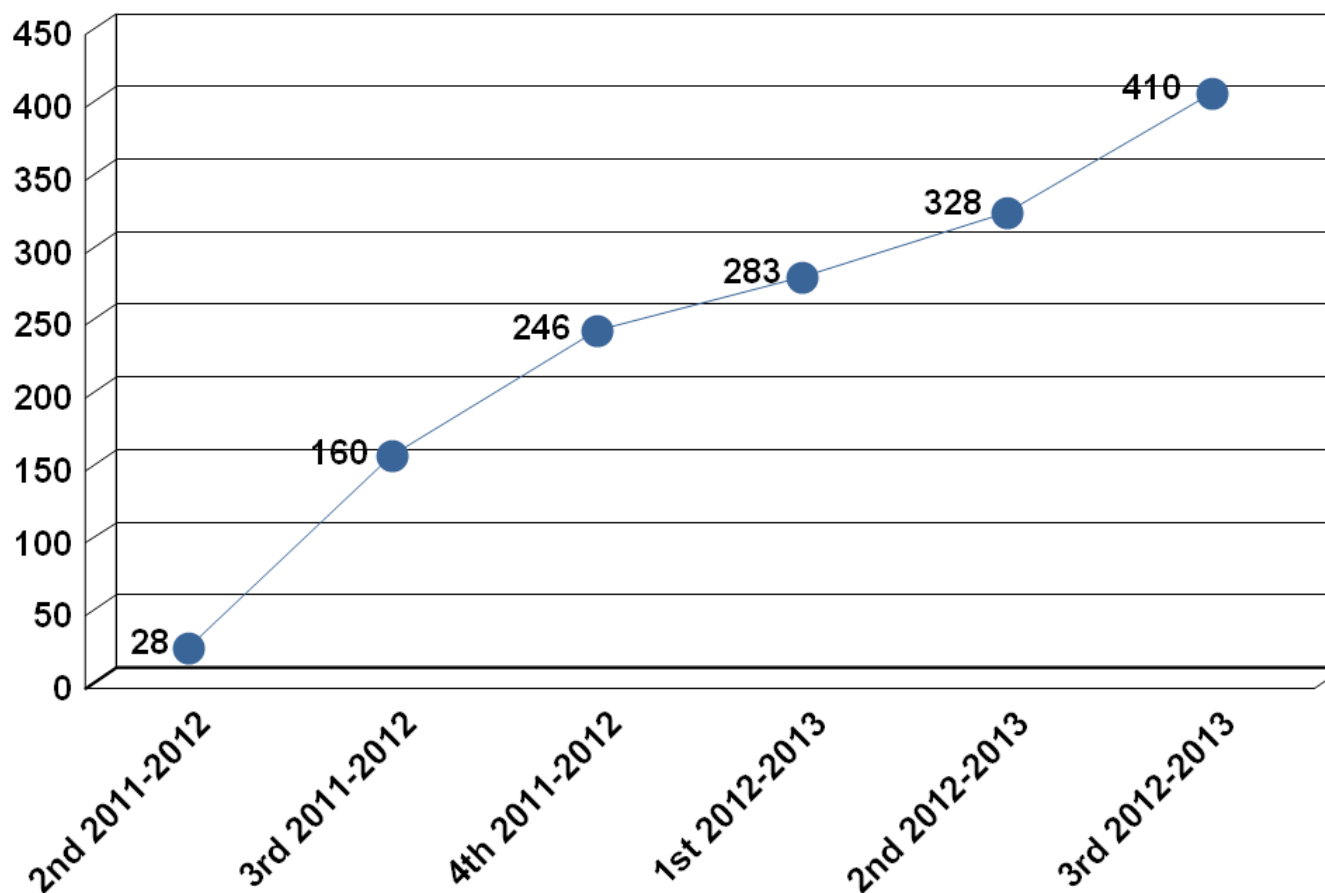


Description:

This graph represents referrals to SUD treatment programs by modality. Enrollments into the program may not occur within the same quarter as the CASC assessment for treatment.

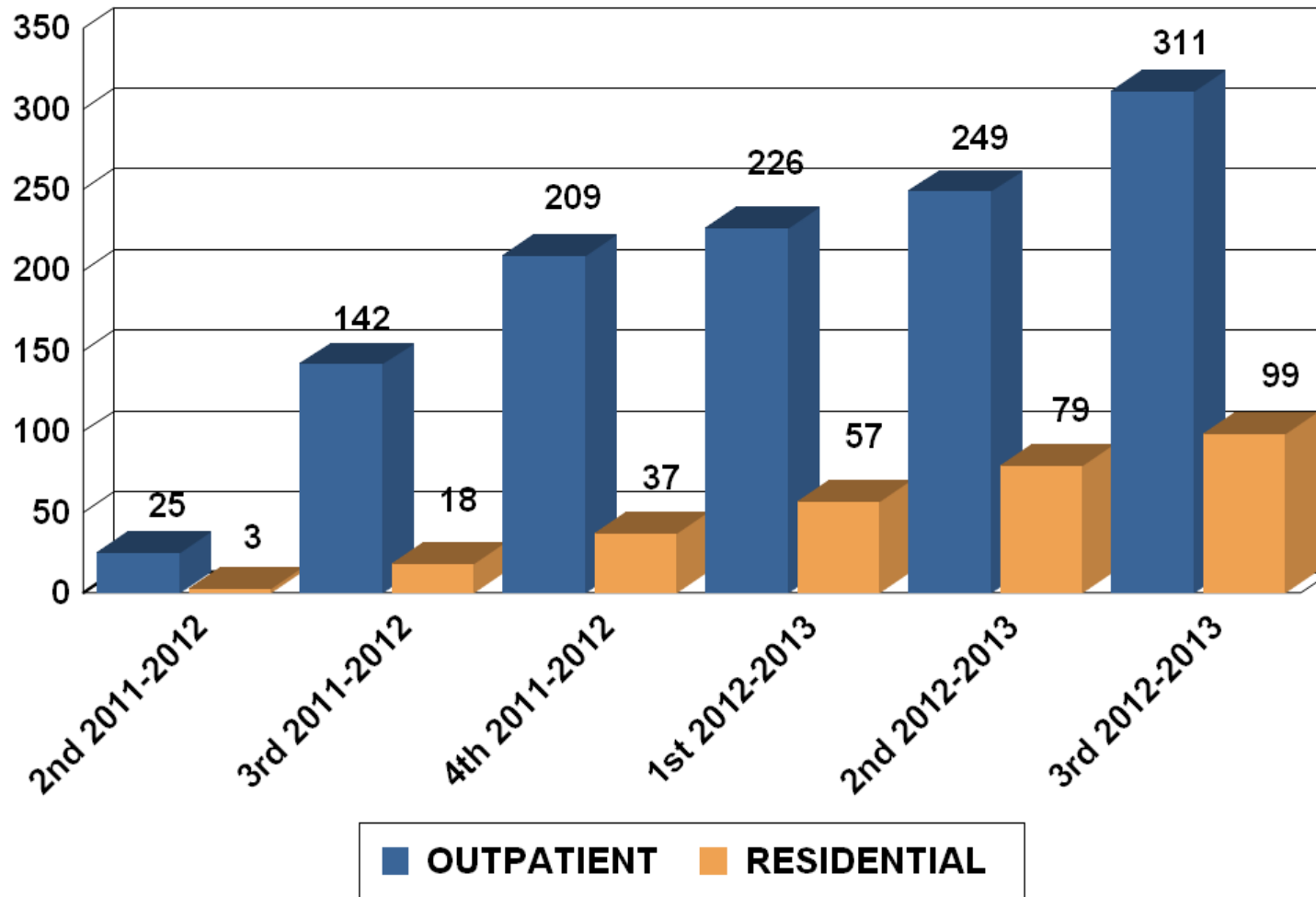

- Help coordinate the care for the client by partnering in obtaining medical records from State prior to release back to LAC



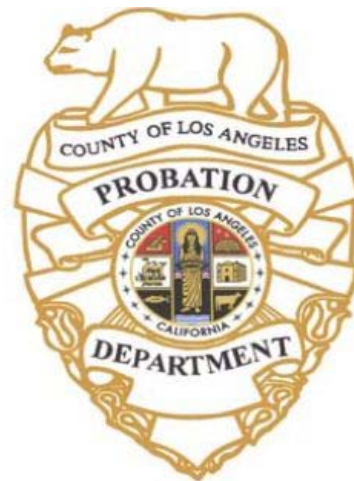

 - Increase referrals
 - Chronic care issues require more costly medications
- Sharp increase of referrals and increase in wait times
- Improve specialty care in the jails
 - Launching specialty care initiative with onsite enhanced urgent care to start at Sheriff's Medical Services Bureau in July 2013 and other specific specialty services to be provided on-site at MSB beginning next Winter.



Emerging Issues

- Continuing to increase volume of specialty care available to growing number of jail inmates.
- Identifying primary care and follow-up sites for PSPs coming to LAC with short notice.
- Supporting the specialized needs of PSPs upon arrival to LAC.
- Creating processes to increase enrollment into Medi-Cal or other coverage source prior to release from custody.

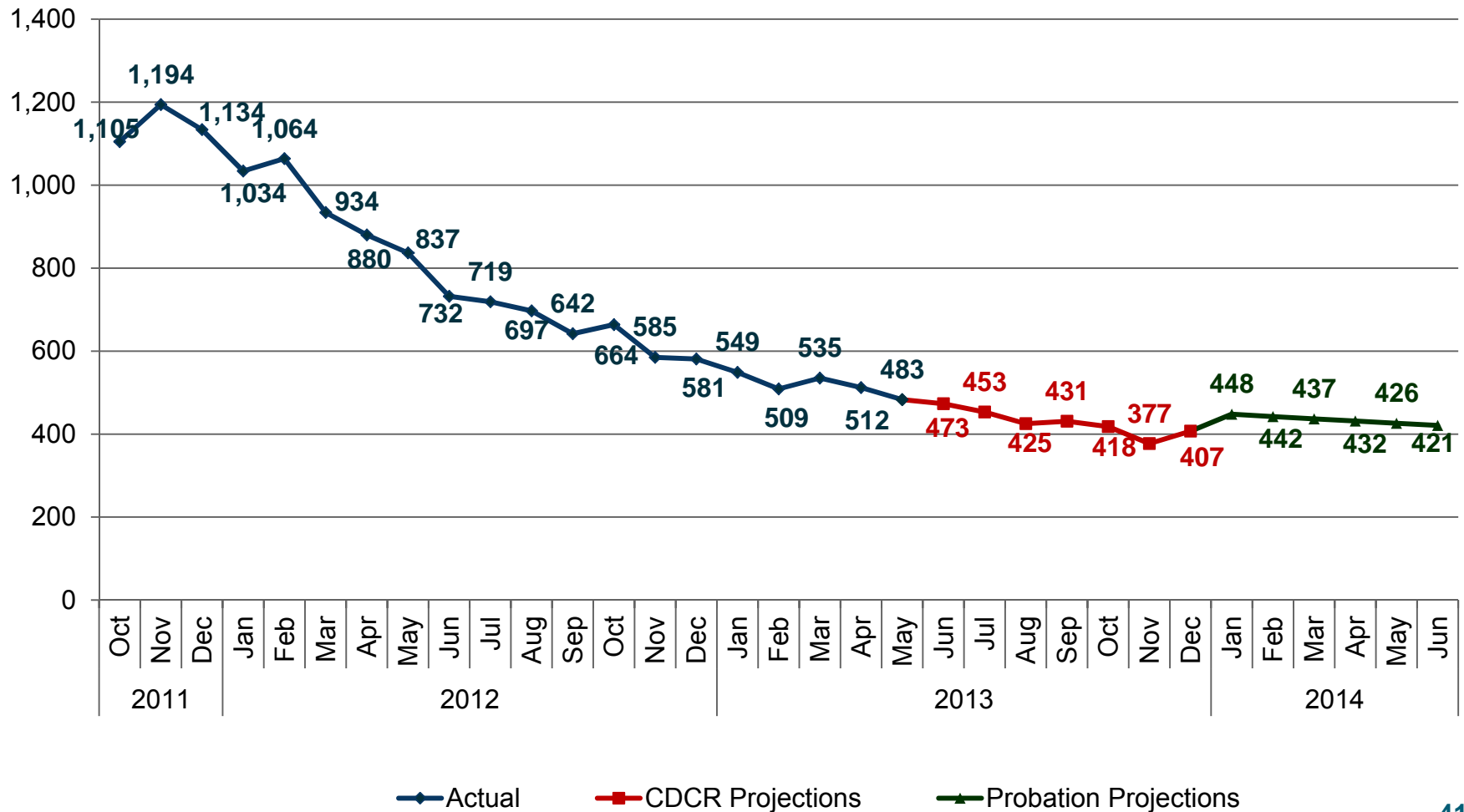

PRCS Actuals/Projections-Intake

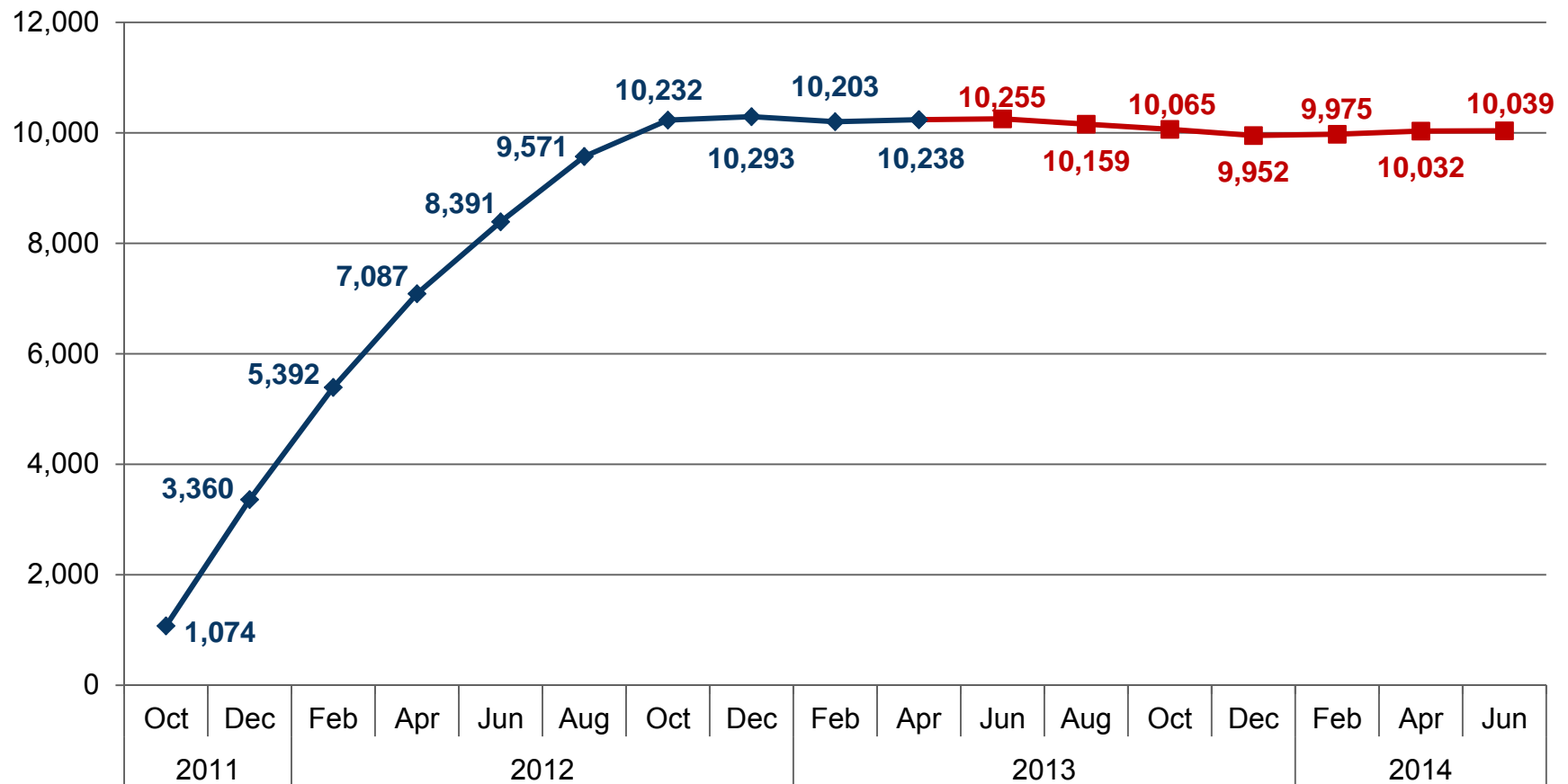
October 2011 through June 30, 2014

October 2011 through June 30, 2014



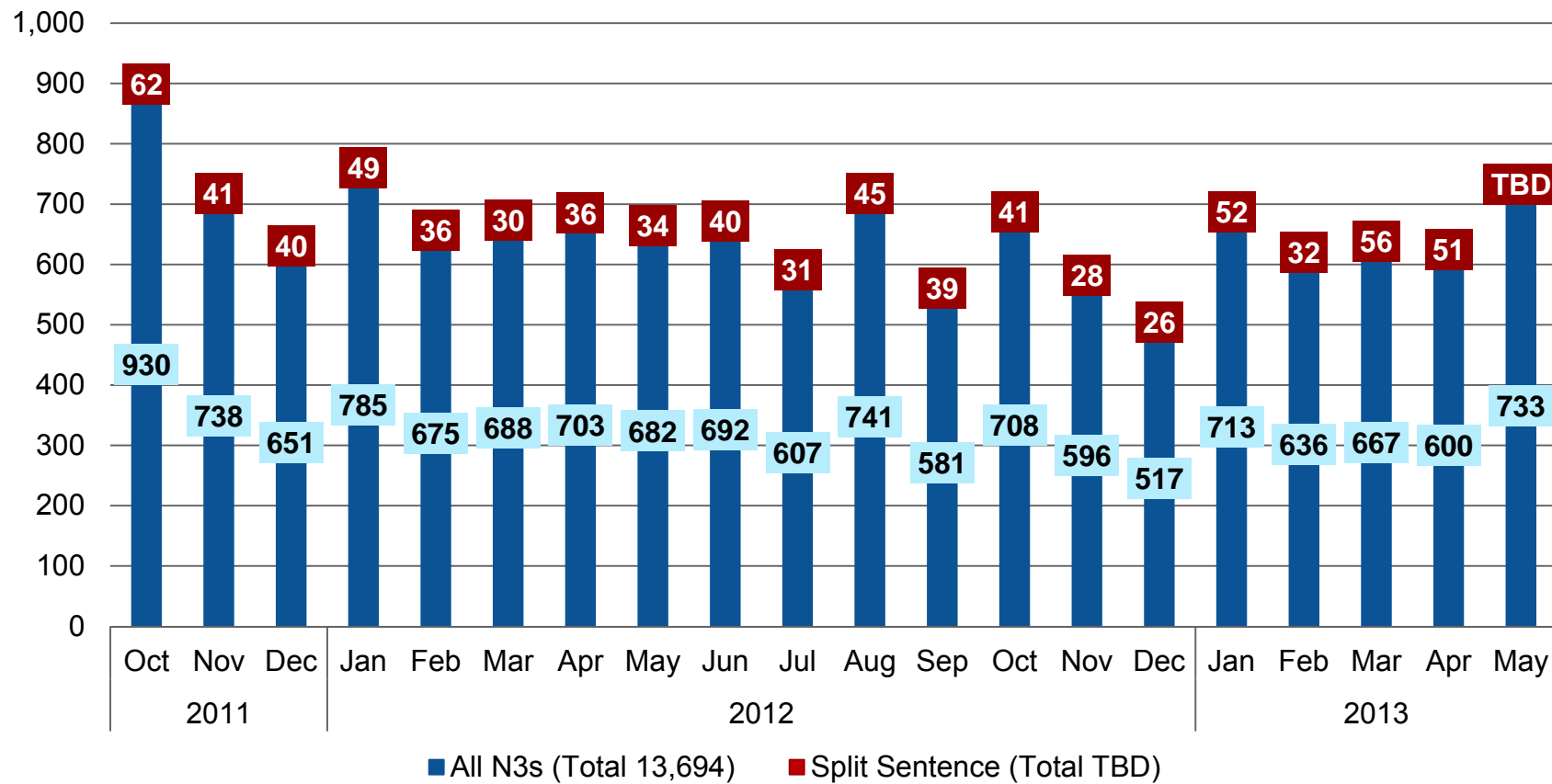

Defendants Sentenced Pursuant to Penal Code 1170(h) By Month

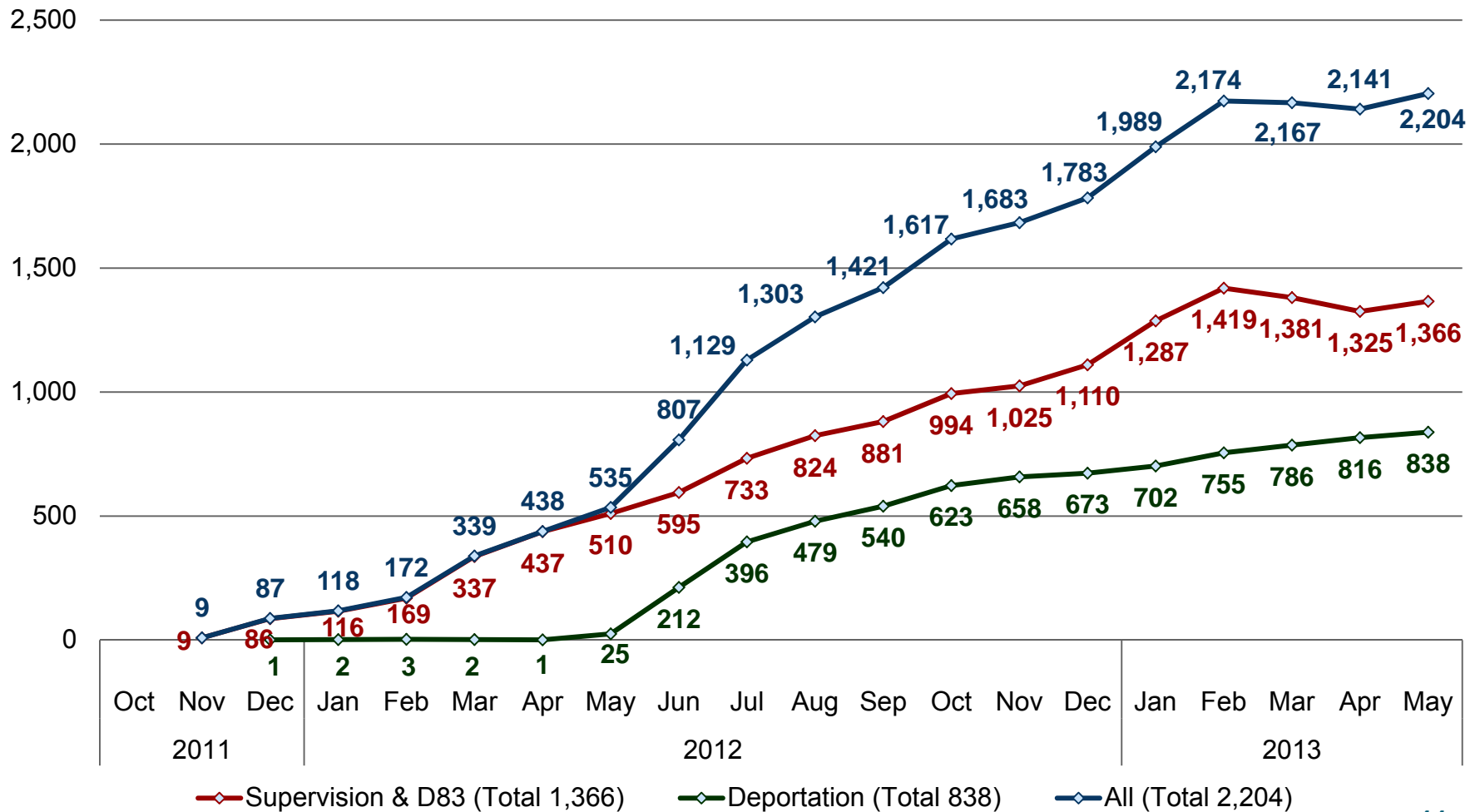

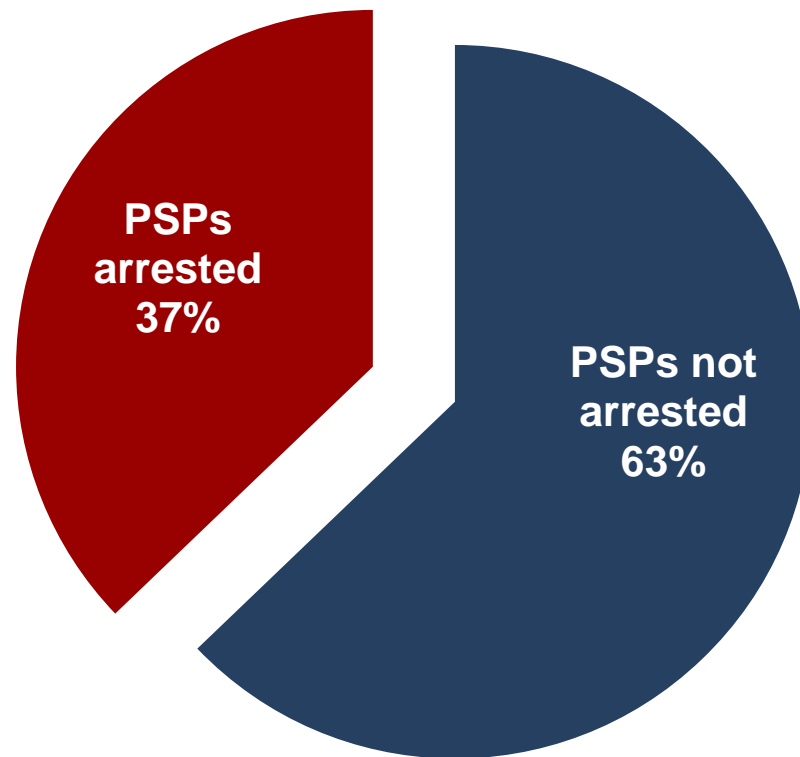
Cumulative Active Warrants

Includes Deportations





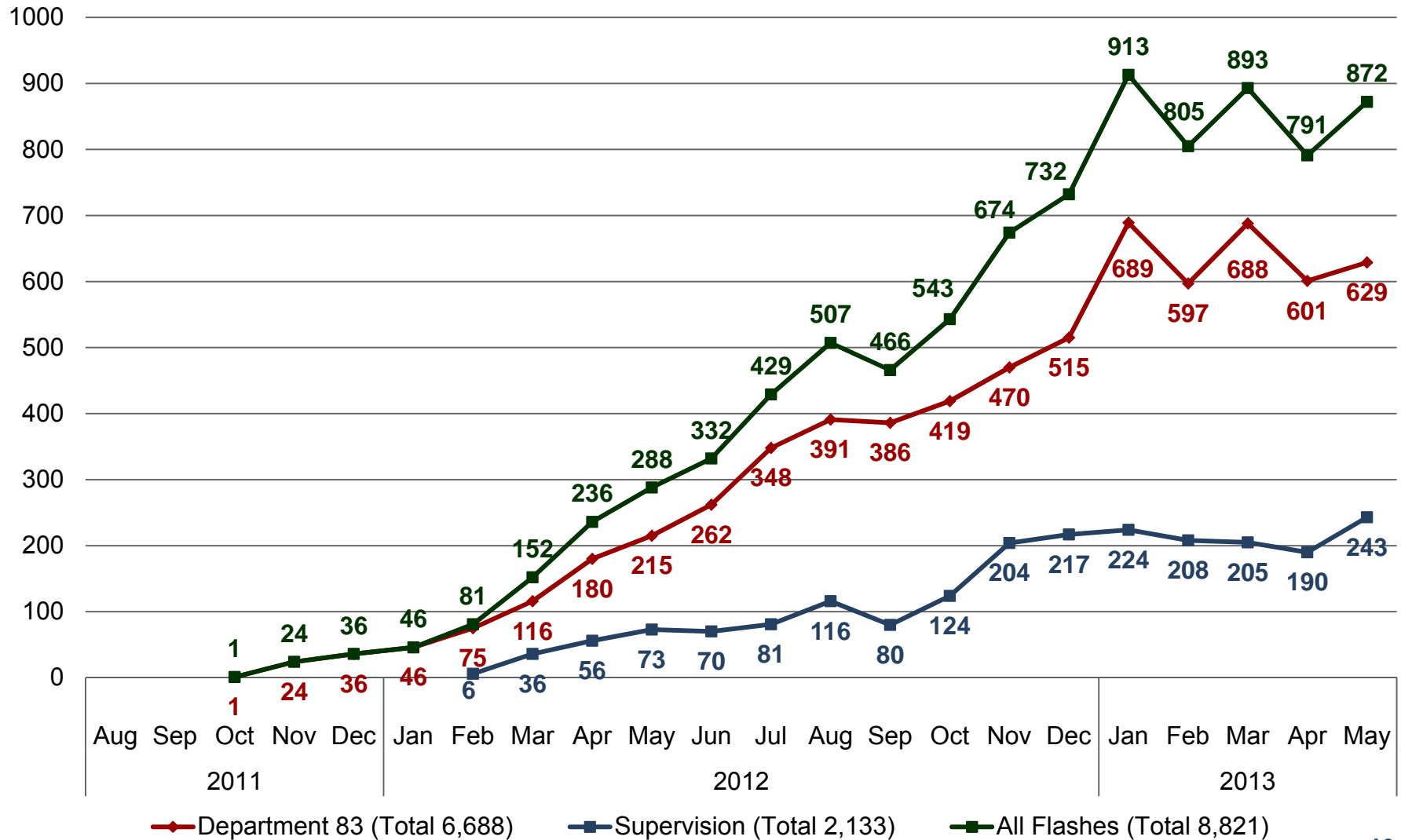

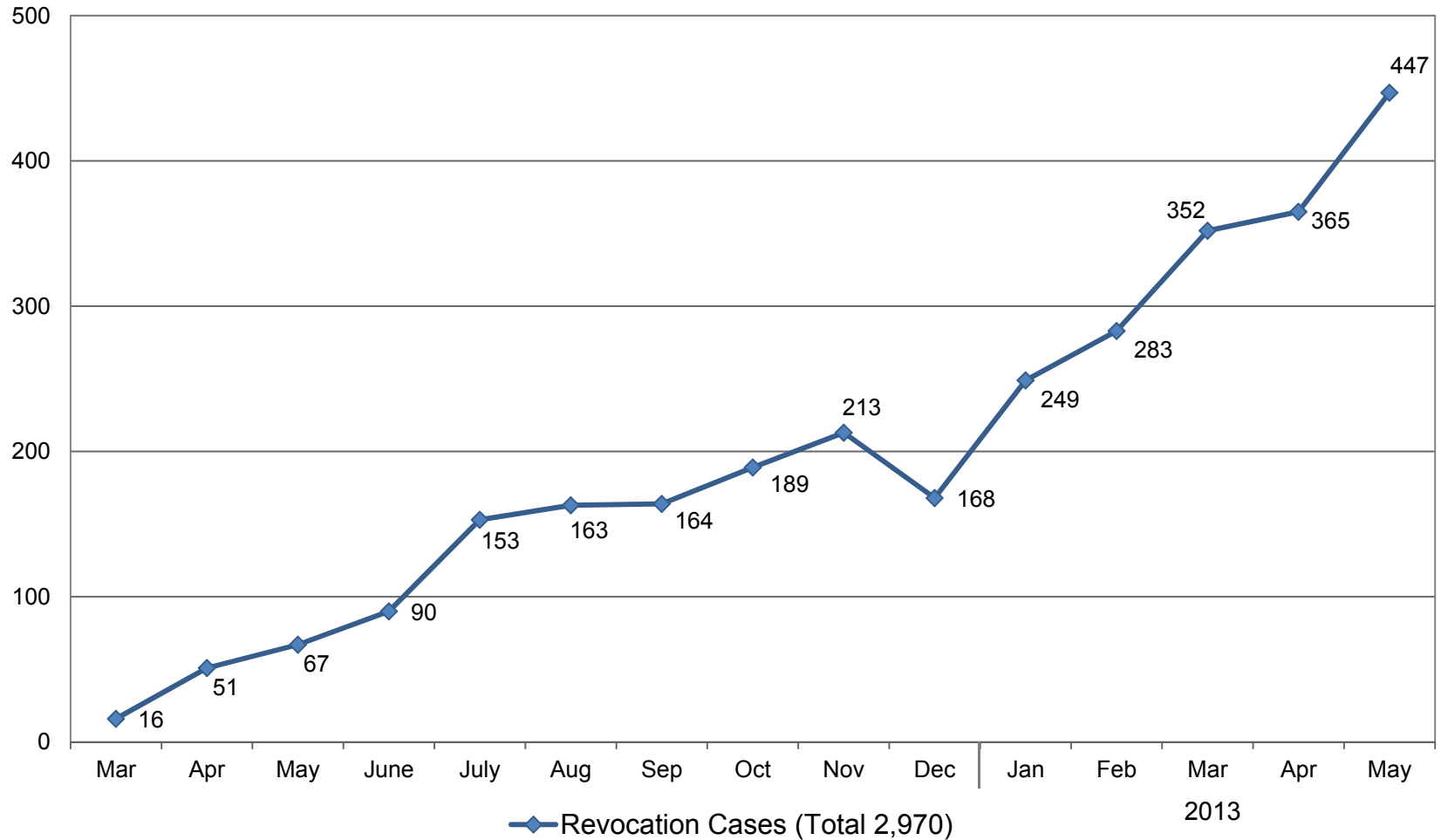


Flash Incarcerations

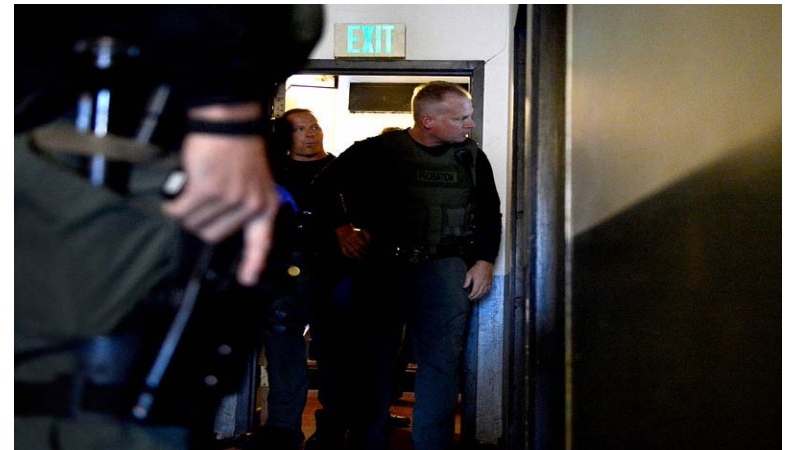
