4. DISCUSSION OF POTENTIAL PROJECTS 2022-2023

Commissioner Haik stated he would like to thank all the Commissioners who submitted ideas. He also thanked Executive Director Ed Eng and Administrative Assistant Pittmon for the effort they put into making the PowerPoint presentation and setting up a meeting to discuss each project.

Commissioner Haik reviewed the PowerPoint presentation and stated that the following projects were in no specific order of importance: (1) Improve Internal Service Department's (ISD) Procurement Process which was originally brought to the commission by the 5th District, Supervisor Barger's Office, (2) Assess the Video Arraignment Process and its impacts on the justice system, a legacy project for the E&E Commission that was implemented during the height of Covid, (3) Commission Realignment was submitted by 1st District Hilda Solis and Commissioner Taubman. He stated this project is to look at all the Commissions, JPA's, Administrative Boards, and Committees and how they align and work together, (4) Assess, incorporate and assess new technologies (E-government 3.0) for adoption by the County, (5) Follow up on the Hybrid Work 1.0 study since businesses are ready to reopen their offices as the COVID pandemic wanes, (6) A follow up study on the Commission's Economic Development study, (7) Analyze the County's Worker's Comp process for improvement.

Chair Cole led a discussion on prioritizing the seven projects. After an in-depth discussion by commissioners, the following projects were selected for 2022-2023:

- 1. Video Arraignment
- 2. Worker's Comp
- 3. Hybrid Work 2.0

Executive Director Eng stated if you are interested in working on one or more of the projects, please email him or his Assistant before the next meeting. He stated that historically one representative from each Board District serves on a task force so that each Board office could have a representative to report back to their supervisor.
