3. APPROVAL OF SEPTEMBER 9, 2021 MINUTES

Vice-Chair Jackson asked if there were any objections or changes to the minutes of the September 9, 2021 Commission meeting. Hearing no changes, the motion was then Moved, Seconded, and Adopted. The minutes of the September 9, 2021 Commission meeting were approved.

5. REPORTS

i. CCJCC

Commissioner Jackson reported that since the meetings have been virtual, a majority of the meetings have been run by the Chair Pro Tem Chief Probation Officer, Adolfo Gonzalez. He reported on two presentations: (1) California Advancing and Innovating Medi-cal (CalAIM), given by Mr. David Panush, President of California Health Policy Strategies. He reported that CalHPS has been working with the county to expand access to Medications for Addiction Treatment (MAT) among the justice-involved population. Commissioner Jackson also reported that Mr. Panush summarized California Advancing and Innovating Medi-Cal CalAIM, which is a new approach for delivering health care to the highly vulnerable, hard-to-serve, high-utilization Medi-Cal beneficiaries with complex needs, including specific elements for the justice-involved population and reentry process. He reported that CalAIM is a multi-year initiative by the California Department of Health Care Services (DHCS); (2) the County Commission on Alcohol and Other Drugs (CAOD), whose mission is to advise and make recommendations to the County Board of Supervisors on issues related to alcohol and other drugs (AOD). He reported other functions to include:

- Legislative review and recommendations;
- Recommendations to strengthen enforcement, medication, prevention, and rehabilitation efforts:
- Advise the Department of Public Health Substance Abuse Prevention and Control (DPH-SAPC) on goals/policies;
- Organize and assist on AOD conferences; and
- Support AOD addiction education and prevention efforts.

He also reported there were no actions taken at this CCJCC meeting, but CCJCC members were asked to submit nominations for a representative of a public safety agency to service as a member at the November CCJCC meeting.

ii. Environmental Transit Stop Solution

Commissioner Saliba reported that Transit Stop Solutions project was conceived by the creative brain of Executive Director, Edward Eng. She reported that 3 of the City Colleges from the 1st District: Rio Hondo, East LA, and LA City College all have classes participating in the project. She reported that Executive Assistant Aisha did a fantastic job bringing all these various groups together including Metro, Board District One, and Department of Public works.

Executive Assistant Pittmon reported that the task force meeting with the representative judges from Metro, Department of Public Works, Board District One, and the Commission will be on Tuesday, November 13, 2021.



Executive Director Eng reported that he wanted to thank Administrative Assistant Pittmon for doing such a good job communicating and coordinating the meetings with the colleges, Metro, and the 1st District. He reported that the projects will be worked on by the students under the guidance of the course professors. He reported that the judging process will take place on December 1, 2021.

8. STAFF ANNOUNCEMENTS
