- 8) We have no place in our deliberations for homophobic, racist, sexist, and other discriminatory statements and "-isms" (including misogyny, transphobia, ableism, and ageism).
- 9) We give ourselves permission to learn from our mistakes.

1. WELCOME + INTRODUCTIONS + CHECK IN

Co-Chair Alasdair Burton welcomed attendees and led introductions.

2. COH MEETING DEBRIEF

The Caucus expressed frustrations related to the earlier HOPWA report and cited the many limitations in leveraging the Ryan White Program to eliminate barriers. Members shared that it would be problematic to include HIV-negative consumer clients in receiving RWP services when those living with HIV have challenges accessing services. Excessive documentation was also mentioned as a barrier to accessing HOPWA services. The Caucus requested that the Commission's HOPWA representative and/or his team attend the next Caucus meeting to provide an update. In July 2022, an agreement was made to provide quarterly updates. City of Long Beach HOWPA representaties were also requested to attend.

The Caucus briefly noted the open mic incident during the main meeting and staff assured that the matter would be addressed appropriately.

3. ED/STAFF REPORT

County/Commission Operational Updates.

- Resumption of In-Person Brown Act Meetings Beginning March 2023
 - Dawn Mc Clendon shared updates regarding the resumption of in-person meetings beginning in March and reminded folx that the first in-person Commission meeting will take place on Thursday, March 8, 2023. Continental breakfast will be provided for the main Commission meeting and lunch will be provided for the Consumer Caucus meeting which will immediately follow. The Consumer Caucus will be a hybrid meeting, allowing folx to join in person or virtually.
- Consumer Caucus "Closed" Listening Session w/ Health Resources & Services Administration (HRSA) | Thursday, February 16th @ 4-5PM
 - DMc Clendon reminded the Caucus that the HRSA closed listening session will not include staff as it is meant to be a dedicated space for the Consumer Caucus. DMc Clendon provided logistical details of all the upcoming HRSA site visits as follows:

4. CO-CHAIR REPORT:

<u>2023 Workplan Review</u>. Under the listening session recommendation, it was suggested that topical speakers be included to create an community educational component to the listening sessions.

Meeting Schedule & Frequency. The Caucus expressed that it would like for its meetings to be hybrid once Brown Act in person meetings resume and requested that lunch be provided for those attending in-person. Additionally, given the in-person meeting format for the Commission meeting, the Caucus determined it will meet at 2PM and will assess whether to meet earlier depending on when the main meeting adjourns.

5. MEMBER REPORTS (Opportunity for COH Caucus members to provide updates from their assigned COH Committees and related conferences/events attended to better coordinate activities and harness feedback from a consumer perspective.)

None reported.

6. DISCUSSION

HRSA Closed Listening Session Preparation

In preparation for the listening session with HRSA, the Caucus agreed to strategically coordinate its approach by developing talking points from a list of concerns provided by members. It was agreed that staff would compile the list and email it to the Caucus membership for reference when participating in the closed listening session. Kevin Stalter agreed to be the notetaker to memorialize the discussion, as staff will not be in attendance nor will the session be recorded. The Caucus agreed to debrief at its next meeting and draft a letter to HRSA, following up on the discussion and formalizing its concerns.

Topics of concerns to be included in the talking points are:

- Emergency Financial Assistance (EFA)
- Merging the EHE Steering Committee with the Commission
- Treatment and training of new and returning unaffiliated consumer members
- HRSA funding constraints, i.e., EFA
- Impending homelessness for those aging with HIV
- Siloed nature of funding versus current needs. I.e., a 35 year old law is no longer serving the needs of people living with HIV.
- Consumer voice needs to be amplified & integrated into EHE efforts
- HRSA's lack of understanding of the long-term impact of PLWH
- Immigrant access to services when documentation is not available

Concerns were shared that having these conversations are retraumatizing because HRSA does not have intentions of improving the RWP legislation to make it more consumer-centered.

A suggestion was made to think broadly when it comes to requesting legislative changes and think from collective impact perspective in how these changes can impact other jurisdictions.

Overview of Draft Oral Healthcare Service Standards

Erika Davies and Kevin Stalter, Standards & Best Practices (SBP) Committee Co-Chairs, presented an overview of the Oral Healthcare Service Standards. A final review will be held at the SBP Committee's next meeting before it is submitted for approval. Any feedback up until that time is welcomed.

The Caucus shared concerns about how dental providers treat PLWH. The SBP Co-Chairs shared that it will be reviewing its Universal Standards and Patient Bill of Rights to address some of those concerns.

PURPOSE OF THIS DOCUMENT: To identify activities and priorities the Consumer Caucus will lead and advance throughout 2023.



Los Angeles County HOPWA Program

Housing Opportunities For Persons with HIV/AIDS (HOPWA) is a federally-funded program that provides assistance with housing and supportive services for low-income persons living with HIV/AIDS and their families. The program goals are to maintain stable housing, reduce the risk of homelessness, and increase access to care. Services are provided countywide.

Housing Information and Referral – Locates vacant units within the County of Los Angeles and maintains a user-friendly website that includes rental listings, housing resources, and additional community resources.

Housing Specialist/Crisis Housing – Performs comprehensive assessments and housing plan to address barriers to finding and sustain stable housing. Emergency and transitional housing for clients homeless or atrisk of homelessness.

Short Term Finanacial Assistance –Short-Term Rent, Mortgage, and Utility (STRMU) program provide short term financial assistance to maintain housing and Permanent Housing Placement (PHP) provides move-in grant to help households with first month's rent, security deposits and utility switch on fees.

Tenant Based Rental Assistance (TBRA) – Funded through four housing authorities, operates similarly to a Section-8 voucher program. Households who remain eligible after 12 months may convert to the Section-8 program.

Scattered Site Master Leasing – Households living in units leased by a non-profit agency scattered throughout multiple buildings and receive supportive services.

Residental Service Coordination – Households living in affordable permanent housing (PH) receive supportive services and linkages to other community resources.

Legal Sevices – Assists with evictions, issues related to eligibity for public benefits, and informs tenants of rights regarding fair housing laws.

Animal Advocacy – Teaches tenants' rights regarding service animals for emotional support as well as supportive services for animals.
